1. DESCRIPTION OF THE PLAN

The following description of the Starkweather & Shepley Insurance Brokerage, Inc. & Subsidiaries 401(k) & Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Starkweather & Shepley Insurance Brokerage, Incorporated and Subsidiaries (collectively referred to herein as the Plan Sponsor). Employees are eligible to participate in the Plan on their date of hire. The entry dates for the Plan are the first day of each month. The Plan is qualified under Section 401(k) of the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Contributions to the Plan are made by both participating employees and the Plan Sponsor. Upon meeting eligibility requirements, participants become automatically enrolled into the Plan, unless the participant specifically opts out of the Plan. Participants are automatically enrolled in the Plan at 3% of their eligible compensation, as defined in the plan agreement. Participants may contribute up to the maximum amount which will not cause the Plan to violate actual deferral percentage tests, as defined in the Plan agreement, and which will not exceed the dollar limitation as provided by the Internal Revenue Service (IRS). The Plan Sponsor may make discretionary matching contributions. Such discretionary matching contributions are determined annually by the Board of Directors. For the year ended December 31, 2024, such discretionary matching contributions were equal to 100% of the contributing participant's elective deferrals not exceeding 3% of such participant's eligible compensation, as defined in the Plan agreement.

Participants may also make Roth contributions to the Plan. Such contributions are after-tax contributions. The amount of Roth contributions a participant may make is limited to the maximum allowed by the IRS less any pre-tax contributions made.

The Plan Sponsor may elect to contribute a discretionary non-elective contribution in addition to the discretionary matching contribution. Participants who are employed on December 31st and who have completed at least 1,000 hours of service during the plan year are eligible for the discretionary non-elective contribution. Such discretionary non-elective contribution is allocated to each participant's account based on the participant's

eligible compensation to total eligible compensation. For the year ended December 31, 2024, the Plan Sponsor elected to make a discretionary non-elective contribution to the Plan of \$3,275,000.

Participants direct contributions into various investment options which consist of mutual funds and a common/collective trust. Participants may change the investment options into which their salary deferrals and employer contributions are being invested and may transfer previously invested contributions among investment options on a daily basis, subject to certain limitations.

Participant Accounts

Each participant's account is credited with the participant's salary deferral contributions and (a) discretionary employer matching contributions, if any; (b) an allocation of additional Plan Sponsor discretionary contributions, if any; and (c) an allocation of Plan net earnings or losses. Allocations are based on participant compensation or account balances, as defined in the Plan agreement. Each participant's account is reduced on a unit basis by withdrawals, transfers, direct investment expenses, asset charges and, if applicable, loan set up fees. Changes in unit values are reflected in each participant's account based on units held within each account on the valuation date. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in that portion of their account which relates to their contributions and the income earned thereon. Vesting in the employer contributions, plus actual earnings thereon, occurs in 20% increments commencing upon the completion of two years of service, with 100% vesting upon the completion of six years of service, death, disability or attainment of normal retirement age as defined in the Plan agreement.

Notes Receivable from Participants

Participants may borrow a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are collateralized by the participant's nonforfeitable interest in the Plan and are supported by a promissory note. Loans must be repaid over a period not to exceed five years unless the loan proceeds are used for the purchase of a primary residence, in which case a longer repayment period is allowed. As of December 31, 2024, the outstanding notes require interest at rates ranging from 3.25% to 8.50%. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Benefits may be distributed to participants upon termination of employment by reason of retirement, disability, death or other separation from service. If the participant's vested account balance does not exceed \$5,000, the distribution is paid in one lump sum. If the participant's vested account balance exceeds \$5,000, the participant may elect to receive a distribution either in a lump sum or periodic installments.

Upon written request to the plan administrator, participants may request a financial hardship withdrawal from the vested portion of their account. The minimum amount of such withdrawal is \$3,000.

Forfeitures

When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account represents a forfeiture, as defined in the Plan agreement. If a forfeiting participant is re-employed and fulfills certain requirements, as set forth in the Plan agreement, the participant's account will be restored. Forfeitures of the employer matching and profit sharing contributions may be used to pay administrative expenses and reduce future employer contributions.

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$333,000 and \$213,000, respectively. Forfeitures from nonvested accounts used to reduce employer contributions total approximately \$1,400 during the year ended December 31, 2024.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by T. Rowe Price Retirement Plan Services, Inc., (the Custodian). See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. An allowance for credit losses has not been recorded as of December 31, 2024 and 2023 as it is not deemed necessary. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Other Income

The Plan's service agreement with T. Rowe Price Retirement Plan Services, Inc. includes plan servicing credits in which the Plan may receive rebates for utilizing T. Rowe Price investment products. Credits received are allocated to participant accounts in proportion to their account balances invested in those investment options. To be eligible for an allocation of fee credits, a participant must maintain a balance in the Plan on the last day of the quarter. For the year ended December 31, 2024, credits received of approximately \$125,600 are included in other income in the statement of changes in net assets available for benefits.

Expenses

Certain expenses incurred in maintaining the Plan are to be paid by the Plan unless paid by the Plan Sponsor. Amounts paid by the Plan Sponsor are excluded from these

financial statements. Fees related to the administration of in-service withdrawals, hardship distributions, and notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through September 16, 2025, which is the date the financial statements were available to be issued.

3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/Collective Trust – A Stable Value Fund issued by T. Rowe Price Trust Company that is valued daily at the net asset value of units of the collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily.

Stable Value Fund

The Stable Value Fund is a common/collective investment trust fund managed by T. Rowe Price which invests in a variety of investment contracts such as guaranteed investment contracts issued by insurance companies and other financial institutions and other investment products and other similar investments that are intended to maintain a constant net asset value while permitting participant-initiated, benefit-responsive withdrawals for certain events. Participants ordinarily may direct withdrawal or transfer all or a portion of the investment at contract value.

4. TRANSACTIONS WITH PARTIES-IN-INTEREST

Parties-in-interest are defined under Department of Labor (DOL) Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. For the year ended December 31, 2024, the Plan's transactions with parties-in-interest were as follows:

Investments

The Plan held various investments managed by an affiliate of the Custodian. Transactions in such investments qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation in the

fair value of investments. Plan servicing credits received by the plan are included in other income.

Administrative Expenses

For the year ended December 31, 2024, the Plan's transactions with parties-in-interest related to administrative expenses and investment advisory and recordkeeping fees paid to T. Rowe Price Retirement Plan Services, Inc. and T. Rowe Price Trust Company. Administrative expenses are to be paid by the Plan unless paid by the Plan Sponsor. Also, certain officers and employees of the Plan Sponsor, who are also plan participants, perform administrative services on behalf of the Plan at no cost to the Plan.

5. TAX STATUS

The Plan adopted a prototype plan sponsored by T. Rowe Price Retirement Plan Services, Inc. Such prototype plan, as then designed, has received an opinion letter from the IRS dated August 19, 2020 that the Plan is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the plan administrator and Plan's tax counsel believe that the Plan was designed and is being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or the DOL. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by the IRS and DOL; however, there are currently no audits for any tax periods in progress.

6. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
