INDEPENDENT AUDITOR'S REPORT

To the Participants and Plan Administrator of Ocean Casino-Resort 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Ocean Casino-Resort 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Plan management, having determined it is permissible in the circumstances, has elected to have the audits of the Ocean Casino-Resort 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Plan Management for the Financial Statements

Plan management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Such information is the responsibility of Plan management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of Plan

The following brief description of the Ocean Casino-Resort 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a contributory, defined contribution savings plan covering all eligible full-time employees of AC Ocean Walk LLC (“Ocean” or the “Company”) who have 90 days of service and are age 18 or older. Non-resident aliens, union employees and leased employees are not eligible for the Plan. Temporary and seasonal employees whose regular scheduled service is less than 1,000 hours in the relevant period are not eligible for the Plan. Salary deferral eligibility requirements have been modified to reflect provisions required by the Setting Every Community Up for Retirement Enhancement (“SECURE”) Act of 2019 and the SECURE 2.0 Act of 2022. The effective date of the Plan was July 1, 2018. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

Each year, participants may contribute to the Plan a portion of their compensation, as defined in the Plan document, subject to Internal Revenue Code (“IRC”) limitations. Contributions may be designated as pre-tax or Roth 401(k) contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled into the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated age appropriate fund until changed by the participant. The Plan also has an automatic escalation provision. The automatic escalation provisions apply to all participants who file a new salary reduction agreement to defer at least 1% of compensation, unless and until they make a contrary election. The elective deferral percentage will increase 1% each January 1st until the percentage reaches 10%. The participant’s first automatic deferral increase will be on the first available change date (January 1st) that is at least one month following the day the participant enters the automatic increase program.

The Plan also provides for discretionary matching contributions and discretionary nonelective contributions. A participant must be employed on the last day of the Plan year to be eligible for any discretionary matching contributions or discretionary nonelective contributions. A discretionary match contribution was made by the Company during the year ended December 31, 2024 in the amount of \$1,907,057. The match was calculated as matching the percentage of elective deferral contributions (including catch-up contributions, if made) at 50%, not to exceed 6% of participant compensation. No discretionary nonelective contributions were made during the year ended December 31, 2024.

Participant Accounts

Individual accounts are maintained for each participant. Participants direct the investment of their contributions into various investment options offered by the Plan. Each participant’s account is credited with the participant’s contributions and employer contributions, when applicable, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan except for loan origination and other participant directed fees, which are charged directly to the respective participant’s account. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are vested immediately in their contributions, including their elective pre-tax deferral contributions, Roth 401(k) deferrals, and rollover contributions, plus actual earnings thereon.

Vesting in the discretionary matching contributions and discretionary nonelective contributions portion of their accounts is based on years of continuous service. For discretionary matching contributions, participants vest at a rate of twenty-five percent per year of service and achieve full vesting at four years of service. For discretionary nonelective contributions, participants vest at a rate of twenty percent per year of service and achieve full vesting at five years of service. A participant becomes fully vested upon death, disability, or normal retirement (age 59 1/2).

Forfeited Amounts

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$6,811 and \$6,686, respectively. These accounts may be used to pay expenses or to reduce future Plan Sponsor contributions. During the year ended December 31, 2024, no forfeitures were applied to payment of administrative expenses and/or to reduce discretionary matching contributions and discretionary nonelective contributions.

Payment of Benefits

On termination of service, death, or retirement, participants are entitled to their vested benefits. A participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, partial payments, or annual periodic installments over a period not to exceed the participant's assumed life expectancy. If a participant's vested account in the Plan is below \$50 at the time of termination or retirement, the Plan may distribute the entire balance to the participant following termination. If a participant's vested account in the Plan is between \$50 and \$7,000 at the time of termination or retirement, the Plan may distribute the entire balance to an individual retirement account established on the participant's behalf. Hardship and in-service distributions are also permitted from participant accounts, subject to the terms of the Plan.

2. Summary of Significant Accounting Policies

The significant accounting policies of the Plan are as follows:

Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by trustees, custodians and investment advisors. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and discretionary matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation. Discretionary nonelective employer contributions, if any, are recorded in the year in which the related participant compensation was earned.

Payments of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain administrative expenses are paid by the Company. Expenses of maintaining the Plan that are paid directly by the Company are excluded from these financial statements. Certain investment fees, as well as administrative expenses associated with participant specific transactions are deducted from participant accounts. Certain other professional expenses of the Plan may be paid through the Plan's trust through use of forfeitures or through income generated from revenue sharing agreements (which is reported in the statement of changes in net assets available for benefits as other income). Certain investment related expenses are included in net appreciation in fair value of investments.

The Plan receives revenue sharing income which may be used to pay Plan expenses or may be allocated to participants. During the year ended December 31, 2024, the Plan received \$74,208 of revenue sharing from Principal (see Note 8). During the year ended December 31, 2024, the Plan utilized \$61,939 to pay certain Plan level expenses. As of December 31, 2024 and 2023, the Plan has in unallocated accounts approximately \$46,188 and \$38,379, respectively, which is available to pay Plan expenses or to allocate to participants.

3. Information Certified by a Qualified Institution

The Plan administrator having determined that it is permissible in the circumstances elected to have the audits of the Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information included in the accompanying financial statements and ERISA-required supplemental schedule of assets (held at end of year) was obtained or derived from information obtained by the Plan administrator and certified as complete and accurate by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company ("Principal"), trustee of the Plan and a qualified institution, in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- Investments, at fair value, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment activity, including net appreciation in fair value of investments, interest and dividend income, and other income, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- The information for the mutual funds and common collective trust listed in the schedule of assets (held at end of year) as of December 31, 2024, as shown in the ERISA-required supplemental schedules.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The shares of mutual funds held by the Plan are deemed to be actively traded.

Common collective trust: Valued based on the NAV of units of the common collective trust held by the Plan at year end. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's investment options include a common collective trust that seeks the preservation of capital and to provide a competitive level of income over time that is consistent with the preservation of capital. This common collective trust is redeemable at NAV under agreements with the underlying common collective trust. However, it is possible that these redemption rights may be restricted by the common collective trust in the future in accordance with underlying trust agreements. Due to the nature of the investments held by the common collective trust, changes in market conditions and the economic environment may significantly impact the NAV of the common collective trust, and consequently, the fair value of the Plan's interest in the common collective trust. Furthermore, changes in the liquidity provisions of the common collective trust may significantly impact the fair value of the Plan's interest in the common collective trust.

5. Plan Termination

Although it has not expressed any intent to do so, Ocean has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants would become 100% vested in all employer contributions.

6. Tax Status

Effective January 1, 2024, through the adoption of a Principal Life Insurance Company pre-approved defined contribution plan, the Plan was amended and restated. The Internal Revenue Service ("IRS") issued an opinion letter dated June 30, 2020, stating that the pre-approved defined contribution plan document was designed in accordance with applicable requirements of the IRC as of that date. Although the Plan has been amended since receiving the opinion letter, management of the Plan believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan, as amended, is qualified and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. Related-Party and Party-In-Interest Transactions

Principal provides recordkeeping, trustee and custodial services to the Plan. Certain Plan investments are shares of mutual funds managed by Principal. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA. Fees paid by the Plan were \$233,202 for the year ended December 31, 2024.

Principal Trust Company or their affiliates generate income to the Plan through revenue sharing agreements. More specifically, Principal Trust Company or their affiliates may receive revenue from mutual fund and collective trust service providers for services Principal Trust Company or their affiliates provide to the mutual funds and collective trust. This revenue may be used to offset certain amounts owed to Principal Trust Company or their affiliates for administrative services to the Plan. If the revenue received by Principal Trust Company or their affiliates from such mutual fund or collective trust service providers exceeds the amount owed as agreed to by Principal and the Plan for administrative services, Principal Trust Company or their affiliates are to remit the excess to the Plan. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants (see Note 2). The Plan or Plan Sponsor may make a payment to Principal Trust Company or their affiliates for administrative expenses not covered by revenue sharing.

During 2024, the Company failed to remit to the Plan's trustee certain employee contributions totaling \$78 within the period prescribed by the Department of Labor regulations. During 2025, the Company made contributions to the affected participant's account to compensate for potential lost income due to the processing delays. The Company believes that these transactions do not affect the tax status of the Plan and took action prescribed by the regulations to remedy such errors.

9. Plan Amendments

Effective January 1, 2024, the Plan was amended to:

- Update the vesting schedule for discretionary matching contributions so that participants vest at a rate of twenty-five percent per year of service and achieve full vesting at four years of service;
- Reduce the threshold for minimum direct payment to participants for termination or retirement payments from \$1,000 to \$50;
- Modify the distribution amounts for distributing balances to individual retirement accounts for terminated or retired participants from between \$1,000 and \$5,000 to between \$50 and \$7,000; and
- To make other administrative changes to the Plan.

10. Subsequent Events

Management evaluated subsequent events for the Plan through October 8, 2025, the date the financial statements were available to be issued, and believes the appropriate disclosures have been made throughout these footnotes.
