Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

(1) Description of Plan

The following description of Infrastructure Technology Services 401(k) Plan (the "Plan") provides only general information. Participants in the Plan should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan is a defined contribution prototype plan.

(a) General

The Plan became effective on June 1, 2018 as a profit sharing and safe harbor 401(k) plan. The Plan is sponsored by Infrastructure Technology Services, Inc. (the "Company"). The Plan covers all employees of the Company who have 90 days of service and have attained age eighteen. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and The Economic Growth and Tax Relief Reconciliation Act of 2001 (EGTRRA). The Plan's investments are held by Acensus, LLC.

(b) Contributions

Participants can elect to defer a percentage of their compensation into the Plan, not to exceed the limits of the Internal Revenue Code. The Company has elected to match the contributions of participating non-management group employees (as defined by the Plan Sponsor) to a maximum of 4% of compensation according to the Plan formula. This election is made annually, and matching contributions will be made on behalf of all qualifying employees.

The Company can also elect on an annual basis to make a discretionary profit sharing contribution equal to a percentage of each participant's compensation. During 2024 and 2023, the Company did not make a profit sharing contribution.

Participants can deposit "rollovers" (distributions from other qualified plans) into the Plan.

(c) Participant's Account

Each participant's account is credited with the participant's contribution and an allocation of the Company's contribution and plan earnings. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Forfeitures of terminated participants' non-vested accounts are applied to reduce the Company contributions and to pay administrative costs of the plan.

(d) Vesting

Participants are 100% vested in the salary reduction and safe harbor match amount contributed to the Plan. Vesting in the Company's discretionary contribution portion of their accounts is based on the years of continuous service. Participants vest 20% after year two and then increase 20% each year thereafter until completing six years of credited service at which time they are 100% vested. Participants who are disabled or die prior to the six year period become 100% vested immediately.

(e) Investment Options

Upon enrollment in the Plan, a participant may direct employee and employer contributions in a wide variety of mutual funds including American, Vanguard, and others, as well as a stable value fund.

(f) Payment of Benefits

Generally, the participant becomes eligible to receive benefits upon attaining retirement age (as defined by the Plan), death, disability, or termination of employment. The participant may receive 100% of their vested account balance in a lump sum.

(g) Loans to Participants

Participants may borrow from the Plan up to one-half of their vested balance up to \$50,000. The loan is secured by the vested account balance and interest is charged at prime (Federal Reserve) plus one percent. The resulting rate is 9.50% as of December 31, 2024 and 9.50% as of December 31, 2023. Repayments are made through payroll deductions over a range of one to five years.

(h) Forfeitures

Forfeitures of non-vested Company contributions are used to reduce future Company contributions or pay administrative costs. There were no forfeitures on hand as of December 31, 2024 or 2023.

(i) Administrative Expenses

Certain expenses incurred in the administration of the Plan are paid directly by the Company.

(2) Significant Accounting Policies

(a) Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America and present the net assets available for plan benefits and changes in those net assets on the accrual basis of accounting.

(b) Fair Value Measurements

For determining fair value measurements, fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants. Management follows an established framework for measuring fair value. That framework provides a fair value hierarchy, which requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The three levels of inputs that may be used to measure fair value are described below:

Level 1: quoted prices (unadjusted) in active markets for identical assets or liabilities

Level 2: inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly

Level 3: one or more significant inputs or significant value drivers are unobservable or based on market assumptions

(c) Investment Valuation and Income Recognition

Investments in mutual funds managed by the Plan's trustee are valued on the last business day of the year based on the current market values (quoted prices in active markets) of the funds. Redemptions from the fund may be made each business day, subject to certain restrictions by the fund.

The stable value fund (the "Fund") is primarily invested in conventional and synthetic Guaranteed Investment Contracts ("GICs") and high quality bonds. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan. The Fund is valued daily based on its net asset value for the Plan's account type, with such net asset value determined at the contract value of the Fund, based on the value of the underlying investments, as described below.

Conventional GICs are typically issued by insurance companies or banks and are essentially nonmarketable deposits with the issuing entity. The issuer is contractually obligated to repay the principal and stated interest. The repayment of a conventional contract is the sole responsibility of the issuing entity. In the case of a synthetic GIC, the Fund purchases high quality debt obligations and enters into contractual arrangements (wrapper contracts) with third parties related to these debt obligations to provide a guarantee of contract value and specified interest.

The fair value of conventional investment contracts is determined using a discounted cash flow methodology where the individual contract cash flows are discounted at the prevailing interpolated yield curve rate as of year-end.

Individual assets of the synthetic investment contract are generally valued at representative quoted market prices. Short-term securities, if any, are stated at amortized cost, which approximates market value. Debt securities are valued on the basis of valuations furnished by a pricing service approved by the fund trustee, which determines valuations using methods based on market transactions for comparable securities and various relationships between securities which are generally recognized by institutional traders. Accrued interest, if any, on the underlying investments is added to the fair value of the investments for presentation purposes.

There are several specific risks to investment contracts. One of the primary risks involved is credit risk of the contract issuer. Credit risk for security-backed contracts includes risks arising from the potential inability of the issuer to meet the terms of the contract wrapper and the potential default of the underlying fixed-income securities. Secondly, liquidity is limited because of the unique characteristics of investment contracts and the absence of an actively traded secondary market. Interest rate risk is also present because rates may be fixed with these products.

Market value events may limit the ability of the Fund to transact at contract value with the issuer. Market value events are events or conditions that occur which are outside of the normal operation of the Fund and lead to any Fund disbursements which have or will have a material adverse effect on the operations of the Fund and a financial effect on the investment contract or wrap issuer's interest hereunder. In the normal course of business, such events or conditions would not limit the ability of the Fund to transact at contract value with the participants in the Fund. The Fund is managed to maintain a certain amount of liquidity to provide for the day-to-day liquidity needs of participants as well as the occasional market value event.

The Plan presents in the statement of changes in net assets available for plan benefits the net appreciation (depreciation) in the market value of its investments which consists of realized gains or losses and the unrealized appreciation (depreciation) on investments held at year-end. There are no unfunded commitments as of December 31, 2024. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

(d) Notes Receivable from Participants

Notes receivable from participants are valued at their unpaid principal balance plus any accrued but unpaid interest. Interest earned on these notes was \$7,369 and \$2,399 in 2024 and 2023, respectively.

(e) Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of net assets available for plan benefits and disclosure of contingent liabilities at the date of the financial statements, and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

(f) Payment of Benefits

Benefits are recorded as an expense when paid.

(3) Federal Income Taxes

The Plan obtained its latest determination letter dated June 30, 2020, in which the Internal Revenue Service ("IRS") stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (the "Code"). Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. No provision for income taxes has been included in the Plan's financial statements. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

(4) Investments

Acensus, LLC, the custodian of the Plan, has certified that the Plan's investments, totaling \$6,430,011 and \$5,050,590 as of December 31, 2024 and 2023, respectively, and investment return and activity for the periods then ended, as reported in the accompanying financial statements and supplemental schedule are complete and accurate.

During 2024, the Plan's investments, (including investments bought, sold and held during the year), appreciated \$606,281 and, during 2023, they appreciated \$576,229. In addition, interest and dividends on investments totaled \$114,528 and \$93,835 for 2024 and 2023, respectively.

(5) Related Party Transactions

The Company pays certain costs of administration of the Plan, and these expenses are excluded from these financial statements. Investment management fees are paid by the Plan, and certain investment management fees are charged directly to the individual funds and included in net appreciation (depreciation) in fair value of investments.

(8) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for plan benefits.

(9) Subsequent Events

The date to which events occurring after December 31, 2024, the date of the most recent statement of net assets available for plan benefits, have been evaluated for possible adjustment to the financial statements or disclosure is September 29, 2025, the date the financial statements were available to be issued.
