NOTE 1 - DESCRIPTION OF PLAN

The following description of the Lakeland Automall 401(k) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General - The Plan is a defined contribution plan covering all full-time and part-time employees of the Company who have six months of service and are age eighteen or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act 1974 (ERISA), as amended.

Contributions - Participants may contribute up to 100% of their compensation as defined by the Plan and subject to certain limitations. All employees are automatically enrolled in the plan at 4% deferral upon eligibility but are permitted to decline entry at any time. The Company may make a discretionary matching contribution. For 2024, the Company matched 50% of the employee deferral up to 4% of the participant’s compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans.

Investment Options - A participant may direct contributions in any of a number of investment options.

Retirement, Death, and Disability Benefits - A participant is entitled to 100% of his or her account balance upon retirement, death, or disability.

Participant Accounts - Each participant’s account is credited with the participant’s contribution and an allocation of a) the Company’s contribution, b) Plan earnings, and c) charged with the participant’s withdrawals, Plan losses, and an allocation of administrative expenses. Allocations are based on participant investment account earnings, elective deferrals, or account balances, as defined. The benefit to which a participant is entitled is the vested balance in the participant’s account.

Payment of Benefits - Upon normal retirement, death, disability or termination, a participant may elect to receive their account balance as a lump-sum payment equal to the value of the participant’s vested interest in his or her account or installments.

Notes Receivable from Participants - Participants may borrow from their fund accounts an amount not less than \$1,000 up to a maximum of \$50,000 or 50% of the vested portion of the participant’s account balance, whichever is less. The term of the loan may not exceed five years, except if the loans is for the purchase of a primary residence, which the term would then be ten years. The loans are secured by the balance in the participant’s account and bear interest at prime, plus 1%. Principal and interest are paid ratably through payroll deductions.

Forfeitures - Forfeitures of the nonvested portion of the participant’s accounts related to the Company’s contributions may be used to pay plan expenses or to reduce future employer contributions. The Plan had \$1,805 and \$5,723 of forfeitures as of December 31, 2024 and 2023, respectively. The Plan used \$39,111 of forfeitures for the 2024 Plan year.

Payment of benefits - Upon normal retirement, death, disability, or termination, a participant may elect to receive their account balance as a lump-sum amount equal to the value of the participant’s vested interest in his or her account or installments.

NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)

Vesting - Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the Company contribution portion of their accounts, plus actual earnings thereon, is based on each employee's years of continuous service, as defined by the Plan. The Plan's vesting provision is as follows:

<u>Years of Service</u>	<u>Vested Percentage</u>
1 Year	20%
2 Years	40%
3 Years	60%
4 Years	80%
5 Years	100%

An active participant who is less than 100% vested is deemed to be 100% vested upon death, total disability or termination of the Plan.

Administrative and Investment Management Expenses - The Plan's recordkeeping and contract administrator fees are paid by the Plan and are reflected in the financial statements as administrative expenses of the Plan. Investment management fees are charged to the Plan as a reduction of investment return and included in investment income reported by the Plan. All other expenses of the Plan are paid by the Company and are excluded from these financial statements.

Plan Termination - Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions and earnings thereon.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The accompanying financial statements have been prepared on the accrual basis of accounting.

Estimates - The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties - The Plan holds various investments. Investments are exposed to various risks, such as interest rate, market, liquidity, and credit risks. Due to the level of risk associated with certain investments and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the values of investment will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Payment of benefits - Benefits are recorded when paid.

Notes Receivable from Participants - Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances.

Investment Valuation and Income Recognition - The Plan's investments are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTE 3 - INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the custodian of the Plan, Fidelity Management Trust Company, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate as of December 31:

NOTE 4 - FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

- Level 1 - Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.
- Level 2 - Significant other observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.
- Level 3 - Significant unobservable inputs that reflect the Plan’s own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair value of investments.

- *Mutual funds*: The fair value of mutual fund investments are determined by obtaining quoted market prices on nationally recognized security exchanges (Level 1 inputs).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS

Parties in interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. For the year ended December 31, 2024, the Plan's investments are managed by FMTC and, therefore, payments to FMTC for investment management fees and record keeping fees qualify as party-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions.

NOTE 6 - INCOME TAX STATUS

The Internal Revenue Service (IRS) has issued an opinion letter dated June 30, 2020 indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended from the original prototype document, Plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 7 - SUBSEQUENT EVENTS

The Plan evaluated subsequent events through October 7, 2025, the date these financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosure in these financial statements.
