## INDEPENDENT AUDITOR'S REPORT

Plan Trustees and Plan Administrator  
Avenir Financial Federal Credit Union 401(k) Plan and Trust

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Avenir Financial Federal Credit Union 401(k) Plan and Trust subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for plan benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Avenir Financial Federal Credit Union 401(k) Plan and Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Avenir Financial Federal Credit Union 401(k) Plan and Trust (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from Matrix Trust Company (Matrix Trust) and CMFG Life Insurance Company (CMFG), the custodians of the Avenir Financial Federal Credit Union 401(k) Plan and Trust as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information as described in Note 9 to the financial statements is complete and accurate.

### Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by Matrix Trust and CMFG agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Avenir Financial Federal Credit Union 401(k) Plan and Trust and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free of material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Avenir Financial Federal Credit Union 401(k) Plan and Trust's ability to continue as a going concern within one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Avenir Financial Federal Credit Union 401(k) Plan and Trust; and determining whether the Avenir Financial Federal Credit Union 401(k) Plan and Trust's transactions that are presented and disclosed in the financial statements are in conformity with Avenir Financial Federal Credit Union 401(k) Plan and Trust's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

DECEMBER 31, 2024 AND 2023

### NOTE 1 – DESCRIPTION OF THE PLAN

The following brief description of the Avenir Financial Federal Credit Union 401(k) Plan and Trust (the Plan), formerly the AEA Federal Credit Union 401(k) Plan and Trust, provides only general information. Participants and others should refer to the plan document for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering substantially all employees of Avenir Financial Federal Credit Union (the Plan Sponsor). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Eligibility and Vesting:** All employees are eligible to participate in the Plan on the first entry date provided the employee has reached 18 years of age. Participants are immediately vested in their voluntary and rollover contributions plus actual earnings thereon. Employees will be eligible to participate in employer matching and profit sharing contributions upon reaching 18 years of age and 90 days of employment. Effective October 30, 2020, employees are eligible to participate in employer matching and profit sharing contributions upon reaching 18 years of age. Vesting in any employer match and discretionary match by the employer is based on years of credited service. Participants in the Plan will vest at 25% per year and become 100% vested in any employer match or discretionary match after completing four years of credited service.

**Contributions:** Participants may elect to defer to the Plan a portion of their eligible earnings on a pre-tax and/or post-tax basis up to the maximum allowed under Section 402(g) of the Internal Revenue Code (IRC). Participants may also contribute funds from another qualified plan as rollover contributions. Participants who have attained the age of 50 before the end of the plan year are eligible to make catch-up contributions. The Plan Sponsor may make discretionary matching contributions or other discretionary profit sharing contributions to the Plan. Participants may direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an automatic deferral feature whereby, unless the participant elects otherwise, 6% of employee compensation will be deducted for each payroll period the employee is an active participant. Employees eligible for employer Safe Harbor matching contributions received 50% of their employee contributions, up to 6% of salary, as employer matching contributions during 2023 and 2024.

**Participant Accounts:** Each participant's account is credited with the participant's contribution and allocations of the Plan's earnings and losses, reduced by distributions. Allocations are based on participant contributions, participant earnings (losses) or account balances, as defined. The benefits to which a participant is entitled are the benefits that can be provided from the participant's vested account.

**Notes Receivable from Participants:** Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 9.50%, which are commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions.

**Payment of Benefits:** Upon termination of service due to death, disability or retirement, benefits are paid either in a lump sum, in the form of an annuity, or in equal installments over a period not more than the participant's or designated beneficiary's assumed life expectancy at the time of distribution. Upon termination of service due to other reasons, a participant may receive the value of the vested interest in their account as a lump-sum distribution.

**Forfeitures:** A participant vests in the employer contributions in accordance with the provisions of the Plan. Forfeitures of nonvested amounts remain in the Plan and may first be used to reduce future contributions of the Plan Sponsor, pay administrative expenses or reallocate among participants. There were no forfeiture amounts available as of December 31, 2023. The forfeited amount of \$22,451 was used to reduce employer contributions for the year ended December 31, 2024.

#### NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting:** The financial statements of the Plan were prepared using the accrual method of accounting. Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for plan benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

**Use of Estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (US GAAP) requires the custodians to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition:** The Plan's investments are reported at fair value except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis, and dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Fair Value Measurements:** The Accounting Standards Codification establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The guidance also establishes a three-level fair value hierarchy that describes the inputs used to measure assets and liabilities.

- Level 1 asset and liability fair values are based on quoted prices in active markets for identical assets and liabilities.
- Level 2 asset and liability fair values are based on observable inputs that include quoted market prices for similar assets or liabilities, quoted market prices that are not in an active market, or other inputs that are observable in the market and can be corroborated by observable market data for substantially the full term of the assets or liabilities.
- Level 3 assets and liabilities are financial instruments whose value is calculated by the use of pricing models and/or discounted cash flow methodologies, as well as financial instruments for which the determination of fair value requires significant management judgment or estimation.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Variable Annuity Contracts:** Variable annuity contracts are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year-end. Variable annuity contracts are classified as Level 1 measurements.

The Plan's investments that are subject to fair value measurement and/or disclosure are summarized in Note 3.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

**Notes Receivable from Participants:** Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the plan document.

**Benefit Payments:** Benefits are recorded when paid.

**Administrative Expenses:** Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Fees related to the administration of distributions from participants and investment related expenses are charged directly to the participant's account and included in administrative expenses. Investment related expenses are included under net appreciation in fair value of investments.

**Subsequent Events:** The Plan has evaluated subsequent events through September 30, 2025, the date the financial statements were available to be issued.

Certain events limit the ability of the Plan to transact at contract value with the issuer. The Plan Administrator believes any events that would limit the Plan's ability to transact at contract value with participants are not probable of occurring.

Gains and losses included in changes in net assets available for plan benefits for the year ended December 31, 2024 are reported under net appreciation in fair value of variable annuity contract.

The Plan's policy is to recognize transfers between Levels 1 and 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the years ended December 31, 2024 and 2023, there were no significant transfers between Levels 1 and 2 and no transfers into or out of Level 3, as the Plan only has Level 1 investments.

#### NOTE 4 – INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan has entered into a benefit-responsive investment contract with CMFG. The assets are reported as the CUNA Mutual Stable Value. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is fully benefit responsive and included in the financial statements at contract value as reported to the Plan by CMFG. Contract value represents contributions made under the contract, plus earnings, less withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal at a specified interest rate that is guaranteed to the Plan. There are no reserves against the contract value for credit risk of the contract issuer or otherwise.

Certain events limit the Plan's ability to transact at contract value with CMFG. Such events include (a) amendments to the plan document, including complete or partial termination of the Plan or merger with another plan, (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan Sponsor or other plan sponsor events (e.g., divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe any events that would limit the Plan's ability to transact at contract value with the Plan's participants are likely to occur.

The fair value of the investment contract is \$794,998 and \$681,495 as of December 31, 2024 and 2023, respectively.

#### NOTE 5 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain investments of the Plan are managed by Matrix Trust and CMFG. Matrix Trust and CMFG are the current custodians as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services were immaterial for the plan years ended December 31, 2024 and 2023.

The Plan Sponsor provides certain accounting and administrative services to the Plan for which no fees are charged. These expenses constitute exempt party-in-interest transactions under ERISA.

#### NOTE 6 – TAX STATUS

The Plan had previously adopted the CMFG Insurance Life Company Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA. The Internal Revenue Service (IRS) informed CUNA Mutual by a letter, dated June 30, 2020, that its Plan was designed in accordance with applicable sections of the IRC. Although the Plan has been amended since the adoption, the Plan Administrator believes that the Plan was designed and is currently being operated in compliance with the applicable requirements of the IRC and that the Plan is qualified and the related trust is tax exempt.

US GAAP requires the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the DOL or IRS. The Plan is subject to routine audits by tax jurisdictions; however, there are currently no audits for any tax periods in progress.

#### NOTE 7 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants would become 100% vested in their employer contributions.

**NOTE 8 – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities, which are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.

The Plan is required to disclose significant concentrations of credit risk regardless of the degree of such risk. As of December 31, 2024 and 2023, the financial instruments that potentially subject the Plan to a concentration of credit risk consist principally of investments and participant loans.

**NOTE 9 – CUSTODIAN CERTIFICATION**

The investment information, notes receivable from participants and related income information included in the financial statements, accompanying notes and supplemental schedule of assets, summarized below, were derived from statements certified by Matrix Trust and CMFG as of December 31, 2024 and 2023 as complete and accurate in accordance with 29 CFR 2520.103-5 of the DOL Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTE 10 – SUBSEQUENT EVENTS**

The Plan Sponsor amended the plan document effective January 1, 2025 and made the following changes:

- The plan is referred to as a qualified automatic contribution arrangement 401(k) plan also known as QACA.
- In order to maintain QACA safe harbor status, the Plan Sponsor will make a safe harbor matching contribution equal to 100% of the participant's salary deferrals that do not exceed 1% of total compensation plus 50% of the participant's salary deferrals between 1% and 6% of compensation. This will be determined on an annual basis.
- Participant will be fully vested in the employer matching by two years of service.

In addition, the Plan Sponsor amended the plan document effective June 10, 2025 and added a higher catch-up limit to apply at ages 60 to 63.
