### **Opinion**


## **Other Matter—Supplemental Schedules Required by ERISA**

#### NOTE A – DESCRIPTION OF PLAN

The following description of the I.B.E.W. Local Union No. 573 Profit Sharing Plan and Trust (Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

- 1.) General** - The Plan is a defined contribution plan as defined in the Employee Retirement Security Act of 1974 (ERISA). Established in 1979 and amended and restated on January 1, 2009, the Plan's purpose is to provide members retirement income in addition to any pension benefits and Social Security benefits. It is subject to the provisions of ERISA.
- 2.) Participation and Contributions** - Any employee who is in a collective bargaining unit represented by Local Union No. 573, International Brotherhood of Electrical Workers, on whose behalf contributions are made to the Plan as required by a collective bargaining agreement, becomes a participant of the Plan on the first day of employment by an eligible employer.

- 3.) Participant Accounts** - Each participant's account is credited with the employers' contribution and the allocation of plan earnings. Allocations are based on participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.
- 4.) Vesting** - After 30 days of service or an accumulation of at least \$50 in the Plan, a benefit is considered vested and is not subject to forfeiture.
- 5.) Payment of Benefits** - Upon termination of service, death, total and permanent disability or hardship, a participant may elect to receive either a lump-sum amount equal to the value of his account or annual installments until the credit account is exhausted.

#### NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

- 1.) Basis of Accounting** - The financial statements of the Plan are prepared on the accrual basis of accounting.
- 2.) Investment Valuation and Income Recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustees determine the Plan's valuation policies utilizing information provided by investment advisors and custodians. See Note C for discussion of fair value measurements.

### NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

#### 2.) Investment Valuation and Income Recognition – Continued

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### 3.) Payment of Benefits - Benefits are recorded when paid.

#### 4.) Administrative Expenses – The Plan's expenses are paid by the Plan as provided by the plan document. Expenses incurred in connection with investments and the general administration of the Plan are recorded as deductions in the statement of changes in net assets available for benefits.

#### 5.) Use of Estimates- The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### 6.) Subsequent Events - The Plan has evaluated subsequent events through September 4, 2025, the date financial statements were available to be issued.

### NOTE C – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

**Level 1** – Inputs in to valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has ability to access.

**Level 2** – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in active markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If an asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

#### NOTE C – FAIR VALUE MEASUREMENTS (CONTINUED)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation of the method used for assets measured at fair value. There have been no changes on the methodologies used at December 31, 2024 and 2023.

*Money market funds* – Valued at the closing price reported on the active market on which the individual securities are traded.

*Certain common/collective funds* – Valued using pricing models maximizing the use of observable inputs for similar securities.

*Group trusts* – Valued as a practical expedient, utilizing the net asset valuations provided by the underlying funds, without adjustment, when the net asset valuations of the investments are calculated in a manner consistent with U.S. GAAP for investment companies.

*Common/collective funds – real estate* – Valued at net asset value (NAV) of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liability. This practical expedient is not used when it is determined to be probable that the Fund will sell the investment for an amount different than the reported NAV.

Group Trusts – the group trusts invest in a variety of private investment funds with a variety of investment objectives, all centered around the core objective of producing sustainable income and investment returns over time. The Plan can redeem daily from the Funds at the net asset value at the time of redemption.

Common/Collective Funds – Real Estate – The common/collective fund – real estate invests in a broadly diversified asset base of commercial real estate with a goal of sustainable income and total returns. The Plan can redeem quarterly from the Fund at the net asset value at the time of redemption.

#### NOTE D – INVESTMENTS

The Plan's investments are held by custodial institutions.

#### NOTE E – PARTICIPANT ACCOUNTS

At the end of the year, additional interest or interest reduction is credited to each participant's account based on the performance of the Plan investments during that year. As of December 31, 2023, the total amount due to participants was \$27,301,957. The amount available for benefits at December 31, 2024 was as follows:

#### **NOTE E – PARTICIPANT ACCOUNTS (CONTINUED)**

The trustees anticipate holding all investments until maturity and therefore the difference between assets held for distribution and the participants' account balances are due to temporary market fluctuation as a result of interest rate variances.

#### **NOTE F – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Trustees have the right under the Plan to discontinue the operations of the Plan and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants at all times will remain 100% vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Plan may determine.

#### **NOTE G – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

#### **NOTE H – RELATED PARTY/PARTY IN INTEREST**

Certain plan investments are managed by various custodians of the Plan. As described in Note B, the Plan paid certain expenses related to plan operations and investment activity to various services providers. These transactions are party in interest transactions under ERISA.

#### **NOTE I – TAX STATUS**

The Internal Revenue Service has determined and informed the Plan by a letter dated May 18, 2016, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
