Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Standard Electric Supply Co. 401(k) & Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Standard Electric Supply Co. 401(k) & Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the financial statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the financial statements section of our report. We are required to be independent of Standard Electric Supply Co. 401(k) & Profit Sharing Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Standard Electric Supply Co. 401(k) & Profit Sharing Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements

Note 1: Description of Plan

The following description of the Standard Electric Supply Co. 401(k) & Profit Sharing Plan (the "Plan") is provided for general informational purposes only. For a more complete description of the Plan and Plan investments, participants should refer to the Plan document and individual investment prospectuses.

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. The Plan has adopted the following provisions:

- Option to allow employer to rely on employee certifying that deemed hardship distribution conditions are met.
- Option to increase the dollar limit for mandatory distributions into an IRA for balances between \$1,000 and \$5,000 to balances between \$1,000 and \$7,000.
- Option to allow penalty-free withdrawals for an individual case of domestic abuse.
- Required minimum distribution at age 73 effective January 1, 2023, and is in the process of evaluating other voluntary provisions.
- Improved coverage for part-time workers. The SECURE 2.0 requires employers to allow long-term, part-time workers to participate in their 401(k). Employers maintaining a 401(k) plan must have a dual eligibility requirement under which an employee must complete either 1 year of service (with the 1,000-hour rule) or 3 consecutive years of service (where the employee completes at least 500 hours of service). Section 125 of SECURE 2.0 reduces the 3 year rule to 2 years, effective for plan years beginning after December 31, 2024.
- Require automatic enrollment and automatic escalation for plans established after December 29, 2022.

The Plan is required to be amended in regard to other requirements of SECURE 2.0 by December 31, 2026.

General

The Plan is a defined contribution plan under Section 401(k) of the Internal Revenue Code ("IRC") established by Standard Electric Supply Co. (the "Sponsor"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

Note 1: Description of Plan (Continued)

Eligibility

All employees of the Sponsor become eligible to participate in the Plan upon attaining the age of 18 and completing two months of employment. Plan entry dates are the first day of the month following the date on which the eligibility requirements are met.

Contributions

Each year, participants may elect to contribute any percentage of their eligible compensation to the Plan, not to exceed the maximum allowable limits as defined by the Internal Revenue Service ("IRS"). Participants may contribute distributions from other qualified plans ("rollovers"), and are allowed to make Roth deferrals.

The Sponsor may make discretionary profit sharing and match contributions to the Plan. In 2024, the discretionary profit sharing contributions funded by the Sponsor, totaled \$274,044. In 2024, the Sponsor made a discretionary match of 25% of the participant contributions up to 6% of eligible compensation to the Plan totaling \$237,033.

In order to receive the discretionary profit sharing contribution, a participant must be employed on the last day of the Plan year and meet a minimum hour requirement, unless specifically exempted in the Plan document.

Investment Options

Participant contributions, Sponsor profit sharing and match contributions are allocated among the available investment options as directed by each participant. By designating these investment alternatives for participants, allowing frequent fund transfers and providing the necessary fund information to participants, it is intended that the Plan be treated as an ERISA 404(c) Participant-Directed Account Arrangement.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Sponsor's contributions, as well as allocations of the Plan's investment earnings (losses) thereon. Allocations are based on participant earnings (losses) or account balances, as defined by the Plan. The balance to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings (losses) thereon. Participants that leave the Plan because of death, normal retirement, or disability retirement, as defined by the Plan, are considered 100% vested.

Note 1: Description of Plan (Continued)

Vesting in Sponsor contributions, plus actual earnings (losses) thereon, is based on the number of years of continuous service as shown by the following schedule:

<i>Years of Service</i>	Vesting %
Less than 2 years	0
2 Years	20
3 Years	40
4 Years	60
5 Years	80
6 or more	100

Participants are considered to have completed one year of service for purpose of vesting upon the completion of 1,000 hours of service at any time during twelve consecutive months.

Forfeitures

Forfeitures are the portion of an account balance that participants lose by terminating employment prior to becoming fully vested. Forfeitures remaining in the Plan are used to reduce Sponsor's profit sharing and match contributions.

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$27,998 and \$10,838, respectively. Sponsor profit sharing contributions made in the first quarter of the subsequent year for 2024 were reduced by \$25,956 from forfeited nonvested accounts.

Notes Receivable from Participants

Participants may borrow from their account balance for hardship or financial necessity, as defined by the Plan. The minimum loan amount is \$1,000 and the maximum loan amount, as limited under the IRC, must be the lesser of \$50,000 or 50% of the participant's vested account balance. Principal and interest is paid through payroll deductions.

Payment of Benefits

Upon termination of service with the Sponsor, death, disability, or attainment of normal retirement age (65), participant or designated beneficiary may elect to receive a lump-sum amount equal to the value of the participant's vested account balance. Participant accounts with less than \$5,000 will be paid in a lump-sum distribution as soon as administratively feasible after termination of employment. In addition, in-service distributions are permitted for participants who have attained age 65.

Under certain circumstances, participants may qualify to receive a hardship distribution (less applicable income taxes) from their account balance.

Administrative Expenses

Investment and participant note fees are deducted from participant accounts. Other expenses of the Plan are paid by the Sponsor and are excluded from these financial statements.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates in Preparation of Financial Statements

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value [except for fully benefit-responsive investment contracts ("FBRICs")]. Fair value is the price that would be received to sell an asset or paid to transfer a liability between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains or losses on investments bought and sold as well as held during the year. Dividends are recorded on the ex-dividend date. FBRICs are reported at contract value, which is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Funding

The Sponsor remits participant contributions to the trust when the related payroll is paid by the Sponsor. Sponsor discretionary profit sharing and match contributions, if any, are remitted to the Plan on an annual basis.

Subsequent Events

The Plan has evaluated subsequent events through October 7, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP specifies a three-tier fair value hierarchy, which prioritizes the inputs used in estimating fair value. These tiers include Level 1, defined as observable inputs such as quoted market prices in active markets; Level 2, defined as inputs other than quoted market prices in active markets that are either directly or indirectly observable; and Level 3, defined as unobservable inputs in which little or no market data exists, therefore, requiring an entity to develop its own assumptions.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Pooled separate accounts: Investments in pooled separate accounts are represented by a "unit of account" and per unit values whose value is the result of the accumulated values of the underlying investments. Their underlying investments are public investment vehicles valued using the Net Asset Value ("NAV") provided by the administrator of the mutual fund investments. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding.

The investments have no unfunded commitments, the redemption frequency is daily, and there is no redemption notice that the Plan is required to deliver prior to redemption.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4: Unallocated Contract - Guaranteed Return Account

The Guaranteed Return Account invests in a variety of investments, including fixed interest insurance investment contracts, money market funds, and other fixed income investments. The fund is fully-benefit responsive and seeks to maintain a stable \$1.00 unit value, although there is no guarantee it will be able to do so. The fund is stated at contract value. The Plan's custodian has not determined a reasonable method for determining fair value and therefore has certified contract value as the most reasonable estimate of fair value. Contract value represents contributions made under the contract, plus earnings, less withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The unallocated contract can be purchased or sold continuously. A notice of redemption is not required. The Plan has no obligation to buy additional shares or units. Certain events limit the Plan's ability to transact at contract value with The Standard Insurance Company. Such events include the following: (1) the Plan is no longer deemed to be a "qualified plan" under Section 401 of the IRC or other section of the Code allowing similar tax treatment, (2) termination of the Plan, or (3) The Standard Insurance Company determines that because of a change in the Plan or in the benefits to be provided, it is necessary to amend or modify the contract and the Plan Administrator does not assent to the amendment or modification. The Plan Administrator believes that any events that would limit the Plan's ability to transact at contract value with the Plan participants are improbable of occurring. The contract does not permit the issuer to terminate the agreement prior to the scheduled maturity dates.

Note 5: Information Prepared and Certified by Custodian

Certain information related to the Plan's investments disclosed in the accompanying financial statements and supplemental schedule, was obtained or derived from information certified as complete and accurate by The Standard Insurance Company, custodian of the Plan. This information includes investments held at December 31, 2024 and 2023, net appreciation in fair value of investments and interest and dividend income for the year ended December 31, 2024, and the valuation of notes receivable from participants and applicable interest income earned.

Note 6: Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan document to discontinue its contributions and to terminate or partially terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Sponsor contributions.

Note 7: Tax Status

The Plan adopted a nonstandard prototype document with an IRS notification letter which states the prototype Plan document is in compliance with the applicable sections of the IRC. The Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements. The Plan Administrator is not aware of any significant uncertain tax positions taken by the Plan.

Note 8: Party-In-Interest

The Plan's investments are in pooled separate accounts and an unallocated contract managed by The Standard Insurance Company, the Plan's custodian. These transactions, as well as administrative expenses and notes receivable from participants, qualify as party-in-interest transactions. These transactions are not, however, considered prohibited under ERISA regulations.

Note 9: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.


