***Opinion***

## Notes to Financial Statements

December 31, 2024 and 2023

### Note 1. Description of the Plan

Teamsters Local 346 Savings & 401(k) Plan (the Plan) was established in 1997 as a result of collective bargaining agreements between Teamsters General Local Union No. 346 and participating signatory employers. The Plan is a multiemployer defined contribution retirement plan subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Benefits under the Plan are not insured by the Pension Benefit Guaranty Corporation.

Under current provisions of the Plan, a participant becomes eligible on the date the employer first makes a contribution on the participant's behalf, or when a participant is eligible to make participant deferral contributions under the Plan. A participant is immediately 100% vested in all contributions made.

Participants direct the investment of their account balances and future contributions into various investment options offered by the Plan. In the absence of participant direction, contributions are invested in a target date mutual fund based upon their age, until changed by the participant. Participants must evaluate their own investment goals and objectives and make a decision best suited to achieve those goals and objectives. Poor investment performance may cause their vested balance to be lower than the amounts contributed to the Plan on their behalf.

Employer and participant contributions are credited to an individual account created on the participant's behalf and are adjusted for an allocation of Plan earnings or losses less administrative and related expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Participant accounts are charged an annual administrative fee of \$138 which is collected quarterly and an annual fee of 29 basis points on the investment balance which is collected monthly. Amounts collected are available to pay administrative expenses of the Plan. The Plan collected fees of \$143,782 and \$111,163 for the years ended December 31, 2024 and 2023, respectively. Net assets available for benefits include unallocated account balances of \$68,927 and \$21,418 at December 31, 2024 and 2023, respectively, which are available to pay administrative expenses of the Plan.

Participants are entitled to receive 100% of their account balance after reaching normal retirement age. Distributions are also available under the hardship provisions of the Plan. In the event of a participant's total and permanent disability prior to retirement date or termination of employment, the participant's account balance will be distributed as though they had retired. Upon the death of a participant, the value of the participants account will be distributed to the participant's beneficiary.

## **Note 1. Description of the Plan (continued)**

Effective January 1, 2024, the Plan was amended to allow for the following distributions, as set forth by the provisions of the Setting Every Community Up for Retirement Enhancement Act of 2022 (SECURE 2.0):

- Emergency expense distribution - a participant may apply for a personal expense distribution of up to \$1,000 or the non-forfeitable interest in their account, whichever is less;
- Federally declared disaster distribution - if the President of the United States declares a federal disaster in the area in which a participant lives and the participant suffers an economic loss in connection with the disaster, the participant may make a withdrawal of up to \$22,000 or the non-forfeitable interest in their account, whichever is less;
- Terminal illness distribution - a participant may apply for a distribution if a physician certifies in writing that the participant has an illness or physical condition reasonably expected to result in death within 84 months;
- Domestic abuse distribution - a participant may apply for a distribution of up to \$10,000 indexed for inflation or 50% of the nonforfeitable interest in the participant's account, whichever is less, if the participant self-certifies that they have experienced domestic abuse by a spouse or a domestic partner within the previous one-year period.

Participants should refer to the summary plan description for more complete information.

## **Note 2. Summary of Significant Accounting Policies**

**Method of Accounting** - The accompanying financial statements have been prepared using the accrual basis of accounting.

**Investments** - Investments are reported at fair value. The fair value of a financial instrument is the amount that would be received to sell that asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Purchases and sales of investments are reflected on a trade-date basis.

Interest income is recorded on the accrual basis. Dividend income is recorded on the ex dividend date.

**Contributions Receivable** - Contributions due and not paid at year end are recorded as contributions receivable. Employer contributions owed as a result of payroll compliance audits are recorded upon settlement with the employer. An allowance for uncollectible accounts is considered unnecessary and is not provided.

## **Note 2. Summary of Significant Accounting Policies (continued)**

**Revenue Recognition** - Revenue derived from employer contributions is recognized in the period in which covered employment is performed. Covered employment is primarily derived in the construction, transportation, distribution and manufacturing industries. Employer contributions are based on the number of hours or weeks worked in covered employment and the contribution rates currently in effect, as set forth in the collective bargaining agreements. Employers are required to remit contributions monthly. The Plan carries out its purpose described in Note 1 within a jurisdiction primarily located in northern Minnesota.

**Payment of Benefits** - Benefit payments to participants are recorded upon distribution. There were no participants who elected to withdraw from the Plan but were not yet paid at either December 31, 2024 or 2023.

**Expenses** - Certain investment related expenses are included in net appreciation in fair value of investments.

**Estimates** - The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

**Subsequent Events** - Subsequent events have been evaluated through September 2, 2025, which is the date the financial statements were available to be issued.

## **Note 3. Tax Status**

The Plan's latest determination letter is dated September 22, 2015, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. The Plan's administrator and the Plan's legal counsel believe that the Plan is currently being operated in compliance with the applicable requirements of the Internal Revenue Code. They therefore believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require the Plan to evaluate tax positions taken and recognize a tax liability if the Plan has taken uncertain tax positions that more likely than not would not be sustained upon examination by tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 4. Priorities upon Termination**

It is the intent of the Trustees to continue the Plan in full force and effect; however, the right to discontinue the Plan is reserved to the Trustees. In the event the Plan terminates, the net assets of the Plan will be allocated to pay benefits in priorities as prescribed by ERISA and its related regulations. Termination shall not permit any part of the Plan assets to be used for or diverted to purposes other than the exclusive benefit of participants and their beneficiaries, except that provision may be used for the payment of necessary expenses resulting from termination of the Plan. Whether or not a particular participant will receive full benefits should the Plan terminate at some future time will depend on the sufficiency of the Plan's net assets at that time and the priority of those benefits.

#### **Note 5. Fair Value Measurements**

The *Fair Value Measurements and Disclosures* Topic of the Financial Accounting Standards Board Accounting Standards Codification established a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

##### Basis of Fair Value Measurement

- Level 1      Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted asset or liabilities.
  
- Level 2      Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly.
  
- Level 3      Prices or valuations that require inputs that are both significant to the fair value measurements and unobservable.

The Plan's investments in mutual funds are classified within Level 1 of the fair value measurements hierarchy. The fair values of the mutual funds are determined by reference to the funds' underlying assets, which are principally marketable equity and fixed income securities. Shares held in mutual funds are traded on national securities exchanges and are valued at the net asset value as of the last business day of each period presented.

#### **Note 6. Risks and Uncertainties**

Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. The current economic environment has increased the degree of uncertainty.

**Note 7. Funding Policy**

The Plan is primarily funded by participant deferrals and by employer contributions as specified under negotiated collective bargaining agreements. The hourly employer contribution rate ranged from \$0.10 to \$23.70 during the years ended December 31, 2024 and 2023. The weekly employer contribution rate ranged from \$19.38 to \$105.00 during the years ended December 31, 2024 and 2023.

A participant may make contributions in \$0.05 hourly increments, with a minimum of \$.10 per hour, on a pre-tax basis, subject to Internal Revenue Code limitations. At no time may the combined participant deferral amount plus employer contributions exceed 100% of gross wages.

**Note 8. Major Employers**

Contributions from four employers accounted for approximately 50%, and contributions from two employers accounted for approximately 32%, of total contributions for the years ended December 31, 2024 and 2023, respectively. In the event these employers were to suspend contributions, the Plan would retain the risk of meeting fixed administrative expenses until appropriate adjustments were made.

**Note 9. Participant Contributions**

Employers withhold participants' contributions from their payroll. During the years ended December 31, 2024 and 2023, instances were noted where certain employers remitted contributions to the Plan later than the 15<sup>th</sup> business day of the month following the month in which the amounts were otherwise payable to the participant, as required by the requirements prescribed by U.S. Department of Labor regulations. Therefore, these late deferrals constitute a prohibited transaction with a party-in-interest. Contributing employers failed to timely remit participant contributions of \$40,816 and \$82,053 during the years ended December 31, 2024 and 2023, respectively.

The Plan has a collection program in which the Plan may collect contributions, liquidated damages, interest and attorney fees from delinquent employers. Upon receipt of late contributions from a delinquent employer, the amount of contributions and interest collected are credited to the participants' account to compensate the participant for lost earnings resulting from the delay in contributions.

**Note 10. Related Organization**

The Plan is related to a tax-exempt labor union.
