### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the InvenTrust Properties Corp. Savings Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements (collectively, “financial statements”).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditor’s Responsibilities for the Audit of the Financial Statements* section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. The following description of the InvenTrust Properties Corp. Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

*General* – The Plan is a defined contribution plan covering all full-time employees of InvenTrust Properties Corp. (the “Company”) who are age 18 or older, except employees covered by a collective bargaining agreement. Part-time, temporary, or seasonal employees are eligible to participate in the Plan upon attaining 21 years of age and 1,000 hours of service. Initial enrollment is available upon meeting eligibility requirements.

The Plan was created March 28, 2015, when the Company was formed from a spin-off of Inland American Real Estate Trust, Inc. (“Inland”). Inland employees who became employees of the Company had their investment balances transferred from the Inland retirement plan into the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Savings Plan Committee is responsible for oversight of the Plan, determines the appropriateness of the Plan’s investment offerings, and monitors investment performance.

*Administration* – The Company has designated certain employees, who serve without additional compensation, to administer the Plan. The Plan administrator has the overall responsibility and authority as the named fiduciary to manage and control the operations and administration of the Plan and may designate one or more individuals to perform those responsibilities.

*Contributions* – Each year, participants may contribute a percentage of annual compensation, as defined in the Plan agreement, on a pre-tax or Roth after-tax basis. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their pre-tax deferral rate set at 4% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The deferral rate of automatically enrolled participants increases 1% each year until a maximum deferral rate of 10% is reached.

The Company matches 100% of an employee's annual deferral contributions, up to a maximum of \$6,000. The Company matching contributions totaled \$544,279 for the year ended December 31, 2024. Additional discretionary non-elective contributions may be contributed at the option of the Company’s Board of Directors and are allocated based on the participant’s compensation relative to total compensation of those eligible for a contribution allocation. During the year ended December 31, 2024, the Company did not make any discretionary non-elective contributions to the Plan.

Contributions are subject to certain Internal Revenue Code (“IRC”) limitations.

*Participant Accounts* – Individual accounts are maintained for each Plan participant. Each participant’s account is credited with the participant’s contributions and Company contributions, and an allocation of Plan investment results. Participant accounts are charged with their withdrawals and an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, specific participant transactions, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

*Vesting* – Participants are immediately vested in their elective contributions plus actual earnings thereon. Vesting in the Company’s matching and nonelective contribution portion of their accounts is based on years of continuous service. A participant vests at 25% per year of service and is 100% vested after four years of credited service.

### Note 1—Description of the Plan (continued)

*Notes Receivable from Participants* – Participants are permitted to borrow from their individual fund balances. Participant loans can be for any purpose, classified as either a general purpose or residential purpose loan (as defined in the Plan agreement) and are limited to the lesser of \$50,000 or 50% of the vested portion of the participant's account. The loan interest rate is set at the prime rate plus one, as defined. Principal and interest is paid ratably through payroll deductions. A participant may only have one loan outstanding at any given time. Loans must be repaid within five years unless the loan is for the purchase of a principal residence, in which the loan must be repaid within ten years (fifteen years prior to June 21, 2021). Participants on authorized leave for military service can extend their loan terms longer than five years.

*Payment of Benefits* – Upon termination of service for any reason, a participant may elect to receive a lump sum, installment payments, or partial payments of amounts equal to the value of the participant's vested interest in his or her account. Employees with vested account balances less than \$5,000 as of termination will receive an involuntary distribution. Involuntary distributions of amounts over \$1,000 will be subject to the automatic rollover provisions and will be deposited into an individual retirement account. In-service distributions are also allowed for financial hardship, upon reaching the age of 59.5, and for required minimum distributions at age 73.

*Forfeitures* – The nonvested portion of former participants' accounts may be used to pay administrative expenses of the Plan or to reduce the amount of future employer contribution. Forfeited accounts approximated \$125,000 and \$86,000 at December 31, 2024 and 2023. During the Plan year ended December 31, 2024, no forfeitures were used to pay administrative expenses or reduce employer contributions.

### Note 2—Summary of significant accounting policies

*Basis of Accounting* – The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

*Use of Estimates* – The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*Investment Valuation and Income Recognition* – The Plan's investments are reported at fair value. U.S. GAAP defines fair value as the exchange price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the Plan's year.

*Notes Receivable from Participants* – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant ceases to make loan repayments and the Plan administrator deems the loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

*Payment of Benefits* – Benefits are recorded when paid. There were no benefit payments requested and not yet disbursed at December 31, 2024 and 2023.

### Note 2—Summary of significant accounting policies (continued)

*Administrative Expenses* – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

### Note 3—Information certified by the qualified institution (unaudited)

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Accordingly, Fidelity Management Trust Company ("Fidelity"), a qualified institution, has certified that the following information included in the financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments at fair value, and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, interest and dividends, and interest on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i as of December 31, 2024.

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to the certified investment information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

### Note 4—Fair value measurements

U.S. GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.
- Level 2* – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for assets measured at fair value, including the general classification of such assets pursuant to the valuation hierarchy. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Money Market and Mutual Funds* – Valued at the daily closing price as reported by the fund. Money market and mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The money market and mutual funds held by the Plan are deemed to be actively traded and are therefore classified within Level 1 of the valuation hierarchy.

*Collective Trust Fund* – Valued at the NAV of units held by the Plan at year-end provided by the issuer of the fund. The NAV is used as a practical expedient to estimate fair value and is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. The collective trust fund held by the Plan seeks to preserve principal and maintain a stable crediting rate that is responsive to changes in interest rates. It invests primarily in a diversified portfolio of high-quality, fixed-income securities. Investments valued using NAV as a practical expedient are not reflected in the valuation hierarchy.

*Pooled Separate Account* – Valued at the NAV of units held by the Plan at year-end provided by the issuer of the account. The NAV is used as a practical expedient to estimate fair value and is based on the value of the underlying investment assets held through a separate account of an insurance company. This practical expedient is not used when it is determined to be probable that the account will sell the investment for an amount different than the reported NAV. The pooled separate account held by the Plan seeks to provide a low-risk, stable investment option. It invests primarily in a diversified portfolio of high-quality, fixed income securities. Investments valued using NAV as a practical expedient are not reflected in the valuation hierarchy.

**Note 5—Related party transactions and party-in-interest transactions**

Certain administrative services are provided by the Company at no cost to the Plan and certain administrative costs incurred by the Plan are paid by the Company. The Plan has entered into various service agreements with parties-in-interest. Fees are paid by the Plan to Fidelity Investments, the Plan recordkeeper, for investment management, recordkeeping, and transaction processing services. In addition, Morgan Stanley Global Financial Solutions, and Strategic Advisors provide investment advisory services to the Plan. These transactions as well as notes receivable from participants and related activity qualify as party-in-interest transactions that are exempt from the prohibited transaction rules of ERISA.

### **Note 6—Plan termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the Company's contributions allocated to their accounts.

### **Note 7—Income tax status**

The Internal Revenue Service ("IRS") ruled on June 30, 2020, that the pre-approved plan of FMR, LLC, the document sponsor of which the Plan is based, is designed in accordance with applicable sections of the IRC. The Plan has been amended since receipt of the opinion letter. However, the Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 8—Risks and uncertainties**

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the financial statements.

### **Note 9—Non-exempt transactions**

During the Plan year ended December 31, 2024, employee withholdings totaling \$105,187, were not remitted to the Plan within the appropriate time period by the Company. These transactions constitute prohibited transactions as defined by ERISA. The Company remitted the withholdings in 2024. The Company is in the process of calculating contributions needed to compensate participants for potential lost income due to these delays.

### **Note 10—Subsequent events**

The Plan has evaluated all subsequent events through October 6, 2025, which is the date these financial statements were available to be issued and has determined there are no subsequent events that require disclosure.
