Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Cerium Networks 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(c) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section —

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements

Note 1 – Description of the Plan

The following description of the Cerium Networks 401(k) Plan (the Plan) provides general information only. Participants should refer to the plan document for complete information regarding the Plan's definitions, benefits, eligibility, and other matters.

- a. **General** – The Plan is a defined contribution plan covering substantially all employees of Cerium Networks, Inc. (the Plan sponsor). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.
- b. **Eligibility** – All employees who have attained age 21 are eligible to enter the Plan and make elective deferrals immediately upon hire. Employees are eligible to receive employer safe harbor matching and profit-sharing contributions the first day of the quarter following completion of one year (1,000 hours) of service.
- c. **Contributions** – Eligible employees may contribute up to 100% of their eligible compensation, as defined in the plan document, to the Plan, not to exceed annual limitations prescribed by the Internal Revenue Code (IRC). Effective March 1, 2023, the Plan was amended to also allow after-tax Roth elective deferrals.

The Plan sponsor makes safe harbor matching contributions equal to 100% of participant deferrals that do not exceed 3% of eligible compensation plus 50% of deferrals between 3% and 5% of eligible compensation for each pay period. The safe harbor match will not exceed 4% of eligible compensation. At its discretion, the Plan sponsor may elect to make employer qualified nonelective matching contributions and/or profit-sharing contributions. Discretionary matching contributions, if any, will be determined annually and will be allocated at a uniform percentage of salary deferrals. Profit-sharing contributions, if any, will also be determined quarterly and will be a fixed amount allocated in an amount equal to the total profit-sharing contribution divided by the number of participants eligible to share in such contribution.

- d. **Participant accounts** – Each participant's account is credited with an allocation of (a) the Plan sponsor contributions, if any; (b) deferral contributions; and (c) plan earnings and losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- e. **Notes receivable from participants** – Participants may borrow a minimum of \$1,000 and up to a maximum of \$50,000 or 50% of the vested portion of their account balance, whichever is less. Loans are calculated on a fully amortized basis. General loans have terms ranging from 12-60 months; loans for residential purposes have terms of 61-180 months. Loans are collateralized by the balance in the participant's account and bear interest at a rate commensurate with market rates for similar loans. An origination fee of \$150 is assessed to the participant at loan inception and \$25 annual assessment for loan maintenance.

Note 1 – Description of the Plan (Continued)

- e. **Notes receivable from participants (continued)** – Loan interest rates are fixed at the prime rate published in *The Wall Street Journal* on the first day of the month that the loan is issued plus 1.0%. Principal and interest are paid ratably through payroll deductions.
- f. **Vesting** – Participants are immediately vested in their salary deferral contributions, employee rollover contributions, and safe harbor matching contributions. Discretionary employer matching and/or profit-sharing contributions are subject to a vesting schedule based on years of credited service as follows:

- g. **Forfeitures** – Forfeitures of terminated participants’ nonvested discretionary matching or profit-sharing accounts occur at the earlier of 1) distribution of the entire vested portion of a participant’s account balance, or 2) five consecutive one-year breaks in service. For vesting purposes, a break in service occurs when a participant completes less than 501 hours of service during a plan year. Forfeitures may be utilized for the payment of plan expenses, to reallocate as an employer contribution, or to reduce employer contributions. As of December 31, 2024 and 2023, unallocated forfeitures totaled \$25,281 and \$19,733, respectively.
- h. **Revenue sharing credits** – The Plan received revenue sharing credits from issuers of certain investment securities held by the Plan. These credits are available for payment of plan expenses. As of December 31, 2024 and 2023, unallocated revenue sharing credits totaled \$23,633 and \$76,078, respectively.
- i. **Payment of benefits** – Upon termination of service, death, disability, or retirement, a participant or their beneficiary may elect to receive a distribution of the participant’s vested account balance in the form of a lump-sum payment or in the form of installment payments. For termination of service due to other reasons, a participant may receive a distribution of the participant’s vested account balance in the form of a lump-sum payment. The Plan also provides for hardship withdrawals and in-service withdrawals in accordance with provisions specified in the plan document.

Note 2 – Summary of Significant Accounting Policies

- a. **Basis of accounting** – The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Note 2 – Summary of Significant Accounting Policies (Continued)

- b. **Use of estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amount of assets in the statements of net assets available for benefits and the additions and deductions in the statements of changes in net assets available for benefits, as well as the amounts disclosed in the financial statement footnotes. Actual results could differ from those estimates.
- c. **Benefits paid to participants** – Benefits paid to participants are recognized when paid. As of December 31, 2024 and 2023, there were no benefits requested for payment by participants but not yet paid.
- d. **Investment valuation and income recognition** – The Plan’s investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

- e. **Investment management and administrative expenses** – Administrative costs for investment consulting, auditing, and legal services are paid by the Plan, including administrative costs paid using the Plan’s revenue sharing credits. Several of the investment fund options are subject to investment and administrative fees based on a percentage of invested assets, as disclosed in the fund’s prospectus. Transaction-based fees for loans and distributions are charged directly to participant accounts. The plan sponsor may elect to pay other expenses related to the Plan’s administration.
- f. **Notes receivable from participants** – Notes receivable from participants are measured at their unpaid principal balance. Accrued but unpaid interest, if any, would not have a material impact on the Plan’s financial statements. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded for the full amount of the outstanding loan balance.
- g. **Subsequent events** – The Plan has evaluated subsequent events through October 6, 2025, the date the financial statements were available to be issued.

Note 3 – Fair Value Measurements

The Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Level 1 – Short-term funds and mutual funds are valued at the quoted net asset value of shares held by the Plan at year end. Funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Level 2 – The Plan had no investments that are classified as Level 2 for years ended December 31, 2024 or 2023.

Level 3 – The Plan had no investments that are classified as Level 3 for years ended December 31, 2024 or 2023.

Note 3 – Fair Value Measurements (Continued)

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4 – Information Certified by the Plan Trustee

As permitted by Section 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the plan administrator has elected that information certified by Capital Bank and Trust Company, the plan trustee, not be subject to any auditing procedures except for comparing such information to the related information included in the financial statements and supplemental information. The following information has been certified by the plan trustee as complete and accurate:

- (a) Investments as indicated on the statements of net assets available for benefits;
- (b) Net appreciation in fair value of investments as indicated on the statements of changes in net assets available for benefits; and
- (c) Supplemental schedule – assets held for investment.

Note 5 – Plan Termination

Although it has not expressed any intent to do so, the Plan sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested in their account balances.

Note 6 – Tax Status

The Plan sponsor adopted a Randall & Hurley, Inc., volume submitter plan document. Randall & Hurley, Inc., received an advisory letter from the Internal Revenue Service (IRS) dated March 31, 2014, which states that the volume submitter document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS; however, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of the liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions, and the Plan could be subject to income tax if certain issues were found by the IRS that could result in the disqualification of the Plan's tax-exempt status; however, there are currently no audits for any tax periods in progress.

Note 7 – Related-party and Party-in-interest Transactions

The plan administrator is an employee of the Plan sponsor. There are no transactions between the parties other than contributions to the Plan.

The Plan invests in shares of mutual funds managed by Capital Bank and Trust Company, which is the trustee as defined by the Plan. The trustee charges fees for managing the investments, performing recordkeeping and administration services and, therefore, these transactions qualify as party-in-interest transactions.

Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the rules governing prohibited transactions under ERISA.

Note 8 – Risks and Uncertainties

The Plan provides for various investment fund options, which in turn, invest in a combination of investment securities such as stocks, bonds, and others. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.


