Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Easter Seals of Greater Houston, Inc. Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for plan benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Easter Seals of Greater Houston, Inc. Retirement Plan's (the Plan) financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section –

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE A BASIS OF PRESENTATION AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The Easter Seals of Greater Houston, Inc. Retirement Plan (the Plan) was adopted effective September 1, 2002 to establish a savings and investment plan for the exclusive benefit of the employees of Easter Seals of Greater Houston (Plan Administrator, Plan Sponsor and Agency) and their beneficiaries. The Plan is a tax deferred annuity plan as identified in Section 403(b) of the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Basis of Presentation - The financial statements of the Plan are prepared on the accrual basis of accounting, which is acceptable under the Department of Labor Rules and Regulations. Interest income is recognized when earned.

Estimates - The preparation of financial statements in conformity with generally accepted accounting principles in the United States (GAAP) requires the Plan Sponsor to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Risks and Uncertainties - Investments are exposed to certain risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits and the statement of changes in net assets available for plan benefits.

Valuation of Investments - Pooled separate accounts and interest bearing cash are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. In accordance with the policy of stating pooled separate accounts at fair value, net investment gain or loss is included in the carrying value of related investments in the statements of net assets available for plan benefits and the statement of changes in net assets available for plan benefits.

Fully benefit-responsive interest accounts are reported at contract value because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Benefit-Responsive Funds - The guaranteed interest accounts invest primarily in asset-backed contracts that are fully benefit-responsive. These asset-backed contracts have two components: (1) a portfolio of securities or underlying assets and (2) a wrap contract. Pursuant to the contract, the issuer of the contract (wrap provider) undertakes to repay the principal amount deposited plus accrued interest less expenses to fund participant-directed withdrawals, transfers and loans. The crediting rate of the asset-backed contract is a function of the relationship between the market value, yield and duration of the underlying assets versus the contract value. If the positive adjustment for the portion of net assets attributable to fully benefit-responsive interest accounts from fair value to contract value increases, the crediting rate at the next reset date will be negatively impacted and vice versa. Interest rate change is a key factor that can influence future crediting rates because it impacts the value, yield and duration of the underlying securities.

All of the asset-backed contracts held by the guaranteed interest accounts are fully participating contracts. In a fully participating contract, the asset and liability risks may be transferred from the wrap provider to the guaranteed interest accounts in the event of a termination or non-participant directed withdrawal, transfer or loan. The risk of this event happening is not probable. The wrap provider may terminate a fully benefit-responsive contract and settle at an amount different from the contract value if the wrap provider of the guaranteed interest accounts is unable to meet the terms of the contract.

Notes Receivable from Participants - Loans to participants are reported as notes receivable from participants at the unpaid principal balance plus any accrued but unpaid interest from participants.

Federal Income Tax - The Plan Sponsor adopted a Volume Submitter 403(b) Plan (the Volume Submitter Plan) with deferral arrangements. The Volume Submitter Plan received a favorable opinion letter from the Internal Revenue Service on April 5, 2018, which stated that the Volume Submitter Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (Code). The Plan has been amended since receiving the favorable opinion letter. However, the Plan administrator believes the Plan was qualified and the related trust was tax exempt as of December 31, 2024.

The Plan believes that all significant tax positions utilized by the Plan will more likely than not be sustained upon examination. As of December 31, 2024, the tax years that remain subject to examination by the major tax jurisdictions under the statute of limitations are from the year 2021 forward (with limited exceptions). Tax penalties and interest, if any, would be accrued as incurred and would be classified as tax expense in the statement of changes in net assets available for plan benefits.

Subsequent Events - The Plan has evaluated subsequent events through October 7, 2025, the date the financial statements were available to be issued. No subsequent events occurred which require adjustment or disclosure to the financial statements at December 31, 2024.

NOTE B PLAN DESCRIPTION

The following description of the Plan provides only general information about the Plan. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

Participation - An employee is eligible to become a participant in the Plan on the first day of hire. Employer matching contributions begin after being credited with one year of service.

Contributions - Participants may elect to make contributions to the Plan in an annual amount ranging from 1% to 100% of their eligible compensation. Contributions are made through authorized payroll deductions. Participant contributions are limited to \$23,000 in 2024 for participants under 50 years of age and \$30,500 for those participants over 50 years of age. For the 2024 Plan year, the Agency elected to contribute a matching contribution in an amount equal to 100% of each participant's contribution that does not exceed 3% of eligible compensation.

The Agency may make an additional contribution, in an amount determined solely at the discretion of the Board of Directors. Such additional contribution, if any, is allocated prorata to all eligible participants based upon the proportion of the participant's compensation to total compensation of all eligible participants. The Agency did not elect to contribute an additional discretionary contribution during 2024.

Vesting - A participant is fully vested in all participant and rollover contributions to the participant's account, and related earnings. Employer matching and discretionary contributions and related earnings are vested as follows:

Forms of Benefits - The Plan is designed to encourage a participant to stay in the Plan until normal retirement which is age 65. If there is a termination in employment prior to retirement, a participant is entitled to the vested percentage of employer contributions and all employee contributions and related earnings. Non-vested balances, if any, will be forfeited. The normal form of benefit payable under this Plan is a lump sum. If the amount payable is \$5,000 or less, the participant may receive a lump sum distribution as soon as feasible following the date of termination and no optional form of benefit will be available. If the amount payable is greater than \$5,000, the participant must give written consent before the distribution can be made.

Payment of Benefits - Benefits are recorded when paid.

Investments - Each participant directs the investment of their account into any of the investment options designated by the Plan Sponsor. Each participant account is credited with the participant's contribution and a pro rata share of the earnings of each fund in which the participant has invested. Investment funds are held by The Variable Annuity Life Insurance Company (VALIC).

Participant Loans - Loans are available to all participants. Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan transactions are treated as a transfer between the investment fund and participant loans receivable. Loan terms range from 1 to 5 years or up to a reasonable period of time exceeding five years for the purchase of a primary residence.

The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with the prevailing rates. Interest rates on the loans outstanding at December 31, 2024 range from 2.5% to 5.5%.

Forfeitures - Forfeitures of account balances not fully vested are used to offset part of future employer contributions. During 2024, no forfeitures were used to reduce a portion of employer contributions. At December 31, 2024, there were \$12,258 in forfeitures available to be used to reduce employer contributions.

Administration - The Agency's Chief Financial Officer serves as administrator of the Plan. The Agency, as the Plan Sponsor, may, at its discretion, pay the Plan's administrative expenses. Any Plan expenses not paid by the Agency will be paid by the Plan. Substantially all Plan expenses were paid by the Agency in 2024.

Plan Termination - The Agency has the right under the Plan to terminate the Plan subject to provisions set forth by ERISA. Upon termination, all participants would become fully vested in their accrued benefits as of the date of termination.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and the supplemental schedule of assets (held at end of year).

NOTE D FAIR VALUE DISCLOSURES

GAAP provides a framework for measuring fair value using a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value based upon whether the inputs to those valuation techniques are observable or unobservable. This hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical financial instruments and the lowest priority to unobservable inputs. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs. The financial instrument's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. These inputs are summarized in the three broad levels listed below:

Level 1 – Unadjusted quoted prices for identical financial instruments in active markets that the Plan has the ability to access.

Level 2 – Other significant observable inputs (including quoted prices in active or inactive markets for similar financial instruments), or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the financial instruments. All investments in pooled separate accounts are valued using level 2 inputs.

Level 3 – Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the financial instruments. The fair value of Level 3 financial instruments is determined using pricing models, discounted cash flow methodologies, or similar techniques, including instruments for which the determination of fair value requires significant management judgment or estimation.

Following is a description of the valuation techniques used for investments measured at fair value. There have been no changes in the techniques used during 2024 and 2023.

Pooled separate accounts are valued by the asset custodian of the funds based on market value of the underlying investments.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation techniques are appropriate and consistent with other market participants, the use of different techniques or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E PARTIES-IN-INTEREST

The Plan invests various funds offered by VALIC. These investments are considered party-in-interest transactions because VALIC serves as asset custodian of the Plan. The Plan's trustees have approved of these investment options.

NOTE F RECONCILIATION OF FINANCIAL STATEMENTS TO SCHEDULE H OF FORM 5500

Investments presented on the financial statements as pooled separate accounts are classified as investments in registered investment companies on the Form 5500.
