Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Marmen Energy Co. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2023 and 2022, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Notes to Financial Statements

Note 1. Description of Plan

The following description of Marmen Energy Co. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan was established on November 15, 2013, and is a defined contribution plan covering qualified employees of Marmen Energy Co. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility: Employees are eligible to participate in the Plan once they have reached the age of 18 and have completed six months of service, provided they are not a union employee or nonresident alien.

Entry date: Employees may enter the Plan on the first day of the quarter coinciding with or following the date they satisfy the Plan's eligibility requirements.

Contributions: Participants may elect to contribute to the Plan, in the form of pretax or after-tax (Roth) deferrals, up to 100% of their eligible compensation, as defined in the Plan documents, up to the maximum amount allowable by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the plan year are also eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. The Company may contribute a discretionary matching contribution to the Plan. For the year ended December 31, 2023, the Company approved a discretionary matching contribution equal to 50% of the first 6% of a participant's eligible compensation contributed to the Plan.

The Company may also make a discretionary nonelective contribution at the discretion of the Company's Board of Directors. In order to receive an allocation of the nonelective contributions, participants must have attained 1,000 hours of service in the plan year and be employed at year-end. The Company did not make a nonelective contribution for the year ended December 31, 2023.

The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan at a deferral rate of 6% of eligible compensation, unless they affirmatively elect not to participate in the Plan or elect another deferral rate. Contributions of participants automatically enrolled in the Plan are invested in a target date collective investment trust commensurate with their age until changed by the participant.

Participant accounts: Individual accounts are maintained for each Plan participant. Each participant's account is credited or charged with the participant's contributions, allocations of the Company's discretionary contributions, if any, investment results, and administrative expenses that are paid by the Plan. Allocations are based on participant's compensation, account balances or specific participant transactions, as defined by the Plan document. Participants direct the investment of their contributions into various investment options offered by the Plan, which are more fully described in the Plan's literature. Participants may change their investment options daily. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes to Financial Statements

Note 1. Description of Plan (Continued)

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's discretionary contribution portion of their accounts is based on years of continuous service. Vesting is based on years of credited service as set forth in the following table:

Participant's Years of Service	Vesting Percentage
Less than one	0%
One	25%
Two	50%
Three	75%
Four	100%

Forfeitures are used to fund future employer contributions or offset administrative expenses. At December 31, 2023 and 2022, forfeited nonvested accounts totaled \$0 and \$4, respectively. During the year ended December 31, 2023, employer contributions were partially funded by \$16,046 from forfeited nonvested accounts.

Payment of benefits: Participants may elect to receive a lump-sum amount equal to the value of their vested balance as defined in the Plan document upon retirement, termination of service, death or disability. A terminated participant with a balance of less than \$1,000 may be automatically paid out by the Plan upon termination. Any terminated participants with a balance between \$1,000 and \$5,000 who do not elect to receive a lump-sum amount can still be automatically paid out if their balance is rolled into a qualified individual retirement account. Distributions may be made at the participant's election prior to termination upon attainment of age 59½ or hardship as defined in the Plan document.

Note 2. Significant Accounting Policies

Basis of presentation: The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

Investment valuation and income recognition: The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Contributions: Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Note 2. Significant Accounting Policies (Continued)

Excess contributions payable: Participant contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction in contributions.

Payment of benefits: Benefit payments are recorded when paid.

Administrative expenses: Operating expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments.

Subsequent events: Effective April 15, 2024, the Plan changed the employer match from a discretionary matching contribution equal to 50% of the first 6% of a participant's eligible compensation, to a stated tiered match of 100% of elective deferral contributions that are not over 3% plus 50% of elective deferral contributions that are not over 6%.

Plan management has evaluated subsequent events through November 11, 2024, the date the financial statements were available to be issued.

Note 3. Information Certified or Provided by the Custodians

The following is a summary of the Plan's asset information as of December 31, 2023 and 2022, and for the year ended December 31, 2023, included throughout the Plan's financial statements and ERISA-required supplemental schedule, obtained by management and agreed to or derived from information certified by Principal Trust Company and Principal Life Insurance Company, the custodians of the Plan, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the custodians that information provided to the Plan Administrator by the custodians related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditor not to perform any auditing procedures with respect to information that appears throughout the financial statements and ERISA-required supplemental schedule related to the following assets:

Level 1: Inputs to the valuation methodology are unadjusted, quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

Mutual funds: Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are classified within Level 1 of the valuation hierarchy.

Pooled separate accounts: Pooled separate accounts invest primarily in shares of mutual funds or domestic and international stock. The pooled separate accounts are valued at NAV, used as a practical expedient, based on quoted market prices of its underlying securities or similar instruments. The practical expedient is not used when it is determined to be probable that the issuer will sell the investment for an amount different than the reported NAV.

Collective investment trusts: These investments are public investment vehicles using NAV provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. There are no quoted prices available in active markets for identical instruments for the common collective trusts. The NAV is used as a practical expedient to estimate fair value. The practical expedient is not used when it is determined to be probable that the issuer will sell the investment for an amount different than the reported NAV.

Note 4. Fair Value Measurements (Continued)

The preceding methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Plan management evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2023, there were no transfers in or out of Level 3.

Note 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

Note 6. Tax Status

The Plan has adopted a nonstandardized preapproved plan sponsored by Principal Life Insurance Company. Principal Life Insurance Company has received an opinion letter dated June 30, 2020 from the IRS as to the preapproved plan's qualified status. The preapproved plan opinion letter has been relied upon by this Plan. The most recent amendment to the plan document was effective February 17, 2022. TPA provides the Plan Sponsor with required legislative amendments and amendments for discretionary changes and follows up to make sure such amendments are adopted and communicated, where necessary. The Plan document has been amended on or before IRS deadlines to reflect required law changes. The Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable provisions of the Internal Revenue Code (IRC).

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan. The Plan Administrator has evaluated the Plan's tax positions and concluded that the Plan has maintained its tax-exempt status and has no uncertain tax positions that require adjustments to or disclosure in the financial statements. Therefore, no provision or liability for income taxes is included in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Related-Party and Party-in-Interest Transactions

Certain Plan investments are shares of pooled separate accounts and collective investment trusts managed and held by Principal Life Insurance Company, the custodian as defined by the Plan. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are exempt party-in-interest transactions under ERISA.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the 2023 statement of net assets available for benefits.
