Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Swartley Bros. Engineers, Inc. Employee Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section,

Basis for Opinion

Responsibilities of Management for the Financial Statements

1. DESCRIPTION OF PLAN

The following description of the Swartley Bros. Engineers, Inc. Employee Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Swartley Bros. Engineers, Inc. (the Company). A participant is eligible to participate in elective deferrals if they have completed one year of service and are age twenty-one or older.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute to the Plan a discretionary amount, determined by the participant. The Plan has an automatic enrollment feature for new eligible employees. The employee will be automatically enrolled in the Plan once eligibility requirements are met and the deferral rate will be 3% unless adjusted by the participant. If an employee does not want to participate in the Plan they must choose the opt out feature within 60 days. Deferral percentages can be changed via the Plan website. Contributions are subject to certain Internal Revenue Code limitations. Additionally, participants who have attained the age of 50 before the end of the year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

Each year, the Company may contribute to the Plan a discretionary amount, determined by the Company, not limited to current or accumulated net profits. In order to share in this profit sharing contribution, the employee must have one year of service, be eighteen years of age or older and be actively employed on the last day of the Plan year. Each participant's allocation is equal to the discretionary contribution determined for the allocation group multiplied by the ratio of the participant's annual compensation to the total annual compensation of all participants in the allocation group. Classification to each group is based on the employee's title; ownership, upper management, supervisor and non-supervisor. The Company elected to contribute profit sharing contributions of \$496,792 and \$461,000 in 2024 and 2023, respectively.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contribution (if any), (b) investment earnings, and (c) administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in their contributions as well as the profit sharing contribution plus actual earnings thereon.

Payment of Benefits

On termination of service, due to death, disability or retirement a participant receives a lump-sum amount equal to the value of the participant's account.

Hardship withdrawals are permitted under certain restrictions.

Notes Receivable from Participants

Participants may borrow from their accounts up to a maximum of \$50,000 or 50% of their account balance, whichever is less. The notes are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the Plan administrator. Interest rates varied from 4.25% to 9.50% per annum. Principal and interest are paid ratably through weekly payroll deductions.

Forfeitures

The Plan has a forfeiture holding account included in the annual certified trust statement. This account holds funds that arise from calculation errors in allocating the employer profit sharing contribution and cash in suspense. The balance of this account is \$14,081 and \$12,943 as of December 31, 2024 and 2023, respectively.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The summary of significant accounting policies of the Plan is presented to assist in understanding the Plan's financial statements. The financial statements and notes are representations of the Plan's management, who is responsible for their integrity and objectivity. These accounting policies conform to accounting principles generally accepted in the United States of America (US GAAP) and have been consistently applied in the preparation of the financial statements.

Basis of Accounting

The financial statements of the Plan are prepared on the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with US GAAP requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Capital gain dividends are reported as dividends. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Costs

The audit fee and certain third party administrator (TPA) provided services such as compliance testing, preparation of Form 5500 and Summary Annual Report as well as Plan sponsor consultation on a variety of issues as needed, are paid by the Plan Sponsor.

TPA transaction fees for loan initiation, termination and mailing are charged to the respective participants' accounts.

Other fees based on investment decisions of the participant may be charged directly to participants' accounts. These fees are reflected in net investment earnings of that fund within the participant's account balance.

3. INVESTMENTS

Accounting standards provide the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under accounting standards are described below:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds are deemed to be actively traded.

Pooled separate accounts investing in mutual funds or equity securities: Valued using quoted prices in active markets for identical assets; total value of the assets of the separate account is based on the net asset value (NAV), or price per share, of the underlying mutual fund. The mutual fund calculates its NAV by dividing the mutual fund's net assets by the mutual fund's outstanding number of shares.

4. INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan has a traditional investment contract with Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (Principal) totaling \$3,838,136 and \$3,114,236 at December 31, 2024 and 2023, respectively. Principal maintains the contributions in a pooled account, which is credited with earnings on the underlying investments (principally bank certificates of deposit) and charged for participant withdrawals and administrative expenses. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The contract has certain restrictions that impact the ability to collect the full contract value. Plan management believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable. Principal may not terminate the contract at any amount less than contract value.

Principal is contractually obligated to pay the principal and specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than 0%. Such interest rates are reviewed on a quarterly basis for resetting. The crediting rate of the contract will track current market yields on a trailing basis.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

- a. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code.
- b. Premature termination of the contracts.
- c. Plan termination or merger.
- d. Changes to the Plan's prohibition on competing investment options.
- e. Bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

- a. An uncured violation of the Plan's investment guidelines.
- b. A breach of material obligation under the contract.
- c. A material misrepresentation.
- d. A material amendment to the agreements without the consent of the issuer.

7. TAX STATUS

The Plan was approved by the Internal Revenue Service in its most recent determination letter dated June 30, 2020. The plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

US GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan's federal Form 5500, Annual Return/Report of Employee Benefit Plan, for the previous three years remains subject to examination by the Internal Revenue Service.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, credit and overall volatility risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

9. RELATED PARTY TRANSACTIONS

Plan investments are held in accounts managed by Principal. The Plan also receives investment advisory services from Bernardo Wealth Planning. Advisory fees are based on plan assets at 20 basis points. These transactions qualify as party-in-interest which are exempt from the prohibited transaction rules. Total fees paid by the Plan for the investment services for the year ended December 31, 2024 amounted to \$51,389.

Certain administrative functions are performed by officers and employees of the Company. No such officer or employee receives compensation from the Plan.
