1. Plan Description

The following description of the GIS National, LLC 401(k) Plan and Trust provides only general information. Participants should refer to the Plan Agreement for a more comprehensive description of the Plan's provisions.

- a) *General* – The Plan is a defined-contribution plan covering all full-time employees of GIS National, LLC (“the Company”) and affiliated employers which have adopted the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
- b) *Eligibility* - The Plan substantially covers all employees of the Company who have completed six consecutive months with 500 hours of service and are age twenty-one or older. Once an eligible employee has satisfied the eligibility requirements the employee will become a participant in the Plan on the first day of the month next following the date the eligibility conditions are met.
- c) *Contributions* – Each year, participants may contribute up to the contribution limitation allowed under the Internal Revenue Service guidelines. Participants may also contribute amounts representing distributions from other qualified defined-benefit or contribution plans (rollover contributions).

The Company made a 3% of compensation safe-harbor contribution for the year ended December 31, 2024 to eligible participants. In 2024, the Company made safe-harbor contributions of \$487,747. Participants ineligible for a safe-harbor contribution received a 3% of compensation profit-sharing contribution. In order to be eligible for a profit-sharing contribution, a participant must be employed on the last day of the Plan year and complete 1,000 hours of service in the year. The Company made a discretionary profit-sharing contribution of \$309,275 in 2024.

- d) *Participant Accounts* – Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit that the participant is entitled to is the benefit that can be provided from that participant's vested account.

- e) *Forfeited Accounts* – Forfeitures of non-vested balances may be used to reduce future employer contributions or to pay plan expenses. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$1,317 and \$2,733, respectively.
- f) *Vesting* – Participants are immediately vested in their contributions and Company safe-harbor contributions, plus actual earnings thereon. Vesting in the Company's profit sharing contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 20 percent vested after two years of service an additional 20 percent each year thereafter. Participants are 100 percent vested after six years of credited service.
- g) *Investment Options* – Participants direct the investment of their contributions and the Company's contribution into various investment options offered by the Plan. Participants may change their investment options at any time. Participants who do not select specific investments are invested in accordance with the default investment alternatives established under the Plan.
- h) *Notes Receivable from Participants* – The Plan permits its participants to borrow from his or her account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the participant's account balance. Participants cannot have more than one loan active at any one time. The loans are collateralized by the balance in the participant's account and bear interest at 1% above the prime rate of interest. Principal and interest are paid ratably through payroll deductions.
- i) *Payment of Benefits* - On termination of service with a participant vested balance of more than \$5,000, a participant may elect to receive the value of the participant's vested interest in his or her account as a lump sum distribution, direct rollovers, annuity contract, or installments paid in cash. For termination of service with a participant vested balance of less than \$5,000, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution or direct rollover.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

3. Subsequent Events

The Plan has evaluated events and transactions occurring subsequent to December 31, 2024 through September 29, 2025, which is the date the financial statements were available to be issued. There was an amendment to the plan effective July 1, 2025 to include automatic deferral provisions.

5. Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels:

- Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority;
- Level 2 inputs consist of quoted prices for similar assets or liabilities in active markets or quoted prices for identical or similar assets in inactive markets;
- Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments.

When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trust Fund: Valued at the NAV of units of a collective trust. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the NAV. Participant transactions (purchases and sales) may occur daily.

6. Guaranteed Investment Contract (GIC)

The Key Guaranteed Portfolio Fund is a benefit-responsive investment contract held with Great-West Life & Annuity Insurance Company (Great West). Great West maintains the contributions in a general account. The GIC is included in the financial statements at fair value as reported to the Plan by Great West. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Contract value is equal to fair value prior to contract termination. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The investment contract (Great West Key Guaranteed Portfolio Fund) is a general account product. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. Interest crediting rate is reset quarterly.

The average yield earned by the plan for the benefit responsive fund can be derived by averaging the quarterly gross interest rates for the fund over the year. The average yield for 2024 was 1.41% and for 2023 was 1.23%.

7. Related Party Transactions and Party in Interest transactions

Empower Retirement is the trustee and recordkeeper of the Plan; therefore transactions with Empower Retirement qualify as party-in-interest transactions. Fees paid for the Plan for the investment management and recordkeeping services amounted to \$86,498 for the year ended December 31, 2024.

8. Risks and Uncertainties

The Plan utilizes various investment instruments, which are exposed to various risks, such as interest rates, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

9. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their accounts.

10. Tax Status

The Plan is a pre-approved defined contribution plan ("Pre-approved Plan") sponsored by Empower Annuity Insurance Company ("Empower"). Empower obtained its latest opinion letter dated June 30, 2020, in which the IRS stated that the Pre-approved Plan as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and accordingly is exempt from taxation. Therefore, no provision for income taxes has been included in the Plan's financial statements.
