### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements**

### Note 1 – Plan Description

---

The following description of the Marks & Harrison 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### *General*

The Plan is a defined contribution plan covering all eligible employees of Marks & Harrison, P.C. (the “Company”) who are at least age 21. Employees are eligible to participate in the Plan after completing three consecutive months of service, with at least 250 hours of service. The entry date is the first day of a Plan year quarter after meeting the age and service requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### *Contributions*

The Plan provides for participant contributions of pre-tax and/or after-tax annual compensation, as defined in the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan or elect a specific deferral percentage. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation, with automatic increases of 1% annually, up to a maximum of 6%. Participants of qualifying age may make additional “catch-up” contributions. Participants may also contribute amounts representing distributions from other qualified plans. The Company makes safe harbor matching contributions to the participants’ accounts each payroll period. The Company matches 100% of the first 1% plus 50% of the next 5% of eligible compensation deferred. The Company may contribute additional profit-sharing amounts at the option of the Board of Directors. Contributions are subject to certain limitations.

#### *Participant Accounts*

Each participant’s account is credited with the participant’s contributions, the Company’s contributions, an allocation of Plan earnings (losses), and is charged with benefit payments, transaction fees related to notes receivable from participants, and allocations of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### *Vesting*

Participants are immediately vested in their contributions, the Company’s safe harbor contributions plus actual earnings thereon, and the Company’s discretionary profit-sharing contributions plus actual earnings thereon.

#### *Notes Receivable from Participants*

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, reduced by the highest outstanding balance of any loan to them made in the prior twelve months, or 50% of their vested account balance. The loans are secured by the balance in the participant’s account and bear interest at the prime rate. At December 31, 2024, outstanding notes bore interest rates ranging from 3.25% to 8.50%. Principal and interest are paid ratably through payroll deductions.

### *Payment of Benefits*

Distribution of the vested portion of a participant's account will occur upon the participant's termination of service, retirement, death, disability, or hardship withdrawal, as defined in the Plan. A participant is entitled to receive a lump-sum or an installment payment in an amount equal to the vested value of his or her account. The Plan allows for terminated participant vested account balances of \$7,000 or less to be automatically distributed without the participant's consent.

## **Note 2 – Summary of Significant Accounting Policies**

---

### *Basis of Accounting*

The financial statements of the Plan are prepared under the accrual method of accounting.

### *Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the Plan's management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from the estimates.

### *Investment Valuation and Income Recognition*

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest.

### *Benefit Payments*

Benefits paid to participants are recorded when paid.

### *Administrative Expenses*

Plan fees and administrative expenses are paid by the Company or the Plan on a discretionary basis.

### Note 3 – Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

### Note 7 – Tax Status

---

The Plan adopted a non-standardized plan sponsored by Ascensus, LLC and has not requested a determination letter but rather has relied upon the Internal Revenue Service opinion letter dated June 30, 2020 issued on the non-standardized plan stating the Plan and related trust are designed in accordance with applicable provisions of the *Internal Revenue Code (IRC)*. The Plan has been amended since receiving the opinion letter. However, the Plan Administrator believes that the Plan is designed and is currently being operated in accordance with the applicable requirements of the *IRC*.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that, more-likely-than-not, would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.
