### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audits***

We were engaged to perform audits of the financial statements of Munson 403(b) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the years then ended and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023 and for the years then ended stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### ***Disclaimer of Opinion***

We do not express an opinion on the accompanying financial statements of the Plan. Because of the significance of the matter described in the *Basis for Disclaimer of Opinion* section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

### ***Basis for Disclaimer of Opinion***

As described in Note 3, the Plan has excluded from investments in the accompanying statement of net assets available for benefits certain annuity and custodial accounts issued to current and former employees prior to January 1, 2009, as permitted by the DOL's Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*. If the identified contracts, as reported by the plan administrator, were included, net assets would increase by approximately \$20.9 million and \$20.6 million as of December 31, 2024 and 2023, respectively. Furthermore, investment income of approximately \$3.3 million and \$3.7 million and distributions of approximately \$3.1 million and \$2.5 million related to such accounts, as identified by the plan administrator, have also been excluded from the accompanying statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, respectively. Accounting principles generally accepted in the United States of America (GAAP) require that these accounts and the related income and distributions be included in the accompanying financial statements.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

**Note 1 - Plan Description**

The following description of Munson 403(b) Plan (the "Plan") provides only general information. Participants should refer to the plan document or summary plan description for a more complete description of the Plan's provisions.

***General***

The Plan was originally established by Munson Medical Center effective January 1, 1985. The Plan was amended and restated in its entirety effective January 1, 2020. The plan sponsor is Munson Healthcare (the "Organization"). The Plan was established for the employees of the Organization and consolidating entities that are exempt under Internal Revenue Code (IRC) Section 501(c)(3). The Plan is a defined contribution plan that provides benefits to eligible participants, as determined according to the provisions of the plan document. The Plan is intended to qualify under and satisfy the requirements of IRC Section 403(b). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

***Contributions***

The Plan provides for employee salary deferral contributions up to a maximum percentage of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code.

The Organization makes matching contributions for certain eligible participants based on a percentage of eligible compensation, as defined by the Plan.

Certain employees who chose to remain active in the Organization's defined benefit pension plan are not eligible for employer matching contributions. These employees are allowed to defer up to the maximum amount that will not cause the Plan to fail certain nondiscrimination tests subject to the limits of the IRC.

Eligible participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan. The Plan also includes a qualified Roth contribution program.

Certain employees are covered by a collective bargaining agreement. Employer contributions for these employees will be subject to the terms of the collective bargaining agreement.

***Participant Accounts***

Each participant's account is credited with the participant's contributions and allocations of the Organization's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

***Vesting***

Participants are immediately 100 percent vested in their voluntary and rollover contributions to the Plan plus actual earnings thereon. Employer contributions vest according to a five-year vesting schedule. Participants become 100 percent vested on their normal retirement date.

***Forfeitures***

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future organization contributions.

**Note 1 - Plan Description (Continued)**

***Benefit Payments***

Upon retirement, termination, death, or disability, a participant or his or her beneficiary may receive (1) a lump-sum payment equal to the value of the participant's account balance; (2) substantially equal cash installments over a period that does not extend beyond the participant's life or beyond the lives of the participant and his or her legal beneficiary; or (3) designated sums from time to time, as elected by the participant.

***Participant Notes Receivable***

Participants may borrow from their accounts subject to certain maximum and minimum amounts prescribed in the Plan and in the Internal Revenue Code. Notes receivable bear interest at a market rate.

***Party-in-interest Transactions***

Certain plan assets are in investment funds managed by State Street Bank and Trust Company (State Street) and The Standard Insurance Company (The Standard). State Street and The Standard are the custodians of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

***Termination***

While it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

**Note 2 - Summary of Significant Accounting Policies**

***Investment Valuation and Income Recognition***

Investments held by the Plan are stated at fair value except as noted below. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

The fully benefit-responsive investment contract is valued at contract value. Contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

***Benefit Payments***

Benefits are recorded when paid.

***Administrative Expenses***

Various administrative costs are paid by the Organization. Fees incurred as a result of participant-directed transactions (e.g., participant loan origination) are charged directly to the participant's account.

**Note 2 - Summary of Significant Accounting Policies (Continued)**

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including September 24, 2025, which is the date the financial statements were available to be issued.

**Note 3 - Excluded Investments**

The Plan has excluded from investments in the accompanying statement of net assets available for benefits as of December 31, 2024 and 2023 certain annuity and custodial accounts issued to current and former employees prior to January 1, 2009, as permitted by the Department of Labor's Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*. If the identified contracts, as reported by the various custodians, were included, net assets would increase by approximately \$20.9 million and \$20.6 million as of December 31, 2024 and 2023, respectively. Furthermore, investment income of approximately \$3.3 million and \$3.7 million and distributions of approximately \$3.1 million and \$2.5 million related to such accounts, as identified by the various custodians, have also been excluded from the accompanying statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, respectively. In addition to these known excluded assets, there are also other undeterminable assets and related investment income that have been excluded from these statements. The owners of these contracts and custodial accounts are fully vested, and the benefits of these accounts are enforceable against the excluded custodians. Accounting principles generally accepted in the United States of America require that these accounts and the related income and distributions be included in the accompanying financial statements.

**Note 4 - Fair Value Measurements**

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the inputs and valuation techniques used to measure fair value.

***Level 1***

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

***Level 2***

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

**Note 4 - Fair Value Measurements (Continued)**

**Level 3**

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan's investments:

**Mutual Funds**

Mutual funds are valued at quoted prices reported in active markets.

**Interest-bearing Cash**

The fair value of these investments is based on their outstanding balances.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 5 - Certified Information**

State Street and The Standard hold the Plan's investments and execute certain investment transactions (see Note 3). The investment balances and related investment income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by State Street and The Standard.

**Note 6 - Tax Status**

The Plan, as adopted, is a volume submitter plan, which does not require an application for a determination letter from the Internal Revenue Service (IRS). The volume submitter plan has received a favorable notification letter from the IRS dated March 31, 2017. The Plan has not individually sought its own determination letter.

**Note 7 - Investment Contracts**

The Plan has a benefit-responsive investment contract with The Standard Insurance Company (The Standard). The Standard maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The interest crediting rate is based on a formula agreed upon with the issuer but may not be less than 1 percent. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the insurance company. Such events include termination of the contract, spinoffs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules. The plan administrator believes that the occurrence of any such events, which would limit the Plan's ability to transact at contract value with participants, is not probable.

The insurance company may terminate the contract with a 30-day advance written notice to the contract owner for reasonable cause, which includes the contract owner's failure to abide by state or federal law, failure to render performance necessary to comply with the terms of the contract, failure to maintain assets of at least \$25,000, plan disqualification, and failure to adopt the Plan in a reasonable period of time. If an event of default occurs and is not cured, the nondefaulting party may terminate the contract.

As described in Note 2, because the contract is fully benefit responsive, contract value is the relevant measurement attribute for that portion of the net assets attributable to the investment contract. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.
