Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

**Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. - Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit

### **Supplemental Schedules Required by ERISA**

The supplemental schedules identified in the table of contents are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

## Notes to Financial Statements

### **1. SIGNIFICANT ACCOUNTING POLICIES**

#### **BASIS OF ACCOUNTING**

The financial statements of the EDKO, LLC 401(k) Profit Sharing Plan (the Plan) have been prepared on the accrual basis of accounting.

#### **INVESTMENT VALUATION AND INCOME RECOGNITION**

For the year ended December 31, 2024 and 2023 the Plan's investments are held in pooled separate accounts reported at estimated fair market value. These accounts are considered Level 2, Fair Value Measurements. The fair value of these investments is measured by the underlying publicly traded funds.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

#### **PAYMENT OF BENEFITS**

Benefits are recorded when paid.

#### **USE OF ESTIMATES**

The preparation of the Plan's financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make significant estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the changes in net assets available for benefits during the reporting period and, when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

### **2. DESCRIPTION OF THE PLAN**

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **GENERAL**

The Plan is a defined contribution pension plan covering all employees of EDKO, LLC (the Company) who have attained the minimum requirements of one year of service following the employee's commencement date and are eighteen (18) years of age or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **CONTRIBUTIONS**

Each year, participants may contribute any percentage of pretax annual compensation or after-tax compensation (Roth elective deferrals), up to the maximum deferral allowed by law. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Plan sponsor, at its discretion, may contribute a matching and profit-sharing contribution. Matching contributions are limited annually to \$10,000.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 2% of eligible compensation.

## Notes to Financial Statements

### **PARTICIPANT ACCOUNTS**

Each participant's account is credited with the participant's contribution and allocations of (a) the Plan sponsor's contribution (if applicable), (b) Plan earnings and (c) charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **VESTING**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Companies matching contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after five (5) years of credited service.

### **INVESTMENT OPTIONS**

Upon enrollment in the Plan, a participant may direct contributions into selected pooled separate accounts that are administered by John Hancock. The available accounts allow the participant to choose from variety of investment objectives. If no investment options are chosen by the participant, the funds are invested in a portfolio of funds based on their age and retirement date.

### **PAYMENT OF BENEFITS**

On termination of service due to death, disability or retirement, a participant is entitled to receive the value of his account as soon as the distribution is administratively feasible. The participant may elect to receive the vested portion of the account in a lump-sum distribution.

### **FORFEITURES**

The forfeited, nonvested accounts for the years ended December 31, 2024 and December 31, 2023 were \$18,125 and \$16,254 respectively. These amounts will be used to reduce employer contributions and pay plan expenses.

### **Expenses**

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in administrative expenses. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account.

### **3. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to modify, suspend, or discontinue contributions to the Plan at any time, and such action shall not be deemed to be a termination of the Plan. The Plan sponsor also has the right to terminate the Plan subject to the provisions of ERISA.

In the event of Plan termination, each participant will become 100% vested in his or her account balance. Each participant, retired participant or beneficiary shall be entitled to receive any amounts then credited to his or her account.

### **4. FAIR VALUE MEASUREMENTS (UNAUDITED)**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets. Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3.

Pooled separate accounts are reported at fair value based on Level 2 inputs. The Level 2 inputs consist of quoted market prices for various securities held in pooled separate accounts. The fair value hierarchy presentation for investments reported at fair value as of December 31, 2024 and 2023.

### **6. INCOME TAX STATUS**

The Internal Revenue Service has ruled that the Plan qualifies under Section 401(a) of the Internal Revenue Code (IRC) and is, therefore, not subject to tax under present income tax law. Since being qualified by the Internal Revenue Service the Plan has been amended. The Plan administrator and the Plan's trustee believe that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. The sponsor is not aware of any course of action or series of events that have occurred that might adversely affect the Plan's qualified status.

### **7. PARTY IN INTEREST TRANSACTIONS**

Certain Plan investments are shares of pooled separate accounts managed by John Hancock Life Insurance Company. The Plan sponsor is party to agreements with John Hancock, John Hancock Life Insurance Company, Wells Fargo Advisors, LLC, and Heard, McElroy, & Vestal. These entities provide investment management, recordkeeping services, and administration to the Plan. Due to the services provided by these companies, each of them is considered a party-in-interest.

### **8. MANAGERMENTS' REVIEW**

The Plan sponsor has evaluated subsequent events through October 2, 2025, which is the date the financial statements were available to be issued. There were no subsequent events that require recording or disclosure in the financial statements for the year ended December 31, 2024.

### **9. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

### **10. SECURE ACT 2.0**

The SECURE Act 2.0 was signed into law in December 2022. SECURE Act 2.0 includes numerous reforms to existing retirement law intended to increase retirement savings, facilitate access to retirement savings, encourage employees to save for retirement, and simplify and clarify retirement plan rules.


