## Independent Auditor's Report

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed audits of the financial statements of Munson 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the years then ended and the related notes to the financial statements.

### Note 1 - Plan Description

The following description of Munson 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document or summary plan description for a more complete description of the Plan's provisions.

#### **General**

Effective January 1, 1997, Munson Healthcare (the "Organization") implemented the Plan. The Plan is a defined contribution plan that provides benefits to eligible participants, as determined according to the provisions of the plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan originally was established for the employees of the Organization's for-profit wholly owned subsidiaries and the employees of the entities that were exempt under Internal Revenue Code (IRC) Section 501(c)(3).

#### **Contributions**

The Plan provides for employee salary deferral contributions up to the maximum amount that will not cause the Plan to fail certain nondiscrimination tests subject to the limits of the Internal Revenue Code for participants employed by Munson Healthcare's for-profit and not-for-profit entities.

The Organization makes matching contributions for certain eligible participants based on a percentage of eligible compensation, as defined by the Plan.

In addition, the Organization makes an annual discretionary contribution of 3 percent of eligible employees' compensation. For the purpose of the discretionary contribution into the Plan, participants include the employees of both the Organization's for-profit and not-for-profit subsidiaries. All participants also may make contributions to the Plan in the form of a rollover of funds from another qualified plan. The Plan includes a qualified Roth contribution program for all participants.

Certain employees who chose to remain active in the Organization's defined benefit pension plan are not eligible for employer matching and discretionary contributions. These employees are allowed to defer up to the maximum amount that will not cause the Plan to fail certain nondiscrimination tests subject to the limits of the IRC.

Certain employees are covered by a collective bargaining agreement. Employer contributions for these employees will be subject to the terms of the collective bargaining agreement.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Organization's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

#### **Vesting**

Participants are immediately 100 percent vested in employee and rollover contributions and any income or loss thereon. Matching and discretionary contributions made to the Plan by the Organization vest according to a five-year vesting schedule. Employees of Northern Michigan Supply Alliance, a separate employer participating in the Plan, vest according to a four-year vesting schedule. Participants become 100 percent vested on their normal retirement date.

### Note 1 - Plan Description (Continued)

#### ***Forfeitures***

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce administrative expenses and future employer contributions of the Plan. At December 31, 2024 and 2023, forfeited account balances totaled \$231,157 and \$108,917, respectively.

The Plan used approximately \$248,000 and \$417,000 for the years ended December 31, 2024 and 2023, respectively, to reduce administrative expenses and employer contributions.

#### ***Benefit Payments***

Distributions are payable upon retirement, death, disability, or termination of employment in the form of (1) a lump-sum amount equal to the vested balance of a participant's account; (2) substantially equal cash installments over a period that does not extend beyond the participant's life or beyond the lives of the participant and his or her legal beneficiary; or (3) designated sums from time to time, as elected by the participant.

#### ***Participant Notes Receivable***

Participants may borrow from their accounts subject to certain maximum and minimum amounts prescribed in the Plan and in the Internal Revenue Code. Notes receivable bear interest at a market rate.

#### ***Party-in-interest Transactions***

Certain plan assets are in investment funds managed by State Street Bank and Trust Company (State Street). State Street is the custodian of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

During 2024, the Plan received notice from the Department of Labor (DOL) indicating that the nonexempt transaction from 2020 was not fully corrected. During the Plan year ended December 31, 2020, the Plan reimbursed the Organization for certain administrative expenses, which qualified as a nonexempt transaction. This resulted in an inadvertent loan as of December 31, 2020 and December 31, 2021, when it was initially corrected. The DOL notice indicated the nonexempt transaction was not fully corrected, as the full amount of lost earnings had not been remitted to the Plan. The remaining lost earnings were remitted to the Plan in 2024, which fully corrected the transaction (see the schedule of nonexempt transactions).

#### ***Termination***

While it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan document and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

### Note 2 - Summary of Significant Accounting Policies

#### ***Investment Valuation and Income Recognition***

Investments held by the Plan are stated at fair value except as noted below. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for further discussion of fair value measurements.

The fully benefit-responsive investment contract is valued at contract value. Contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

**Note 2 - Summary of Significant Accounting Policies (Continued)**

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

***Benefit Payments***

Benefits are recorded when paid.

***Administrative Expenses***

Various administrative costs are paid by the Organization. Fees incurred as a result of participant-directed transactions (e.g., participant loan origination) are charged directly to the participant's account.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including September 24, 2025, which is the date the financial statements were available to be issued.

**Note 3 - Fair Value Measurements**

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

***Level 1***

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

***Level 2***

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

**Note 3 - Fair Value Measurements (Continued)**

**Level 3**

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan's investments:

**Mutual Funds**

Mutual funds are valued at quoted prices reported in active markets.

**Interest-bearing Cash**

The fair value of interest-bearing cash is based on the outstanding balances.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 4 - Certified Information**

State Street holds the Plan's investments and executes all investment transactions. The investment balances and related investment income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by State Street.

**Note 5 - Tax Status**

The Plan has received a determination letter from the Internal Revenue Service indicating that the Plan, as designed, is qualified for tax-exempt treatment under the applicable section of the Internal Revenue Code. Accordingly, no provision for income taxes has been made in the accompanying financial statements.

**Note 6 - Investment Contracts**

The Plan has a benefit-responsive investment contract with Standard Insurance Company (The Standard). The Standard maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The interest crediting rate is based on a formula agreed upon with the issuer but may not be less than 1 percent. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the insurance company. Such events include termination of the contract, spinoffs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules. The plan administrator believes that the occurrence of any such events, which would limit the Plan's ability to transact at contract value with participants, is not probable.

The insurance company may terminate the contract with a 30-day advance written notice to the contract owner for reasonable cause, which includes the contract owner's failure to abide by state or federal law, failure to render performance necessary to comply with the terms of the contract, failure to maintain assets of at least \$25,000, plan disqualification, and failure to adopt the Plan in a reasonable period of time. If an event of default occurs and is not cured, the nondefaulting party may terminate the contract.

As described in Note 2, because the contract is fully benefit responsive, contract value is the relevant measurement attribute for that portion of the net assets attributable to the investment contract. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.
