Note 1. Description of the Plan

The following description of the Porte Brown LLC 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan that is sponsored by Porte Brown LLC (the “Employer”) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan consists of a 401(k) elective deferral component and a non-elective profit sharing component.

Eligibility

The Plan covers all employees who are at least 21 years of age. In order to be eligible to make elective 401(k) deferrals to the Plan, employees must have completed one month of service, while employees must have completed one year of service in order to participate in the profit sharing component of the Plan. Eligible employees may participate in the 401(k) portion of the Plan on the first day of the month coinciding with or next following their meeting the age and period of service requirements. Eligible employees may participate in the profit sharing portion of the Plan on the first day of the Plan year or the first day of the seventh month coinciding with or next following their meeting the age and period of service requirements.

Contributions

Each year, participants may contribute up to the maximum amount allowed under the Internal Revenue Code, and those who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Plan also provides that the Employer may make a discretionary profit sharing contribution to the Plan in amounts as determined by the Employer’s Board of Directors, Participants must be employed on the last day of the Plan year in order to receive a portion of this discretionary contribution.

Participants direct the investment of their contributions and the Employer profit sharing contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a collective trust fund as investment options for participants.

Note 1. Description of the Plan (continued)

Participants' accounts

Each participant's account is credited with (a) the participant's elective 401(k) contributions, (b) an allocation of the Employer profit sharing contribution, and (c) earnings or losses on their individual investments. Participants may change their investment elections daily for both existing account balances and future contributions.

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at a rate established by the plan administrator based upon prevailing interest rates. Principal and interest are to be paid ratably through payroll deductions but may also be repaid through a separate payment.

Vesting and forfeitures

Participants are immediately vested in their own contributions, plus actual earnings thereon. Generally, vesting in the Employer's discretionary profit sharing contribution portion of their account, plus actual earnings thereon, is based on years of continuous service and is subject to the following vesting schedule:

In the event there are forfeitures, such amounts may be used to pay administrative expenses of the Plan or to reduce employer contributions. At December 31, 2024, forfeited nonvested accounts amounted to \$27,916 (\$11,711 at December 31, 2023). In addition, \$16,444 was used to pay administrative expenses of the Plan during the year ended December 31, 2024 (\$18,989 for the year ended December 31, 2023).

Payment of benefits

Upon termination of employment, death, or total or permanent disability, participants may receive the value of the vested interest in their account as a lump-sum distribution. In addition, participants may elect to receive hardship withdrawals, as defined in the Plan agreement. In-service distributions are also permitted and may be made to a participant who has not separated from service provided they have attained age 60.

Note 2. Summary of significant accounting policies

Basis of accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis, and related fees are charged directly to the borrowing participant's account when incurred. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document. During the year ended December 31, 2024 delinquent loans reclassified as benefit payments were \$5,435 (\$27,707 for 2023).

Payment of benefits

Benefits are recorded when paid.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year. During 2024 and 2023, the Plan's investments (including gains and losses on investments bought, sold and held during the year) appreciated in value by \$2,417,070 and \$3,622,549, respectively.

Note 3. Fair value measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

*Level 1 Fair Value Measurements*

The fair value of mutual funds are based on quoted net asset values of the shares held by the Plan and as reported by the fund. The mutual held by the Plan are open-end funds that are registered with the U.S. Securities and Exchange Commission. The funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds and money market funds held by the Plan are considered to be actively traded.

*Investment measured at net asset value*

The investment measured at net asset value (NAV) represents units in the MetLife Stable Value Fund – Series 25053, which is a stable value collective trust fund that invests in high-quality bonds with short to intermediate-term maturities. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value and is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily and there are no unfunded commitments. Were the Plan to initiate a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations would be carried out in an orderly business manner. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

Note 4. Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 5. Related party transactions and expenses

Certain Plan investments are shares of mutual funds managed by Vanguard Investments. Vanguard Investments is associated with Ascensus Trust Company, the trustee of the Plan and, therefore, these transactions qualify as party-in-interest transactions. These party-in-interest transactions, however, are exempt from the prohibited transaction rules of ERISA.

Certain administrative expenses of maintaining the Plan are paid by the Employer on behalf of the Plan. These expenses, however, are not material to the financial statements. In addition, investment-related expenses are included in net appreciation (depreciation) in fair value of investments. Fees for the administration of notes receivable from participants are charged directly to the participant's account. In addition, as described in Note 6, the form of the Plan is both designed by and sponsored by the Employer.

Finally, certain employees of the Employer serve as Plan Administrators for the Plan. These employees are also participants in the Plan. The employees do not receive any compensation from the Plan for services performed as Plan Administrators.

Note 6. Income tax status

The Employer has adopted a Non-Standardized Pre-Approved Profit Sharing and Money Purchase Plan with CODA that is both designed by and sponsored by Porte Brown LLC, the Employer. The Internal Revenue Service has determined and informed the Employer by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Note 6. Income tax status (continued)

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

Note 7. Plan termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in their accounts.

Note 8. Date of management's review

Subsequent events were evaluated through October 3, 2025, which is the date the financial statements were available to be issued.

Note 9. Information prepared and certified by the trustee
