Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of CW Financial Services LLC Investment Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

(1) Description of Plan

The following brief description of the CW Financial Services LLC Investment Plan (the Plan) is provided for general information purposes. Participants should refer to the Plan document for more complete information.

(a) General

CW Financial Services LLC sponsors the Plan, which is a defined contribution plan established to provide a savings and investment vehicle to substantially all employees of CW Financial Services LLC and its affiliates (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. John Hancock Trust Company LLC (John Hancock) serves as trustee and custodian for the Plan. John Hancock Retirement Plan Services LLC (JHRS) serves as the recordkeeper for the Plan.

(b) Contributions

Any employee who has attained the age of 21 shall be eligible to participate in the Plan. A participant contributes under a salary deferral agreement. The minimum contribution that may be specified by a participant for any payroll period is 1% of eligible compensation, and the maximum contribution is 100% of eligible compensation for pretax compensation deferral agreements. Participants who have attained age 50 may also be eligible to make catch-up contributions in accordance with the Internal Revenue Code (the Code). Participant contributions are limited under the Code. Participants may also contribute amounts representing rollovers from other qualified defined contribution plans.

The Company matched 50% of the first 6% of eligible compensation deferred by each participant for the years ended December 31, 2024 and 2023. The Plan allows the Company to make a discretionary profit-sharing contribution to participants with at least 1,000 hours of service in the Plan year. The Company did not make any profit-sharing contributions related to the 2024 and 2023 plan years.

The Plan includes an auto-enrollment provision, whereby all newly hired employees who become eligible for the plan are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have the deferral rate set at 6% of eligible compensation and their contributions are invested in a designated fund until changed by the participant.

(c) Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution, the Company's matching and profit-sharing contributions, and allocations of Plan earnings or losses, and charged with participant withdrawals, and an allocation of fees and revenue sharing related to each mutual fund. Allocations are based on participant earnings or account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(d) Investments

Participants direct the investment of their contributions and Company contributions into various investment options offered by the Plan. The Plan offers its participants a variety of investment options including several mutual funds and a pooled separate account.

(e) Vesting

Participants vest immediately in the value of their accounts attributable to their contributions. Participants become vested in the value of their accounts attributable to Company matching and profit-sharing contributions ratably over four years of service to the Company or upon disability or death while employed by the Company.

(f) Forfeitures

Forfeited nonvested accounts of \$7,000 and \$11,221 were utilized to reduce Company contributions and pay administrative expenses for the years ended December 31, 2024, and 2023, respectively. Unallocated forfeited balances at December 31, 2023 and 2022 were \$4,953 and \$1,492, respectively.

(g) Payment of Benefits

Plan provisions allow participants to receive distributions of their vested account balance upon termination or upon meeting Plan requirements for in-service withdrawals. All withdrawals are prorated from each participant's investment funds. The amount available for withdrawal is determined by the previous day's market value. Certain other provisions, as described more fully in the Plan document, address withdrawals.

(h) Notes Receivable from Participants

The trustee has the authority to make loans from participants' respective accounts to participants with vested account balances of at least \$2,000 to the extent that no more than one loan is outstanding with respect to any participant at any given time. The minimum loan available is \$1,000, and the maximum loan available is 50% of the participant's vested account balance, up to a limit of \$50,000. The interest rate on any loan is prime plus 1%, as determined as of the date the loan is initiated. The term of the loan is normally not to exceed five years. Loans for the purchase of a primary residence may be extended to 15 years. All loans are secured by the participant's interest in benefits accumulated under the Plan. Principal and interest are paid through payroll deductions or through direct payments by the participant.

(2) Significant Accounting Policies

(a) Basis of Accounting

The Plan's financial statements have been prepared on the accrual basis and in conformity with accounting principles generally accepted in the United States of America (GAAP).

(b) Use of Estimates

The preparation of the Plan's financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

(c) Risks and Uncertainties

The Plan invests in mutual funds, which hold various securities, including U.S. government securities, corporate debt instruments, and corporate stocks. The Plan also invests in the Anchor Account, which invests primarily in government securities, private and public mortgage-backed securities, asset backed securities and investment grade corporate obligations. Investment securities, in general, are exposed

to various risks such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

(d) Investments Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. If available, quoted market prices are used to value investments.

(e) Benefits Paid

Benefits paid are recorded upon distribution.

(f) Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

(g) Expenses

The Plan's fee agreement with John Hancock is a levelization program whereby fees paid to John Hancock are fixed in terms of a target basis point amount. In addition, individual participants are charged for the direct costs related to mutual funds they selected, and John Hancock also passes through a portion of revenue sharing amounts it receives from certain mutual funds directly to participants selecting those funds as fee credits. Therefore, these amounts are reflected directly in participant accounts. All other amounts paid to service providers are included in administrative expenses.

(h) Reclassification

Certain amounts from prior year have been reclassified to conform to the current year's presentation.

(3) Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level I – Inputs are unadjusted, quoted prices in active markets for identical assets or liabilities at the measurement date.

Level II – Inputs (other than quoted prices included in Level I) are either directly or indirectly observable for the asset or liability through correlation with market data at the measurement date and for the duration of the instrument's anticipated life.

Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level III – Inputs reflect management’s best estimate of what market participants would use in pricing the asset or liability at the measurement date. Consideration is given to the risk inherent in the valuation technique and the risk inherent in the inputs to the model. Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Assets are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. A summary of the Plan’s investments measured at fair value on a recurring basis, as of December 31, 2024 and 2023, are as follows:

Shares of mutual funds are valued at closing daily prices as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual

funds held by the Plan are deemed to be actively traded. The Plan invests in a Pooled Separate Account (the Anchor Account) that is reported at fair value. The investment contract is a group annuity contract issued by New York Life Insurance, which participates in the investment returns of New York Life's Pooled Separate Account No. 25. The fair value of the Pooled Separate Account is based on the net asset value of the underlying investments. Where quoted market prices are not available, fair values are primarily determined using pricing models using observable market data or quoted prices of securities with similar characteristics.

(4) Information Certified by the Trustee

The Plan has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Plan has obtained certification from the trustee as to the investments and notes receivable on the statements of net assets available for benefits as of December 31, 2024 and 2023, and related financial statement disclosures, the investment income (loss) reflected in the statement of changes in net assets available for benefits for the years ended December 31, 2024, and the investment information included in the supplemental schedule H, Line 4i Schedule of Assets Held as of December 31, 2024. As permitted under such election, the Plan instructed the Plan's independent auditors not to perform any auditing procedures with respect to all such information, which was certified as complete and accurate by the Plan's trustee.

(5) Income Tax Status

The Plan's management received a favorable determination letter from the IRS, dated June 30, 2020. The Plan's management believes that the Plan is currently designed and being operated substantially in compliance with the applicable requirements of the Code. Therefore, no provision for income tax has been included in the Plan's financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

(6) Plan Termination

The Plan was established with the intention that it will continue indefinitely. However, the Company reserves the right to suspend its contribution or to terminate the Plan at any time subject to the provisions set forth in ERISA. In the event the Plan is terminated, all individual participants will become fully vested in their accounts and any funds held by the trustee, which are not in individual participant accounts, will be distributed to participants proportionately according to their account balances.

(7) Party-In-Interest Transactions

Fees paid by the Plan to John Hancock for various administrative fees totaled \$69,722 and \$64,885 for the years ended December 31, 2024 and 2023, respectively. These fees and fees paid to other service providers qualify as exempt party-in-interest transactions. The Plan holds a John Hancock mutual fund and notes receivable from participants, both are also considered exempt party-in-interest transactions.

(8) Subsequent Event

The Plan evaluated subsequent events and transactions that occurred after December 31, 2024 through October 6, 2025, which is the date the financial statements were available to be issued.
