We have performed audits of the financial statements of PayTech, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and 2023 and the related statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

**1) Description of the Plan**

**General Overview**

The following description of the PayTech 401(k) Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

PayTech 401(k) Plan ("Plan") was established January 1, 1999. The Plan is a defined contribution plan, which is a single-employer plan. The Plan operates on a calendar year ending on December 31. The Plan is available to substantially all employees who are 21 years of age or older and have completed six months of service. Principal Financial Group, Inc. administers and invests the assets of the Plan and the income therefrom for the benefit of Plan's participants.

**Contributions**

Eligible employees are able to make contributions to the Plan through wage deferral agreements. The annual maximum contribution per participant is limited to the lesser of their annual compensation, as defined in the Plan, or the maximum Section 401(k) contributions allowed under the Internal Revenue Code ("IRC"). In addition, participants aged fifty (50) and over are allowed to make catch-up contributions, subject to IRC limitations. Participants may also contribute distributions from other qualified plans ("rollovers"). Participants direct the investment of their accounts (including employee and Company contributions) into various investment options offered by the Plan. The Plan currently offers a series of varied risk pooled separate account options and a common collective trust fund.

Participants meeting certain criteria, as defined by the Plan document, are eligible for a matching contribution ("Company Match") equal to 50% of the participant's elective deferral, not to exceed 5% of the participant's compensation.

Additional discretionary contributions may be made each year. The allocation of discretionary contributions is defined in the Plan document. Discretionary contributions were \$0 for the years ended December 31, 2024 and 2023.

**Participant Accounts**

Individual accounts are maintained for Plan participants. Each participant is credited with the participant's contributions and allocation of (a) the Company's matching contributions and (b) Plan earnings, and (c) charged with withdrawals as well as an allocation of administrative expenses. Allocations are based on the proportion that each participant's account balance bears the total of all participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Payment of Benefits**

On termination of service due to death, disability, or retirement, a participant (or participant's beneficiary in the case of death) may elect to rollover the value of the vested interest in his or her account to another qualified plan, to receive the value as a lump-sum distribution or, if the participant's vested account is more than \$5,000, elect to remain in the Plan.

**Forfeited Accounts**

When a participant terminates, the unvested portion of the participant's account represents a forfeiture, unless the participant resumes service within 5 years (as further defined in the Plan document). Forfeitures may first be used to pay Plan expenses. Any forfeitures left after paying plan expenses may be used to offset the Company's next contribution. If any forfeitures remain, such forfeitures will be reallocated. On both December 31, 2024 and 2023, forfeited non-vested accounts totaled \$39,066 and \$14,090, respectively.

**2) Summary of Significant Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

**Payment of Benefits**

Benefits are recorded when paid.

**Expenses**

Certain expenses for maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

**3) Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1:

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2:

Inputs to the valuation methodology include

- unadjusted quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3:

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

**4) Related-Party Transactions and Party-in-Interest Transactions**

Principal Life Insurance Company (Principal) manages Certain Plan investments. Principal is the custodian and recordkeeper for the Plan, and therefore, these transactions qualify as a party in interest transactions.

**5) Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

**6) Tax Status**

The Internal Revenue Service has determined that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with applicable requirements of the IRC and therefore believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any periods in progress.

**7) Risk and Uncertainties**

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonable that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

**8) Certified Investments**

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the plan administrator and certified as complete by Principal (the custodian and recordkeeper of the Plan).

**9) Reconciliation of Financial Statements to Form 5500**

The accompanying financial statements present the net assets available for benefits of the Plan on an accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America. Form 5500 reflects certain information on a cash basis or modified cash basis in accordance with regulatory requirements under the Employee Retirement Income Security Act of 1974 (ERISA). Accordingly, the net assets available for benefits reported in the financial statements differ from those reported on the Form 5500 due to timing differences.

**Pooled Separate Accounts**

Valued at the net asset value (NAV), which approximates the closing price reported on the active market on which the individual securities of the pool are traded. Securities in the active market are adjusted for internal fees and pooled into an adjusted market price. The Plan has concluded that the NAV as adjusted (for mutual fund dividends, mutual fund splits and administrative maintenance charges and other items) and reported by the insurance company approximates fair value of the investments. The investments are redeemable at the adjusted NAV under agreements with the insurance company. Plan participants have the ability to redeem these investments with a one-day notice. However, it is possible that redemption rights may be restricted or eliminated in the future. Due to the nature of the investments, changes in market conditions, liquidity requirements, and the economic environment may significantly affect the NAV of pooled separate accounts and, consequently, the fair value of the Plan's investments. The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. The NAV of Pooled Separate Accounts as of December 31, 2024 and 2023 were \$11,616,233 and \$10,102,747, respectively.

**Contributions receivable**

Contributions receivable represents amounts due from participants and the employer for contributions earned prior to year-end but deposited to the Plan subsequent to the fiscal year-end. These receivables are recorded when earned and are generally collected within a short period after year-end. Contributions receivable as of December 31, 2024 and 2023 were \$338,732 and \$419,715, respectively.
