Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of Adena Health System Defined Contribution Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the years then ended and the related notes to the financial statements.

Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that audits conducted in accordance with GAAS will always detect a material misstatement when it exists. Note 1 - Plan Description

The following description of Adena Health System Defined Contribution Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a noncontributory defined contribution plan, established on January 1, 1998 and restated as of January 1, 2021, covering employees of the Plan's sponsor, Adena Health System (the "System"). System matching contributions were made for employees who participate in the 403(b) plan sponsored by the System, Adena Health System Tax Deferred Annuity/Matched Savings Plan. Additionally, employees were able to receive system discretionary contributions upon completion of one year of service (at least 1,000 hours). Physicians who signed initial contracts after June 1, 1998 are excluded from participation in the Plan. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective January 1, 2021, the Plan was frozen following a plan restatement. As a frozen plan, the System will not make any contributions with respect to plan compensation earned after such date. In addition, no employee will become a participant after the date the Plan is frozen.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the System's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Vesting

Vesting is based on years of service. Participants are 100 percent vested in matching contributions upon completion of one year of service, defined as 1,000 hours of service within one year. For discretionary contributions, under the original plan, a participant is 100 percent vested after one year of service, defined as a minimum of 800 hours of service within one year. Employees entering into the Plan prior to July 1, 2004 are grandfathered according to the original document specifications for vesting. Employees entering the Plan after July 1, 2004 are 25, 50, 75, and 100 percent vested in discretionary contributions after two, three, four, and five years of service, respectively, defined as a minimum of 1,000 hours of service within a year.

Benefit Payments

A participant shall be entitled to a distribution of his or her account balance upon death, disability, termination of employment, or attainment of the normal retirement age. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account and may be provided in the form of a lump-sum distribution or various installments, as defined in the plan document.

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to pay plan expenses. At December 31, 2024 and 2023, forfeited account balances totaled \$929,330 and \$722,999, respectively. The forfeiture balances are included within the fixed-interest investment account.

Note 1 - Plan Description (Continued)

Termination

While it has not expressed any intent to do so, the System has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, all participants shall be fully vested and nonforfeitable with respect to amounts credited to participants' accounts. The Plan shall make full provisions to pay retirement benefits to which participants and their beneficiaries are entitled but only to the extent such provisions have not previously been made.

Administration

The System is the sponsor of the Plan. The retirement committee, as provided in the plan agreement, is the plan administrator and has responsibility for the administration of the Plan. VALIC Trust Company Inc. (formerly known as AIG Federal Savings Bank) (VALIC) functions as the trustee and investment manager.

Party-in-interest Transactions

Certain plan assets are investment funds managed by VALIC or its affiliates. VALIC is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value except the fully benefit-responsive unallocated investment contract valued at contract value. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

All other investments are valued based on quoted market prices reported in active markets. See Note 6 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Certain administrative expenses, including audit fees, are paid by the System.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain amounts and disclosures at the date of the financial statements and during the reporting period. Accordingly, actual results may differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 2 - Summary of Significant Accounting Policies (Continued)

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including August 14, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

VALIC Trust Company Inc. (the "Trustee") holds the Plan's investments and executes all investment transactions. The investment balances and related investment income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

Note 4 - Tax Status

Effective January 1, 2021, the Plan adopted a preapproved plan. There were no changes to the Plan as a result of the adoption of the preapproved plan except for the election to freeze the Plan to new participants and contributions. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

Note 5 - Investment Contract

The Plan has a benefit-responsive investment contract with The Variable Annuity Life Insurance Company (VALIC Life). VALIC Life maintains these contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

There are no reserves against contract value for credit risk of the contract issuers or otherwise. The interest crediting rate is based on a formula agreed upon with the contract issuers but may not be less than 2 percent for accounts set up on or after December 1, 2003 and 3 percent for accounts set up prior. Such interest rates are reviewed on a periodic basis for resetting. When establishing interest crediting rates for this product, VALIC Life considers many factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer's general account.

Certain events limit the ability of the Plan to transact at contract value with the insurance company. Such events include the following: (i) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (ii) changes to the Plan's prohibition on competing investment options or deletion of equity wash provision, (iii) bankruptcy of the plan sponsor or other plan sponsor events (e.g., divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or (iv) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator believes that the occurrence of any such events, which would limit the Plan's ability to transact at contract value with participants, is not probable. There are no events that allow the issuer to terminate the contract and that require the plan sponsor to settle an amount different than contract value paid either within 90 days or over time.

As described in Note 2, because the contract is fully benefit responsive, contract value is the relevant measurement attribute for that portion of net assets attributable to the investment contract. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

Note 6 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The Plan measures mutual funds at fair value on a recurring basis. The fair value of mutual funds is based primarily on Level 1 inputs, as described above. Total mutual fund investment balances were \$92,715,532 and \$88,559,689 at December 31, 2024 and 2023, respectively.
