A. DESCRIPTION OF PLAN

Nature of Operations

The following description of the William Cumming Chevrolet (the “Company”) 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement and the Summary Plan Description for a more complete description of the Plan’s provisions.

General

On June 1, 1985 the Board of the Plan’s sponsor, William Cumming Chevrolet (the Company), adopted a tax qualified employee savings and retirement plan covering the Company’s employees. The Plan is a defined contribution plan covering all full-time employees who have at least three months of service and have reached 20 years of age for elective deferral and employer matching. Eligibility for non-elective contributions is one year and 1,000 hours of service. The plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Pursuant to the Plan, Participants may elect to reduce their current compensation by up to the lesser of 100% of such compensation or the statutorily prescribed annual limit (\$23,000 and \$22,500 for the years ending 2024 and 2023, respectively) and have the amount of such reduction contributed to the Plan. Participants may also contribute amounts representing distributions from other qualified plans.

Participants age 50 years or older at the end of the plan year may make special catch-up contributions, up to a maximum of \$7,500 for both years ending December 31, 2024 and 2023, respectively.

The Company may decide to make regular matching contributions at a rate of 10% of employee deferrals. During the years ended December 31, 2024 and 2023, the Company made discretionary matching contributions of \$36,406 and \$32,114, respectively. The Company may decide each plan year whether to make a discretionary non-elective contribution on behalf of eligible employees. Such contributions are allocated, if made, in the ratio that each participant’s compensation compares to the compensation paid to all eligible employees during the Plan year.

Participant’s Accounts

Each participant’s account is credited with the participant’s contribution, employer matching contribution, an allocation of the Company’s discretionary contributions, and Plan earnings. Participant’s accounts are also charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances as defined. The benefits to which a participant is entitled are the benefits that can be provided from the participant’s vested account. Participant accounts are self-directed into variable annuities.

A. DESCRIPTION OF PLAN (continued)

Vesting

Participants are immediately vested in their voluntary contribution plus the actual earnings thereon. Employer matching and employer discretionary contributions are vested over a six-year period in 20% increments starting after the first year of service is completed.

Forfeited Accounts

Upon participant termination, non-vested employer contributions are forfeited and used to reduce Plan administrative expenses and or future employer contributions. At December 31, 2024 and 2023, the Plan had available \$87,320 and \$80,676 respectively, for use in future employer matching contributions or administrative fees. During both years ended December 31, 2024 and 2023, no forfeiture monies were used to fund employer contributions.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the vested value of his or her account, or, annual installments over a life expectancy as defined in the Plan. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum.

Administrative Expenses

The Plan's expenses are paid either by the Plan or the Company, as provided by the plan document. The Plan pays certain expenses incurred related to the general administration of the plan. Forfeited, non-vested accounts can be applied to administrative expenses. The expenses paid using the Plan's assets will generally be allocated among the accounts of all participants in the Plan and are recorded as deductions in the accompanying statement of changes in net assets available for benefits. During the years ended December 31, 2024 and 2023, administrative expenses paid from the Plan's assets and included in these financial statements were \$49,103 and \$42,838, respectively. All other administrative expenses, such as professional fees, are paid by the Company on behalf of the Plan.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to amend or discontinue its contributions at any time, and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become fully vested.

Participant Loans

Participants may not borrow from Plan assets; accordingly, there were no employee loans receivable at December 31, 2024 and 2023.

B. SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements are prepared using the accrual method of accounting.

Receivables

There were \$0 receivables from the Plan sponsor at both December 31, 2024 and 2023, respectively.

Payment of Benefits

Benefits are recorded when paid.

Valuation of Investments

The Plan's investments are stated at fair value. The interests in variable annuities are valued based on observable inputs, either directly or indirectly, which represent the net asset values of the variable annuity accounts held by the Plan at year-end. See Note C.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the USA requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets available for plan benefits during the reporting period. Actual results could differ from those estimates.

Subsequent Events

Subsequent events were evaluated by management through September 26, 2025, the date which financial statements were available to be issued.

C. FAIR VALUE MEASUREMENT

FASB, ASC 820 *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs. All of the Plans investments as of December 31, 2024 and 2023 were variable annuities which are valued based on observable inputs (assumptions obtained from independent sources), either directly or indirectly. Therefore, such investments are considered level two investments.

D. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

E. INFORMATION CERTIFIED BY PLAN TRUSTEE

The Plan administrator has elected the method of compliance by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The Plan administrator has obtained certification from Empower Retirement, LLC for the years ended December 31, 2024 and 2023, respectively, that the following information is complete and accurate:

- Investments had a fair value of \$4,845,426 and \$4,448,072 at December 31, 2024 and 2023, respectively, and are included in the schedule of assets held for investment purposes at the end of the plan year on page 12.
- Net investment gains were \$285,234 and \$415,048 from variable annuities and gains from dividends and interest were \$273,899 and \$173,767 for the years ended December 31, 2024 and 2023, respectively.

G. TRANSACTIONS WITH PARTY-IN-INTEREST

During 2024 and 2023, the Plan's investments were in variable annuities managed and held by Empower Retirement, LLC. As described in Note B, the Plan paid certain expenses related to plan operations and investment activity to various service providers. Fees of \$37,154 and \$31,042 were paid to Empower for recordkeeping and investment management services during the years ended December 31, 2024 and 2023, respectively.

During 2024 and 2023, Talcott Resolution Life Insurance was a party-in-interest covering the group annuity contract.

Merrill Lynch Pierce Fenner & Smith was a party-in-interest which provided the Plan investment advisory services for a fee of \$13,747 and \$11,796 during the 2024 and 2023 years, respectively.

HNK CPAs was a party-in-interest for both years 2024 and 2023. Auditing fees paid by the Company on behalf of the Plan were \$7,650 for both years ended December 31, 2024 and 2023, respectively. These transactions are party in interest transactions under ERISA.

H. INCOME TAX STATUS

The trust established under the Plan to hold the Plan's assets is qualified pursuant to the appropriate section of the Internal Revenue Code, and, accordingly, the trust's net investment income is exempt from income taxes.

The Plan has obtained its latest determination letter from the Internal Revenue Service on March 31, 2008, which stated that the plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. The plan has been amended since receiving the determination letter. However, the Plan sponsor and the plan's tax counsel believe the Plan is currently designed and being operated in compliance with applicable requirements of the Internal Revenue Code. Therefore, no provision for income tax has been included in the Plan's financial statements. See Note I for a summary of amendments made since the date of the last IRS determination letter.

The Plan sponsor believes the plan is no longer subject to informational return examinations for years prior to 2021.

I. COMMITMENTS & CONTINGENCIES

As of December 31, 2024 and 2023, the Plan had IRC compliance corrections due to participants of \$13,310 and \$12,817, respectively.

J. PLAN AMENDMENTS

From time to time, the Company has elected to amend the Plan. The following descriptions of the plan amendments provide only general information. Participants should refer to the Plan agreement for a more complete description of the plan amendments.

Effective July 1, 2018, the Plan was amended to make employer matching contributions discretionary. Effective January 1, 2014, the Plan was amended to change the eligibility age to 20 years old instead of 20.5 years old.
