Notes to Financial Statements

Note 1: Description of Plan

The following description of the Stellis Health, P.A. 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Stellis Health, P.A. (the "Employer") who have completed 30 days of service to be eligible for elective deferrals, with an entry date of the 1st of the month following the date that eligibility requirements are met. Employees who have completed one year of service and are age 21 or older are eligible for employer contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Board of Trustees is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Board of Trustees.

Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan, up to the annual maximum allowed by the Internal Revenue Service (IRS). The Plan also allows for Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catchup contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of the contributions into various investment options offered by the Plan.

Effective July 1, 2017, the Plan was amended to add automatic enrollment of 6% of eligible compensation for all employees who are eligible to participate in the Plan, unless they affirmatively elect to opt-out during the opt-out period. With the amendment, the Plan also elected an automatic escalation clause, which increases employee contributions by 1% each July 1, up to 10%, unless the employee changes their contribution rate.

The Employer makes a safe harbor contribution equal to 3% of all participant's compensation. During the year ended December 31, 2024, the Employer made safe harbor matching contributions of \$521,792. Additional discretionary profit sharing contributions may be contributed at the option of the Employer's Board of Directors. There were no discretionary employer profit sharing contributions during 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution, Employer safe harbor contributions, Employer discretionary profit sharing contributions, and allocations of the Plan's earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note 1: Description of Plan (Continued)

Vesting

Participants are immediately vested in their voluntary contributions and the Employer safe harbor contributions plus actual earnings thereon.

Vesting in a participant's allocation of the Employer's discretionary profit sharing contributions is based on years of service. A participant is 100% vested after six years of service, based on the following schedule:

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. The interest rate on existing loans ranges from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

The Plan provides for payment of the entire vested balance in the participant's account upon death, permanent disability, retirement, or termination of employment. The form of the participant's distribution depends on whether his or her vested account balance exceeds \$1,000. If the vested account balance does not exceed \$1,000, the Plan will distribute the vested account balance in a lump sum. If the account balance exceeds \$1,000, the participant may elect to receive his or her vested account balance in the form of a lump sum, a rollover to another plan, through installment payments, or a combination thereof. In addition, hardship distributions out of the participant's elective contributions account are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59½.

Effective January 1, 2019, the new IRS hardship distribution regulations were implemented to allow participants to have access to earnings on the deferral portion of their account, to include federal disasters as a hardship category, to eliminate the suspension period subsequent to receiving a hardship distribution, and to eliminate the requirement to exhaust plan loans.

Forfeitures

Plan forfeitures arise as a result of participants who terminate service with the Employer before becoming 100% vested in the Employer's discretionary profit sharing contributions. The accounts will be used to reduce future Employer contributions or pay administrative expenses of the Plan in accordance with the Plan document. There were no unused forfeitures as of December 31, 2024 and 2023. During the year-ended December 31, 2024, \$15,154 of were forfeitures used to reduce Employer contributions and \$832 to pay administrative expenses.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of the accompanying financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Employer absorbs various Plan expenses including some third-party administration fees and audit fees. Expenses that are paid by the Employer are excluded from these financial statements. Certain fees are paid by participants on a "per use" basis. These fees include loan administration fees, withdrawal and distribution processing fees, and other fees specifically related to an individual participant and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 3, 2025, which is the date the financial statements were available to be issued.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

Note 3: Fair Value Measurements (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Mutual funds held in pooled separate account: Fair value is estimated using the net asset value (NAV) per unit by the issuer of the pooled separate account. Fair value is based on the fair value of underlying investments held by the pooled separate account.

Collective investment trusts: Fair value is estimated using the NAV per unit by the issuer of the collective investment trusts. Fair value is based on the fair value of underlying investments held by the collective investment trusts.

Self-directed brokerage accounts: Accounts primarily consist of mutual funds and common stocks that are valued on the basis of readily determinable market prices.

Note 4: Information Prepared and Certified by the Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Delaware Charter Guarantee and Trust Company, d/b/a, Principal Trust Company, the Trustee of the Plan.

Note 5: Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Employer contributions.

Note 6: Tax Status

The Company adopted a nonstandard defined contribution pre-approved plan document with an IRS opinion letter which states the pre-approved plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 7: Related-Party Transactions and Party-in-Interest Transactions

The Plan invests in accounts managed by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, who serves as Trustee for investments in the Plan, and therefore, these transactions qualify as party-in-interest transactions. Principal Life Insurance Company is the record-keeper, as defined by the plan and also qualifies as a party-in-interest which is exempt from the prohibited transaction rules. Fees incurred and paid by the Plan for the investment management, administrative services, and recordkeeping services were \$55,010 for the year ended December 31, 2024. Certain Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
