Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Quick Quack Car Wash 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for Financial Statements

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Quick Quack Car Wash 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024

1. DESCRIPTION OF THE PLAN

The following description of the Quick Quack Car Wash 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General – The Plan was established by S&D Car Wash Management, LLC (the “Sponsor”) on July 1, 2016, and is a defined contribution plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Eligibility – Eligible employees of the Sponsor become eligible to make salary deferrals in the Plan on the first day of the first month, or the first day of the seventh month of the Plan year, coincident with or next following their date of hire or their attainment of age 18, whichever is later. Eligible employees become eligible to receive employer safe harbor match and discretionary match contributions in the Plan at the same time that they become eligible for salary deferrals.

Contributions – The Plan provides salary deferrals for eligible employees for amounts not to exceed the limit set by law. Prior to April 23, 2020, the Sponsor provided a 100% safe harbor matching contribution for each eligible participant's salary deferrals, limited to 4% of the participant's eligible compensation. The Sponsor could also provide a discretionary matching contribution to the Plan not to exceed 6% of the participant's compensation.

Effective April 23, 2020, the Plan was amended and the Plan was no longer a Safe Harbor Plan. Per the Plan amendment effective April 23, 2020, the Sponsor could provide discretionary matching contributions for each eligible participant's salary deferrals equal to a uniform percentage or dollar amount of the participant's deferral.

Effective January 1, 2022, the Plan was amended and restated as a Safe Harbor Plan. For the year ended December 31, 2024, the Sponsor had a 100% safe harbor matching contribution for each eligible participant's salary deferrals, limited to 4% of the participant's eligible compensation.

In addition, the Sponsor may make nonelective discretionary contributions to the Plan. No nonelective discretionary contributions were provided for the year ended December 31, 2024.

Vesting – Participants are immediately vested in their voluntary, employer safe harbor matching, and ridged discretionary matching contributions plus earnings thereon. Vesting in the discretionary additional matching and nonelective discretionary contributions are progressive, based upon length of service. A participant is 100% vested in the discretionary profit-sharing contributions after six years of credited service. Participants must complete 1000 hours of service during a vesting compensation period to receive credit for a year of service.

Forfeitures of discretionary additional matching contributions by participants may be used as additional employer contributions, to reduce subsequent employer contributions or pay Plan administrative expenses. Forfeitures totaled \$11,344 in 2024. In the year ended December 31, 2024, no forfeitures were used to reduce employer contributions or administrative expenses.

Payment of benefits – Distributions from the Plan are available to participants or their beneficiaries at retirement, upon termination of employment, or as a result of total and permanent disability, or death in a lump-sum distribution equal to the value of his or her account. Mandatory distributions greater than \$175 and not exceeding \$5,000 are rolled over to an individual retirement plan if the participant does not elect otherwise.

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024

Participant accounts – Individual accounts are maintained for each Plan participant to reflect the participant’s contributions and the employer’s contributions. Each participant’s account is credited with the participant’s contributions and an allocation of the plan earnings. Allocations are based on participant’s account balances, as defined by the Plan. Participants may direct the investment of their account balances into various investment options offered by the Plan.

Administrative expenses – Administrative expenses of the Plan include recordkeeping, trustee, and other professional service fees incurred in connection with the operation and administration of the Plan. These expenses are paid directly by the Plan unless otherwise paid by the Plan sponsor. During the year ended December 31, 2024, administrative expenses of approximately \$156,061 were incurred and charged to the Plan.

Party-in-interest transactions – Certain Plan investments are managed by John Hancock Trust Company, LLC (the Trustee of the Plan), the asset custodian and recordkeeper, and therefore, transactions with such investments qualify as parties-in-interest. Any purchases and sales of these funds are open market transactions at fair market value. Consequently, such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of parties-in-interest transactions under ERISA.

2. SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting – The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment valuation and income recognition – Investments are required to be reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income and gains are recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan’s gains and losses on investments purchased and sold as well as held during the year.

Excess contributions payable – Refunds of excess participant deferral contributions may be required to satisfy the relevant nondiscrimination provisions of the Plan. Such refunds are accrued as a liability with a corresponding reduction in contributions in the Plan year in which the excess deferrals were made to the Plan.

Contributions – Employee contributions and the related employer match are recorded in the period payroll deductions are made.

Payment of benefits – Benefits are recorded when paid.

Income taxes – The Plan, which is a Volume Submitter Plan, obtained its latest opinion letter on March 31, 2014, in which the Internal Revenue Service stated that the plan is in compliance with the applicable requirements of the Internal Revenue Code.

Use of estimates – The preparation of financial statements in conformity with accounting principles generally accepting in the United States of America requires Plan management to make estimates and assumptions that affect certain reportable amounts and disclosures. Actual results could differ from those estimates.

Subsequent events have been evaluated through October 2, 2025, the date the financial statements were available to be issued. The Sponsor concluded that no material events have occurred since December 31, 2024, that requires disclosure in the financial statements.

3. INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within a fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

4. CERTIFIED INVESTMENTS

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule held as of December 31, 2024 and 2023, and net appreciation in fair value of investments for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company (the Trustee of the Plan).

5. PLAN TERMINATION

Although it has not expressed the intent to do so, the Sponsor has the right under the plan agreement to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become fully vested in their accounts.

6. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.


