Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Notes to Financial Statements

1. DESCRIPTION OF PLAN

The following description of the Sequoyah Electric 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all nonunion full-time employees of Sequoyah Electric, LLC (the Company) who have one year of service and are age 18 or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Eligibility to make 401(k) deferrals requires 90 days of service. Employer matching participation requires one year of service. The Board of Trustees oversees governance of the Plan. The Plan's Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Board of Trustees.

Effective January 1, 2021, the Plan was restated to comply with Internal Revenue Service requirements. Effective January 1, 2024 the Plan was amended to remove two Trustees.

Contributions

Each year, participants may contribute any percentage of pre-tax annual compensation. Participants are allowed to make Roth 401(k) contributions on an after-tax basis of compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Unless they choose to opt-out, eligible employees will be automatically enrolled in the Plan at 4%, increasing at a rate of 1% percent annually, up to a maximum deferral of 10%. The Plan allows the Company to make discretionary matching contributions. For 2024, the Company matched 50% of salary deferrals up to 8% of the participant's contributions. Contributions are subject to certain IRS limitations.

Participant accounts

Each participant's account is credited with the participant's contribution and Company matching contributions, as well as allocations of Plan earnings and administrative expenses based on account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Sequoyah Electric 401(k) Plan

Notes to Financial Statements (Continued)

1. DESCRIPTION OF PLAN (continued)

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's discretionary matching portion of their accounts is based on years of service (defined as 1,000 hours per year) as determined by the following vesting schedule: beginning with two years of service, 20% per year until 100% vested after six years of service.

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at the prime rate in effect on the date the loan is made plus 1%. Interest rates ranged from 4.25% to 9.50% in 2024 and mature at various dates through 2038. Principal and interest is paid ratably through weekly payroll deductions.

Payment of benefits

On termination of service due to death, disability, retirement or for other reasons, a participant may receive either a lump-sum amount equal to the value of the participant's vested interest in the account, or annual installments. A participant may also withdraw all or a portion of an account balance at any time if the participant is at least 59 ½ years old. The Plan also allows for financial hardship withdrawals. The Plan provides that if a participant is terminated and his/her vested interest in the Plan does not exceed \$5,000, the account balance will automatically roll over to an Individual Retirement Account if not removed from the Plan within a specified amount of time.

Forfeited accounts

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$36,759 and \$15,583, respectively. Forfeitures of participant balances are used to reduce future employer contributions or to pay for Plan expenses. In 2024, employer contributions were reduced by \$13,744 from forfeited nonvested accounts.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

Sequoyah Electric 401(k) Plan

Notes to Financial Statements (Continued)

2. SUMMARY OF ACCOUNTING POLICIES (continued)

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value, except for the fully benefit-responsive group annuity contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Receivables

Employer contributions receivable and employee contributions receivable are recognized in the period the employee contribution is withheld, are stated net of the allowance for credit losses and represent the amount expected to be collected. The Plan makes estimates of expected credit losses for the allowance for credit losses based upon its historical write-off experience adjusted for current conditions and reasonable and supportable forecasts of future economic conditions. An allowance for credit losses was not deemed necessary as of December 31, 2024 and 2023.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when incurred. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

2. SUMMARY OF ACCOUNTING POLICIES (continued)

Payment of benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account.

Management's review of subsequent events

Subsequent events were evaluated through October 8, 2025, which is the date the financial statements were available to be issued.

3. CERTIFIED INVESTMENTS

Information related to investments, including the group annuity contract, and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including all investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation/depreciation in fair value of investments, changes in contract value of investments, interest and dividends, and interest income on notes receivable for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the custodians of the Plan.

4. GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY

The Plan has a fully benefit-responsive group annuity contract with Empower Annuity Insurance Company of America (Empower), which is known as the Key Guaranteed Portfolio Fund. Empower maintains the contributions in a general account, which is credited with earnings and charged for participant withdrawals and administrative expenses.

The group annuity contract is presented in the financial statements at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Notes to Financial Statements (Continued)

4. GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY (continued)

Certain events limit the ability of the Plan to transact at contract value with Empower. Such events include premature termination of the contracts by the Plan, plant closings, layoffs, plan termination, bankruptcy, mergers and early retirement incentives. The Plan does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

Empower is contractually obligated to pay the principal and specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with Empower. The group annuity contract amounted to \$613,684 and \$868,941 at December 31, 2024 and 2023, respectively.

5. FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. There are no Plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented and there were no changes in the methods used to measure fair value at December 31, 2024 and 2023.

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

6. RELATED PARTY AND PARTY IN-INTEREST TRANSACTIONS

Brighton Jones, LLC provides investment advisory services to the Plan. Certain Plan investments are managed by Empower Advisory Group LLC. Empower Annuity Insurance Company of America and Empower Trust Company, LLC are the custodians as defined by the Plan and also provide administrative, recordkeeping and other services for the Plan in accordance with the terms and conditions of the recordkeeping services agreement. Brighton Jones, LLC, Empower Advisory Group LLC, Empower Annuity Insurance Company of America, and Empower Trust Company, LLC all qualify as parties-in-interest.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their accounts.

Notes to Financial Statements (Continued)

8. TAX STATUS

The Company adopted a Non-Standardized Pre-Approved 401(k) Plan document which received an opinion letter from the Internal Revenue Service (IRS) on November 14, 2022. The letter states that the form of the Pre-Approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the Pre-Approved plan document, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The Plan files U.S. Form 5500 Annual Return/Report of Employee Benefit Plan.

9. RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.
