## INDEPENDENT AUDITOR'S REPORT

To the Pension Committee  
Delta Dental of California 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed audits of the accompanying financial statements of Delta Dental of California 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Delta Dental of California 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audits of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of Delta Dental of California 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audits does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Delta Dental of California 401(k) Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control related matters that we identified during the audits.

#### **Other Matter - Supplemental Schedule Required by ERISA**

The supplemental schedule of assets (held at end of year) as of December 31, 2024 ("supplemental schedule") is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. DESCRIPTION OF THE PLAN

The following description of the Delta Dental of California 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement and the summary plan description for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by Delta Dental of California (the "Company"). The Plan was established effective October 1, 1998, and most recently restated January 1, 2021. The Plan is intended to qualify under Sections 401(a) and 501(a) of the Internal Revenue Code of 1986 as amended. The Plan is designed to constitute a qualified profit-sharing plan and 401(k) qualified cash or deferred arrangement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and subsequent laws.

Plan administration

The Company is the administrator of the Plan and, as such, carries out the duties imposed by ERISA. The Company has delegated certain responsibilities for the operation and administration of the Plan. Trustee services are provided by Charles Schwab Trust Bank ("Charles Schwab" or "Trustee"), and recordkeeping services are provided by Schwab Retirement Plan Services, Inc.

Certain administrative expenses of the Plan were paid directly by the Company for the years ended December 31, 2024 and 2023. Investment fees, which may vary according to the individual funds selected, and certain other administrative expenses are paid out of the assets of the Plan. Prospectus of the individual investment funds, which includes details on individual investment fees, are available to all participants.

Effective March 27, 2020, the Plan administratively adopted the provisions of the Coronavirus Aid, Relief, and Economic Security (CARES) Act, related to participant loans and distributions. The Company has until December 31, 2026, to amend the Plan for changes allowed by the CARES Act. The Plan has not been formally amended to adopt these provisions as of the date these financial statements were available to be issued.

An expansion of Setting Every Community Up for Retirement Enhancement Act of 2019 ("SECURE 2.0") was signed into law on December 29, 2022, as part of the Consolidated Appropriations Act of 2023. The effective dates of provisions within SECURE 2.0 vary through 2026. The Company has until the end of the first Plan year beginning on or after January 1, 2026, to amend the Plan for the changes related to SECURE 2.0. Effective February 14, 2025, the Plan was formally amended to adopt these provisions.

The Plan was also amended effective July 1, 2023, to allow participant to request a Qualified Birth or Adoption Distribution ("QBAD") for the birth or adoption of a child. The aggregate amount of the QBAD a participant may take from all plans maintained by the Employer may not exceed \$5,000.

Eligibility

Employees of the Company and Delta Dental Insurance Company classified as management and non-management are eligible to participate in the plan on the first of the calendar month that coincides with or next follows their date of hire. Excluded employees described as certain nonresident aliens who have earned no income from sources within the United States and leased employees are not eligible to participate. Employees classified as temporary employees become plan participants on the first of the calendar month that coincides with or next follows the day they complete one year of service as a temporary employee on a regular work schedule. The plan was amended effective July 15, 2023, to remove temporary employees from excluded employees.

Compensation

For purposes of determining contributions to the Plan, the term "eligible compensation" refers to all compensation that is subject to income tax withholding under Code §3401 Compensation, excluding the following: any compensation under Code §414(s) Safe Harbor Exclusions, compensation received prior to Plan participation, fringe benefit payments, differential wage payments, sign on bonuses, actuarial exam bonuses, other special bonuses, taxable income for group term life insurance, short term disability, long term disability, long term incentive program payments, non-qualified deferred compensation, domestic partner medical premiums, and non-performance based stipends.

Participant contributions

Newly hired or rehired employees are automatically enrolled in the Plan with an automatic pre-tax contribution percentage of 6% of eligible compensation, unless the employee selects a different percentage of eligible compensation or none at all. As of January 1, 2019, participant's contribution percentage for the Plan automatically increases by 1% each year, until the percentage reaches 12% of compensation. A management employee may select a different percentage of eligible compensation or none at all. Each increase will be effective March 1st of each year.

The Plan allows for two types of 401(k) contributions – pre-tax and Roth 401(k) contributions. Participants may make either or both types of 401(k) contributions during a year, provided the total amount of the combined contributions does not exceed any plan-imposed limitation or Internal Revenue Service ("IRS") maximum deferral limit for that year.

Participants may elect to contribute through payroll deductions amounts up to 50% of their annual eligible compensation, as defined in the Plan, up to a maximum amount allowed by the Internal Revenue Code ("IRC"). The maximum allowed deferral amount was \$23,000 and \$22,500 for 2024 and 2023, respectively. Participants over the age of 50 may also contribute an additional \$7,500 to the Plan for 2024 and 2023.

Participant contributions (continued)

Participants may also make rollover contributions of amounts representing distributions from other qualified retirement plans. All contributions are paid to the Trustee for investment in the appropriate investment fund or portfolio in accordance with the participant's directives and the terms of the Plan.

Employer contributions

The Company contributes a matching contribution, which is equal to 50% of a participant's annual pre-tax and Roth contributions to the Plan, up to 6% of eligible compensation, as defined in Plan documents. Employer contributions are allocated each payroll period. If necessary, eligible participants receive an additional matching contribution at the end of the year to "true up" the employer matching contribution. "True up" matching contributions are allocated to participant's accounts only if their pre-tax contributions were made at a rate that prevented them from obtaining the maximum employer matching contribution for the year.

In addition to the employer matching contributions, management and non-management employees receive an employer paid retirement non-elective contribution of 7.5% and 6% of eligible compensation, respectively.

The Company may also make an employer discretionary contribution on behalf of eligible participants. Contributions would be subject to certain limitations. There were no discretionary contributions due to the Plan for the years ended December 31, 2024 or 2023.

Participant accounts

Each participant's account is credited with the participant's contributions and earnings thereon and allocations of employer contributions and related earnings, and charged with an allocation of administrative expenses. Allocations of investment earnings are based strictly on the participant's selection of investments and timing of purchase. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the employer matching, retirement and discretionary contributions, plus earnings thereon, begin at 33% upon completion of one year of credit service, as defined by the Plan, increasing 33% per year until fully vested at the end of the third year. In the event of death, disability or attainment of normal retirement age of 65, participants are immediately 100% vested in all Company contributions.

Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$692,086 and \$811,368, respectively. These accounts can be used to reduce employer contributions and/or Plan administrative fees in accordance with provisions of the Plan. Forfeitures amounting to \$1,353,313 and \$664,432 were used to reduce employer contributions and administrative fees charged to the Plan for the years ended December 31, 2024 and 2023, respectively.

Payment of benefits

Distributions and withdrawals are payable upon retirement, termination, financial hardship, disability, or death. Effective January 1, 2024, the plan was amended to increase the mandatory cashout threshold to \$7,000. Upon termination, if a participant's vested account balance is equal to or less than \$1,000, the balance is immediately distributed as a lump-sum payment. Upon termination, if a participant's vested account balance is greater than \$1,000 and less than or equal to \$7,000, their balance shall be automatically rolled over into an individual retirement account designated by the Plan administrator, unless otherwise elected. Upon termination, if a participant's vested account balance exceeds \$7,000, the participant (or beneficiary) may elect to receive a distribution of their account balance as a lump-sum payment or postpone payment to a later date and remain in the Plan. For distribution reasons other than death, participants can consent to distributions paid in the form of partial payments.

The Plan allows for in-service and financial hardship distributions from the participant's accounts.

Notes receivable from participants

Participants may borrow from their participant retirement contribution account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the value of their vested account balance. All loans must be repaid over a period of time not to exceed 5 years. However, in the event loans are used to purchase a participant's principal residence, repayments may be made over a period of time not to exceed 30 years. The loans are secured by the remaining vested balance in the participant's account and bear interest rates which are commensurate with prevailing rates at the time of the loans. Principal and interest are paid ratably through monthly payroll deductions. For the year ended December 31, 2024, the rates of interest on outstanding notes ranged from 5.25% to 10.50% and have various maturity dates through November 2054.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Payment of benefits

Benefits are recorded as expenses by the Plan when they have been paid.

Investment valuation and income recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis when earned. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Estimates and assumptions

The preparation of financial statements in conformity with U.S. GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Risks and uncertainties

The Plan utilizes various investment instruments, including mutual funds. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Administrative fees

Certain administrative fees are being absorbed by the Company and the remainder are paid out of the assets of the Plan.

Subsequent events

The Plan administrator has evaluated subsequent events through September 26, 2025, the date the financial statements were available to be issued. Other than the subsequent amendment disclosed in Note 1, during the period from January 1, 2025 through September 26, 2025, the Plan has concluded there were no other events or transactions during this period that required disclosure in its financial statements.

3. INFORMATION PREPARED AND CERTIFIED BY TRUSTEE (UNAUDITED)

The plan administrator, having determined it is possible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(c) pursuant to 29 CFR 2520.103-8 of ERISA. Accordingly, the Trustee, determined to be a qualified institution by the plan administrator, has certified to the completeness and accuracy of:

- Investments and notes receivable from participants as shown in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivables from participants as shown in the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investments and notes receivables from participants reflected in the schedule of assets (held at year end) as of December 31, 2024 ("supplemental schedule").

Accordingly, as requested by the plan administrator, the Plan's independent auditor performed no procedures on the certified information other than to agree the certified information to the related information included in the financial statements and supplemental schedule.

4. FAIR VALUE MEASUREMENTS

The Plan defines fair value as the price that would be received from selling an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Accounting guidance establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to measurements involving significant unobservable inputs (Level 3 measurements).

The three levels of fair value hierarchy are as follows:

- Level 1: inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date.

- Level 2: inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the asset or liabilities; or
- Level 3: inputs are unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The asset or liability's fair value measurement level and classification within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/Collective Trusts ("CCTs"):* Valued at the daily closing price as reported by the fund issuer, based on the market value of its underlying investments minus the fund's liabilities. Participant transactions (purchases and sales) may occur daily. Were the plan to initiate a full redemption of the common collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the common collective trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

*Stable value collective trust:* A stable value collective trust consists of funds that are comprised primarily of fully benefit-responsive investment contracts that are valued at the NAV of units of the bank collective trust. The NAV, as provided by the fund issuer, is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that security liquidations will be carried out in an orderly business manner.

5. INCOME TAX STATUS

The IRS has determined and informed the Company by a letter dated September 21, 2020, that the Plan and related trust were designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving the determination letter, however, the Plan administrator and Plan counsel believe that the Plan remains designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon an examination by the IRS. No uncertain positions have been identified that would require the recognition of a tax liability (or asset) or disclosure in the financial statements as of December 31, 2024 and 2023. The Plan is subject to routine audits by applicable taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

ERISA defines parties-in-interest similarly to a related party under financial accounting standards, except that ERISA's definition is broader and includes all entities and individuals that provide services to the Plan; however, these entities may not necessarily be related parties. Management did not identify any related parties to the Plan that were not also considered to be parties-in-interest.

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, and an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association or relatives of such persons.

Certain fund level fees incurred by the funds in which the Plan invests for such services as investment management, shareholder services, and sub-transfer agency fees are paid through fund level revenue sharing arrangements. These fees reduce fund earnings thereby impacting Plan revenue applied to participants' accounts.

Certain Plan investments are managed by Charles Schwab, who is the Trustee as defined by the Plan. As the Plan Trustee, these investments qualify as exempt party-in-interest transactions specifically exempt from the prohibited transaction rules of ERISA.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, the full value of each participant's account shall become fully vested and nonforfeitable.
