Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

Other Matter – Supplementary Information Required by ERISA

The supplementary information as of and for the year ended December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplementary information, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplementary information that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplementary information, we evaluated whether the supplementary information, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Plan Description

The following description of the Gavilon 401(k) Plan for Salaried and Hourly Employees (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established to provide retirement benefits for non-union employees of the Plan Sponsor, Viterra USA Holdings, LLC, which was previously named The Gavilon Group prior to February 27, 2023.

In April 2024, certain participants and plan assets of approximately \$840,118 were transferred into the Plan from the Viterra 401(k) Plan and Trust.

In February 2023, certain participants and plan assets of \$33,007,199 were transferred to the MacroSource LLC 401(k) Plan for Non-Union Employees as a result of a spin-off from the Company.

Full-time employees are eligible to make pre-tax, Roth after-tax, and additional after-tax salary deferral contributions and receive employer matching contributions at the time of employment. Part-time and seasonal employees are eligible after completing one year of service. Employees are eligible to receive profit sharing contributions if they are employed on the last day of the Plan year. Eligible employees become participants on the first day of the pay period following the date on which entry requirements were met.

Contributions

Participants

Participants may contribute a portion of their annual compensation in connection with the 401(k) provisions of the Plan, up to the maximum allowable by law. All participants who meet the eligibility requirements are automatically enrolled with an initial 6% pre-tax salary deferral contribution. At any time, a participant can elect not to contribute or may increase or decrease his or her deferral rate as allowed under Plan provisions. Participants who are age 50 or older may make additional catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans.

Employer

Employer matching contributions are made each payroll period in an amount equal to a percentage of the participant's elective deferral, not to exceed 6% of compensation for the payroll period. The percentage of the participant's elective deferral that will be made as a matching contribution is determined based on age/service points, which is earned for each full year of the participant's age and each full year of service. For participants with less than 60 age/service points as of the last day of the immediate preceding accounting year, the matching percentage is 100% and for participants with 60 or more age/service points as of the last day of the immediate preceding accounting year, the matching percentage is 125%. Profit sharing contributions are calculated based on specific thresholds of pre-tax profit of the Company. Effective January 1, 2024, profit sharing contributions are allocated to participants by taking 2.5% of eligible compensation. Prior to January 1, 2024, profit sharing contributions were allocated to participants in amounts ranging from 0% to 5.5%. Contributions are subject to certain limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of a) the Company's matching contributions, b) the Company's profit sharing contributions and c) Plan earnings or losses. The Company's matching contributions are allocated among participants based upon each participant's elected salary deferral. The Company's profit sharing contributions are allocated among participants based upon eligible compensation of the participants. Plan earnings or losses are allocated on the basis of actual results of the investments selected by each participant. Investments are maintained in individual member accounts managed by Fidelity Management Trust Company (Fidelity).

Vesting

Participants are vested immediately in their contributions plus earnings thereon. Vesting in the Company's contributions credited to participants' accounts are based on years of continuous service. Participants are 20% vested after one year of credited service and vesting increases 20% per year until a participant is 100% vested after five years of credited service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates. The term of the note is limited to five years (ten years if used to purchase a principal residence) and all principal and interest payments must be made through payroll deductions.

Payment of Benefits

Upon termination, retirement, disability, or death, the participant or beneficiary may elect to receive a lump sum equal to the value of the vested funds allocated to the participant's account. The Plan requires that distributions under \$5,000 be directly rolled over to an individual retirement account designated by the plan administrator in the event the participant does not elect a payout option. Benefits are recorded when paid.

Forfeitures

Upon a participant's termination of employment before normal retirement, disability, or death, the portion of their matching and profit sharing contributions not then vested shall be forfeited. The forfeited portion of any participant's account may be used to restore re-employed participants' account balances, reduce expenses, or to reduce future Company contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$89,288 and \$63,028, respectively. During 2024 and 2023, \$727,440 and \$770,657, respectively, of forfeited amounts were used to reduce Company contributions and pay administrative expenses.

2. Summary of Significant Accounting Policies

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements is set forth below.

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis and in conformity with accounting principles generally accepted in the United States of America.

Presentation of Participant-Directed Funds

The Plan's presentation of participant-directed investments is in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962, *Plan Accounting – Defined Contribution Pension Plans*.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investment assets are held in a master trust (see Note 3). Investments are reported at fair value. Fair value is the price that would be received to sell an investment in an orderly transaction between market participants at the measurement date. See Note 5 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes are reclassified as distributions based upon the terms of the Plan document.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Other fees specifically incurred by or attributable to individual participants are paid from the applicable participant's account (unless their balance is less than \$3,000) and included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments in master trust.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date, but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. Management has considered such events or transactions through October 7, 2025, noting no items requiring disclosure.

3. Interest in Master Trust

The Plan's investment assets are held in a trust account at Fidelity and consist of an interest in an investment account of the Gavilon 401(k) Master Trust (the Master Trust), which is a master trust established by the Company and administered by Fidelity. Use of the Master Trust permits the commingling of trust assets of the Gavilon 401(k) Plan for Salaried and Hourly Employees and the Gavilon 401(k) Plan for Union Employees (collectively the Plans) for investment and administrative purposes. Although assets of the Plans are commingled in the Master Trust, Fidelity maintains supporting records for the purpose of allocating the net gain or loss of the investment account to the participating Plans.

While the Plan participates in the Master Trust, each participant's account is allocated earnings and losses consistent with the performance of the funds in which the participant has elected to invest in. Therefore, the Master Trust's investments and net investment income may not be allocated evenly among the Plans participating in the Master Trust.

5. Fair Value Measurements

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Stable Value Fund: The estimated value of the stable value fund is at NAV, exclusive of the adjustment to contract value. FASB ASC 820, *Fair Value Measurement*, allows NAV per unit to serve as a practical expedient to estimate the fair value as long as certain requirements are met. It is the Plan's assessment that this fund meets those requirements. The participants can redeem the fund at NAV as of the measurement date on a daily basis and there are no unfunded commitments as of December 31, 2024 and 2023.

Common Collective Trust: Valued at the NAV based on the market value of its underlying investments, FASB ASC 820, *Fair Value Measurement*, allows NAV per unit to serve as a practical expedient to estimate the fair value as long as certain requirements are met. It is the Plan's assessment that this fund meets those requirements. The participants can redeem the fund at NAV as of the measurement date on a daily basis and there are no unfunded commitments as of December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested. Distribution to participants of the account balances would be made as soon as practicable after the termination date.

7. Tax Status

The Internal Revenue Service (IRS) has determined and has informed the Company by a letter to the Plan dated January 29, 2015, that the respective Plan was designed in accordance with the applicable regulations of the Code.

The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRS. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

8. Related Party Transactions

Certain Plan investments are assets managed by Fidelity. Fidelity is the trustee and custodian as defined by the Plan, and therefore these transactions qualify as party-in-interest transactions.
