### NOTE A DESCRIPTION OF THE PLAN

#### General

The following description of the Matric Limited, Inc. Profit Sharing 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan sponsored by Matric Limited, Inc. (Company) for the benefit of its employees who have at least three months of service and are age 21 or older. Participants must have 12 months of service to receive Company matching and profit-sharing contributions. Profit-sharing contributions are allocated to eligible employees who either were employed on the last day of the Plan year or had completed more than 500 hours of service during the Plan year. Related employers who also participate in the Plan include Dynamic Manufacturing, LLC. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Individuals employed by the Company are the trustees of the Plan. Voya Retirement Insurance and Annuity Company is the custodian of the Plan.

#### Contributions

The Plan permits eligible employees through a salary deferral election to have the Company make annual contributions of up to 100 percent of their eligible compensation. Employee rollover contributions are also permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Company matching and profit-sharing contributions are discretionary as determined by the Company's Board of Directors. Contributions are subject to certain limitations.

#### Participant Investment Account Options

Each participant has the option of directing their contributions into any of the various investment options offered by the Plan and may change the allocation daily.

The Plan Document also includes an automatic deferral feature whereby a participant is treated as electing to defer a certain percentage of eligible compensation unless the participant made an affirmative election otherwise. The automatic deferral feature also provides for an annual increase in the percentage deferred and is ultimately capped at 10 percent.

#### Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contributions and Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their voluntary and Company contributions plus earnings thereon.

#### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set at one percent above the prime rate, as defined. Principal and interest is paid ratably through bi-weekly payroll deductions.

### Payment of Benefits

On termination of service due to death, disability, retirement or other reasons, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested amount in his or her account, installment payments, or in-kind distributions.

### Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1,007 and \$1,018, respectively. These accounts will be used to reduce future employer contributions or pay administrative expenses. Also, in 2024 and 2023, administrative expenses of \$26 and \$4 were paid from forfeited nonvested accounts, respectively.

### Other Unallocated Assets

In accordance with the service agreement with the Company, a portion of the Voya Fixed Account represents a Plan level expense account that is primarily funded by expense reimbursements provided by Voya Retirement Insurance and Annuity Company. The balance of this account was \$0 at December 31, 2024 and 2023. The Company can use these funds to pay for administrative expenses. During the years ended December 31, 2024 and 2023, the Plan used \$18,546 and \$11,197, respectively, to pay for administrative expenses of the Plan. This account is regarded as an asset of the Plan for financial statement and Form 5500 reporting.

## **NOTE B SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of net assets available for benefits attributable to fully benefit-responsive investment contracts, because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results may differ from those estimates.

### Investment Valuation and Income Recognition

Investments are reported at fair value except for fully benefit-responsive investment contracts, which are reported at contract value. Quoted market prices, if available, are used to value investments. The Plan's interest in the pooled separate accounts is valued at the NAV of units held by the Plan in these investments. The NAV for the pooled separate accounts is used as a practical expedient to estimate fair value of these investments.

Fully benefit-responsive investment contracts are valued at contract value. Contract value represents contributions made under the contract, plus interest at the contract rate, less participant withdrawals and administration expenses.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Contributions

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

### Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

### Payment of Benefits

Benefit payments to the participants are recorded upon distribution.

### Administrative Expenses

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

### Revisions

An immaterial revision was made to the 2023 financial statements to revise the balance of the unallocated forfeiture account as of December 31, 2023. This revision did not have any impact on the financial statement line items, but was updated within the forfeited accounts disclosure in Note A.

## **NOTE C CERTIFICATION OF PLAN TRUSTEE AND CUSTODIAN**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Voya Retirement Insurance and Annuity Company, the custodian of the Plan, has certified the following information included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

## **NOTE D RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association or relatives of such persons.

Certain Plan investments are units of pooled separate accounts and a group annuity contract managed by Voya Retirement Insurance and Annuity Company. Voya Retirement Insurance and Annuity Company is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred

by the Plan for the investment management services are included in net appreciation (depreciation) in the fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. The Company directly pays certain other fees related to the Plan's operations.

The Plan paid \$119,391 and \$81,664 of recordkeeping fees to Voya Retirement Insurance and Annuity Company during the years ended December 31, 2024 and 2023, respectively. Individually nonmaterial expenses paid to other parties in interest aggregated \$18,546 and \$11,197 during the years ended December 31, 2024 and 2023, respectively. The Company provides certain administrative services at no cost to the Plan.

### NOTE E PLAN AMENDMENTS

Effective July 1, 2024, the Plan adopted a provision of the SECURE 2.0 Act to increase the mandatory cash out limit for terminated participants from \$5,000 to \$7,000. This provision has been operationally implemented, and a formal written amendment to the Plan to reflect this change will be adopted at a later date in accordance with the applicable regulatory guidance.

### NOTE F DISCLOSURES ABOUT FAIR VALUES OF PLAN ASSETS AND LIABILITIES

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities

Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

### **NOTE G INVESTMENT CONTRACT WITH INSURANCE COMPANY**

In 2020, the Plan entered into a fully benefit-responsive traditional investment contract with Voya Retirement Insurance and Annuity Company. Voya Retirement Insurance and Annuity Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan.

The guaranteed investment contract is fully benefit responsive; therefore, contract value is the relevant measurement. Contract value, as reported to the Plan by Voya Retirement Insurance and Annuity Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan Documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Company or other Company events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Withdrawals from the Voya investment contract for reasons other than the payment of benefits to participants may be subject to a Market Value Adjustment and a surrender charge, and transfers to other investment opinions are limited by a percentage that may vary at Voya's discretion. The Plan Administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

### **NOTE H PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would remain 100 percent vested in their employer contributions.

### **NOTE I TAX STATUS**

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.
