We have performed audits of the financial statements of Defined Contribution Pension Plan for Employees of ATTIC Correctional Services, Inc. an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). NOTE 1—DESCRIPTION OF PLAN

The following description of Employee Benefits Plan of ATTIC Correctional Services, Inc. (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General. The Plan is a defined contribution plan covering all eligible employees of ATTIC Correctional Services, Inc. (the Company) who have one year of service and are age twenty-one or older. The Plan is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Board of Trustees.

Effective January 1, 2024, the Plan implemented a SECURE Act and SECURE 2.0 Act provision updating the dollar limit for mandatory distributions (\$5,000 to \$7,000).

Contributions. Each year, the Company contributes an amount equal to the sum of (a) 4% of the participant's compensation for the Plan year, and (b) 3½% of the excess, if any, of such compensation over \$45,000 for each Plan year. Participants direct the investment of contributions made on their behalf into various investment options offered by the Plan under an investment contract with an insurance company. No employee contributions are required or permitted. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts. Each participant's account is credited with allocations of (a) the Company's contribution, (b) Plan earnings, and (c) forfeitures of terminated participants' nonvested accounts, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting. Participants are vested in the Company's contributions plus actual earnings thereon based on years of continuous service. A participant is 100% vested after five years of credited service.

Payment of Benefits. Amounts contributed may be withdrawn by, or distributed to, a participant only upon (a) termination of employment or (b) attaining the age of 55. Withdrawals prior to attaining age 55 are not permitted except in the event of death or disability. Certain income tax penalties may apply to withdrawals or distributions prior to age 59½.

Forfeited Accounts. At December 31, 2024 **and 2023**, forfeited nonvested accounts totaled \$61,305 and \$51,996, respectively. These accounts will be reallocated to participants. In 2024, \$48,783 of forfeitures were reallocated to participants.

NOTE 2—SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value except for the investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Monthly administrative charges are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Date of Management's Review

Management has evaluated subsequent events through October 1, 2025, the date which the financial statements were available to be issued.

NOTE 3—FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority.

Level 1 Fair Value Measurements

Pooled Separate Accounts: Valued at net asset value (NAV) as determined by the insurance company which is readily determinable.

NOTE 4—INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan entered into an investment contract with Mutual of America Life Insurance Company (Mutual of America). Mutual of America maintains the contributions in a general account and pooled separate accounts. Amounts placed in the Interest Accumulation Account of Mutual of America's general account are credited with interest at a rate determined by Mutual of America. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Because the general account is carried at amortized cost, or contract value, contract value is the relevant measure attributable to the investment contract. Contract value, as reported to the Plan by Mutual of America, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value, which is also the contract's fair value prior to contract termination.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

The amount the Plan invested in the investment contract was \$352,417 and \$355,016 at December 31, 2024 **and 2023**, respectively. The interest rate is determined by Mutual of America who reserves the right to change the interest rate at their discretion.

NOTE 5—PARTY-IN-INTEREST TRANSACTIONS

Plan investments are managed by Mutual of America. Mutual of America is the contract holder as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

NOTE 6—TAX STATUS

The Company has adopted pre-approved plan document that has received an opinion letter from the IRS dated November 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

NOTE 7—PARTICIPANT LOANS

Plan participants may borrow from Mutual of America a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance subject to annuity contract and Plan provisions. These loans are issued directly from funds owned by Mutual of America and not directly from a participant's account and therefore are not recorded as an asset on the statement of net assets available for benefits. The loans are secured by the participant's Mutual of America General Account balances in an amount equal to 120% of the outstanding loan balances. Loans bear interest rates that may be fixed or variable depending upon the Plan and annuity contract provisions. Principal and interest is paid ratably by the participant to Mutual of America. Interest is paid directly to Mutual of America while the principal repayments increase the amount of Mutual of America General Account funds available for the participants' use.

The amount of such outstanding loans was \$36,012 and \$26,850 as of December 31, 2024 **and 2023**, respectively

NOTE 8—PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their account.

NOTE 9—CERTIFIED INVESTMENTS

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 **and 2023**, and net appreciation in fair value of investments for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Mutual of America (the contract holder of the Plan).

NOTE 10—RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 11—SUBSEQUENT EVENT

Effective July 1, 2025, the Plan switched service providers from Mutual of America to Empower and at that time entry date changed from first of the month upon meeting eligibility requirements to first of the quarter after meeting eligibility requirements.
