### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Allen Distribution 401(k) and Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.



#### Note 1. Description of the Plan

The following description of Allen Distribution 401(k) and Profit Sharing Plan (the Plan), provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution profit sharing plan with a 401(k) salary deferral provision that is available to all eligible employees of Allen Distribution LP (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan document was most recently amended effective January 1, 2025.

Eligibility: Employees are eligible to participate in the Plan after completion of 60 days of service and may enter the Plan on the first of the month following completion of the eligibility requirements. Participants are eligible to receive discretionary employer matching contributions and profit-sharing contributions after completion of 60 days of service. Effective March 1, 2023, the plan changed the eligibility to completion of 30 days of service.

Contributions: Each year, participants may contribute any percentage of pre-tax compensation, subject to annual dollar limitations imposed by the Internal Revenue Code. Participants who attain age 50 by the end of the Plan year are eligible to make additional (catch-up) contributions. Beginning on January 1, 2021, participants are also permitted to make Roth (after-tax) contributions through elective salary deferrals. Participants may also contribute amounts representing distributions from other qualified plans (rollovers).

For eligible employees that enter the Plan on or after January 1, 2021, the Plan has an automatic contribution arrangement. The Company will automatically withhold 1% of pre-tax compensation for each Plan participant entering the Plan, unless the employee opts out of the Plan or opts to contribute a different deferral amount. Effective March 1, 2023, the Plan changed the automatic withholding to 5% pre-tax compensation for each Plan participant entering the Plan, unless the employee opts out of the Plan or opts to contribute a different deferral amount.

The Company may make discretionary employer matching contributions (as a percentage of participants' bi-weekly gross compensation), as determined at the beginning of each Plan year. The Company matching contribution is capped at 2.5% of plan compensation. The Company may also make an annual discretionary profit-sharing contribution. The profit-sharing contribution is allocated to participants based on compensation using new comparability. New comparability is a cross-tested or classed based, type of allocation formula with contribution allocations of each group as determined by the Plan Sponsor. Contributions are subject to certain limitations.

Participant Investment Options: Participants direct the investment of contributions into various investment options offered by the Plan. Participants may change their investment allocations at any time.

#### Note 1. Description of the Plan (Continued)

Participant Accounts: Each participant's account is credited with the participant's contributions, an allocation of employer profit sharing contributions and allocations of plan earnings, net of administrative expenses. Allocations are based on participant earnings or account balances as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's profit-sharing contributions are based on years of service. After two years of service, a participant is vested at 20%. Vesting increases 20% per year thereafter until fully vested after six years of service. Participant accounts become fully vested upon retirement at age 65, permanent disability or death. Effective March 1, 2023, the vesting schedule has changed to 0% vested until 3 years of service has been completed at which point the participants become fully vested. Any participant who has been credited with two years of service as of December 31, 2022, shall continue to be 20% vested until they are credited with one additional year of service at which time they will become fully vested under the new vesting schedule.

Payment of Benefits: Upon termination of service due to death, disability, or normal retirement at age 65, a participant or their beneficiary may elect to receive vested benefits in a lump sum. Participant accounts with balances less than \$5,000 are distributed in a lump sum; whereas, vested account balances between \$1,000 and \$5,000 are automatically rolled over into an IRA selected by the Plan administrator if the participant does not consent to the form of distribution. In-service distributions are available to participants after reaching the age of 59 ½, if the participant is fully vested in the source from which the withdrawal is taken. Hardship withdrawals are also permitted subject to limitations as to amounts and types of contributions that may be withdrawn.

Forfeited Accounts: Forfeitures represent unallocated employer contributions resulting from the termination of participants with less than fully vested benefits under the Plan. Forfeitures may be used to pay administrative expenses, allocated as additional employer contributions or used to reduce employer contributions. Forfeited non-vested accounts at December 31, 2024 and 2023, amounted to \$427,113 and \$111,698, respectively. No forfeitures were used in 2024.

Administrative Expenses: All significant costs to administer the Plan are paid by the Plan if not paid by the Company. Any expenses paid by the Company are not reflected in the accompanying financial statements.

#### **Note 2. Summary of Significant Accounting Policies**

Accounting Method: The financial statements have been prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value (except for a fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management determines the Plan's valuation policies utilizing information provided by the investment advisors, custodian, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits: Benefits are recorded when paid.

Subsequent Events: In preparing these financial statements, the Plan Sponsor has evaluated events and transactions for potential recognition or disclosure through October 2, 2025 the date the financial statements were available to be issued. See Note 11.

#### **Note 3. Information Certified by the Trustee**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplementary schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, for the year ended December 31, 2024, was obtained by management and agreed to information certified as complete and accurate by Empower Trust Company LLC (the Trustee of the Plan).

The insurance company fixed account and related investment income as of December 31, 2024, and the year ended December 31, 2024 and 2023, was certified as complete and accurate by Empower Annuity Insurance Company of America.

#### Note 4. Investments and Fair Value Measurements

The Plan measures on a recurring basis its investments at fair value in accordance with Financial Accounting Standards Board (FASB) codification *Fair Value Measurement*, which provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The three levels of the fair value hierarchy are as follows:

- Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that are accessible to the Plan. These generally provide the most reliable evidence and are used to measure fair value whenever available.
  
- Level 2      Inputs to the valuation methodology include significant inputs, other than Level 1 inputs, which are observable either directly or indirectly for substantially the full term of the asset through corroboration with observable market data. Level 2 inputs include quoted prices for similar assets in active markets, quoted market prices in markets that are not active for identical or similar assets, and other observable inputs.
  
- Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The inputs or methodology used for valuing investments are not an indication of the risk associated with investing in those securities.

The following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered Investment Companies: Shares of registered investment companies (mutual funds and money market funds) are valued at the daily closing price as reported by the funds. The funds held by the Plan are open-end mutual funds registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain investments or financial instruments could result in a different fair value measurement at the reporting date.

#### Note 5. Investment Contract with Insurance Company

The Plan is invested in a fully benefit-responsive group annuity contract with Empower Annuity Insurance Company of America within which participants may direct a portion of their contributions into the Empower Investments Fixed Account (EIFA). The fixed account guarantees principal and credited interest for eligible participant-initiated withdrawals and transfers. The fund that obligates Empower Annuity Insurance Company of America to repay the principal and a specified interest rate to the Plan.

The guaranteed interest fund meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses.

The interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The crediting interest rate may change or stay the same quarterly. The quarterly crediting rate applies to all money deposited in the group contract holder's fixed account regardless of when it was deposited.

The Plan's ability to receive amounts due in accordance with fully benefit responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. There are no reserves against the contract value for credit risk of the contract issuer or otherwise.

#### **Note 5. Investment Contract with Insurance Company (Continued)**

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer, such as partial or complete termination of the contract, plan termination or merger, changes to the Plan's prohibition on competing investment options, bankruptcy of the plan sponsor or other plan sponsor events. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

#### **Note 6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

#### **Note 7. Tax Status**

The Plan has adopted a Non-Standardized Pre-Approved Plan with Cash or Deferred Arrangement sponsored by PA Retirement Solutions, Inc. The Non-Standardized Pre-Approved plan with Cash or Deferred Arrangement has received an opinion letter from the Internal Revenue Service dated June 30, 2020, that the Non-Standardized Pre-Approved plan with Cash or Deferred Arrangement as then designed, was in compliance with the applicable provisions of the Internal Revenue Code (IRC). Although the Plan has been amended subsequently, the Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

#### **Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in in risks will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits.

#### **Note 9. Related Party and Party-in-Interest Transactions**

Certain Plan investments consists of units of a guaranteed income fund managed by Empower Trust Company, LLC. Empower Trust Company, LLC is the current Trustee of the Plan and, therefore, these transactions qualify as party-in-interest transactions. In addition, the plan paid certain expenses related to plan operations and investment activity to various service providers. The transactions qualify as exempt party-in-interest transactions.

#### **Note 10. Prohibited Transactions**

During 2024, the Plan Sponsor inadvertently failed to timely remit to the Plan's custodian certain employee contributions totaling \$193,236. Lost earnings on 2024 late deposits will be remitted to the plan in 2025.

During 2023, the Plan Sponsor inadvertently failed to timely remit to the Plan's custodian certain employee contributions totaling \$454,560. Lost earnings on 2023 late deposits were remitted to the plan in 2024.

#### **Note 11. Subsequent Events**

Effective January 1, 2025, the Plan amended the distribution policy to automatically revoke beneficiary designations for spouses immediately upon the legal divorce of the Participant and spouse.
