INDEPENDENT AUDITOR'S REPORT

To the Employee Benefit Plans Committee of The Boeing Company

Opinion

We have audited the financial statements of The Boeing Company Consolidated Health and Welfare Benefit Plan (Plan 635) and The Boeing Company Consolidated Retiree Health Benefit Plan (Plan 710) (collectively, the "Plans"), employee benefit plans subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits and of benefit obligations of the Plans as of December 31, 2024 and 2023, and the changes in their net assets available for benefits and changes in benefit obligations for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America.

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS AS OF AND FOR THE YEARS ENDED DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF THE PLANS

The following description of The Boeing Company Consolidated Health and Welfare Benefit Plan (“Plan 635”), and The Boeing Company Consolidated Retiree Health Benefit Plan (“Plan 710”) (collectively, the “Plans”) provides only general information. The Plans are sponsored by The Boeing Company (the “Company”). Eligible participants as defined by the Plans (“Participants”) should refer to the plan documents for a more complete description of the Plans’ provisions.

General —

Plan 635:

Plan 635 was established on January 1, 2014, coinciding with the merger of several plans. Plan 635 provides health benefits to eligible active, union, and non-union employees of the Company and their dependents. Eligibility requirements and benefits are dependent upon a wide range of factors. Participants should refer to their applicable Summary Plan Description(s), as modified by any applicable Summaries of Material Modifications, for more details.

Plan 710:

Plan 710 was established on January 1, 2022, as a result of a plan reorganization separating active and retiree health benefits. Plan 710 provides various health benefits for certain qualifying Boeing retirees and their dependents. It consists of six underlying plan designs for the following covered populations: Hourly, Salaried, Boeing North America (BNA), McDonnell Douglas Corporation (MDC), Boeing Satellite System (BSS), and Helicopters plans.

Effective 11:59 p.m., September 30, 2023, the Company elected to terminate the Retiree Health Care Program for MDC Retirees (“Plan 532”) and transferred any benefit options offered under Plan 532 to Plan 710, effective October 1, 2023. The amount of net assets transferred to Plan 710 from Plan 532 in October was \$2,526,403.

Generally, the Plans’ assets are received by the applicable Voluntary Employee Beneficiary Association trusts (“VEBA Trusts”). One of the VEBA Trusts is The Boeing Company VEBA Master Trust (the “Master Trust”).

The Plans are subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Benefits — The health benefits provided under the Plans are a combination of fully insured (with premiums paid) and self-insured (with participant claims paid). There are multiple collective bargaining agreements between the Company and unions that define the terms of an individual union-represented participant’s benefits. These agreements vary in contract length and renewal periods.

In compliance with federal regulations and guidance, the Company amended the Plans during 2020 to provide diagnostic testing for COVID-19 at no cost to participants. This requirement expired effective May 11, 2023, when the federal public health emergency ended. The Company extended

the no-cost diagnostic testing for participants who receive such testing at in-network providers through the end of 2023.

Valuation Oversight — The Company’s Trust Investment Group determines the Plans’ valuation policies and procedures. The Board of Directors of the Company has delegated the fiduciary oversight of the Plans’ assets to the Employee Benefit Investment Committee (“EBIC”). The EBIC has sub-delegated this responsibility to the Chief Investment Officer (“CIO”), who manages Trust Investments and chairs the Valuation Committee.

Administration — The Employee Benefit Plans Committee (or its authorized delegate) is responsible for the overall administration of the Plans.

Contributions — The Plans are funded primarily through contributions by the Company and participants in the Plans. The Company funds such amounts in excess of contributions by participants as necessary to provide assets sufficient to meet the obligations of the Plans.

The Company makes contributions to the Plans as needed to fund claims in excess of participants' contributions. Any deficiency of the Plan's net assets over benefit obligations is funded by the Company on a pay-as-you-go basis.

During 2024, the Company made contributions to the Plans to pay medical claims and premiums, as well as administrative expenses associated with the Plans. In addition to deductibles and co-payments, participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections. Certain plans had an increase in deductibles, copays, coinsurance and/or out-of-pocket maximums.

The costs associated with the retiree portion of postretirement benefit obligations related to Plan 710 are shared by the Company and the retirees participating in the Plan. The remainder of the postretirement benefit obligations is attributable to future retirements and is an estimate of the deferred cost to the Company net of expected future retiree contributions. The annual contributions by participants depend on the participants’ coverage category and age. Participant contributions for the year ended December 31, 2024 for Plan 635 and Plan 710 were \$259.8 million and \$36.7 million, respectively.

Contributions by certain eligible non-union employees and those members of any union groups that have contractually agreed to adopt the provisions of non-union health care plans depend on the participants’ coverage category and annual rate of pay. Contributions by early retirees depend on various factors including the non-union or union status, retirees’ coverage category, pay before retirement, retirement date, employment history with the Company, and the terms of an applicable collective bargaining agreement.

Plan Termination — Subject to the provisions set forth in ERISA and any applicable collective bargaining agreements, the Company has the right under the Plans to modify the benefits provided to participants, to discontinue its contributions at any time, and to terminate the Plans. In the event a plan terminates, the Company is required by the Plans to contribute the amount necessary to pay its share

of the benefits incurred through the date of the termination.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting — The financial statements of the Plans have been prepared in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Valuation of Investments — The investments in the VEBA Trusts are stated at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability (exit price) in an orderly transaction between market participants at the measurement date. J.P. Morgan Chase, N.A. (“J.P. Morgan”) serves as the trustee for the VEBA Trusts and the Plans.

Net appreciation/depreciation in fair value of investments includes both realized and unrealized gains and losses and is calculated as the difference between the fair value of the investments as of the beginning of the year or the purchase date in the current year and either the sales price or the end-of-year fair value. Purchases and sales are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. The income from the Master Trust is recorded on an accrual basis.

Rebates and Refunds — Prescription drug rebates and refunds due from the Plans’ third-party claims processors are recorded when earned. Rebates and refunds due as of the financial statement date have been reported as receivable, with the offset being netted against participant claims and premiums paid.

Prepaid Participant Contributions — Premium payments remitted to the Plans by participants for benefit coverage in future periods are reported as a liability.

Claims Paid — Claim payments are recorded when submitted to the Plans by the third-party claims processors for reimbursement. Claims paid by the claims processors prior to year-end that are not reimbursed by the Plans as of year-end are recorded as claims payable in the accompanying statements of benefit obligations.

Claims Incurred but Not Reported — The Plans’ liability for participant health claims incurred but not reported at year-end is estimated using actuarial methods that use historical trend information developed through studies of medical claim lag patterns incurred in prior years. Factors are then applied to paid claims amounts to estimate claims incurred but not reported at year-end.

The estimated liabilities for retired participants’ health claims incurred but not reported are included in the postretirement benefit obligations. As of December 31, 2024 and 2023, Plan 710’s postretirement benefit obligations included \$30.5 and \$32.2 million, respectively, of estimated claims incurred but not reported.

Administrative Expense — Necessary and proper expenses of the Plans are paid from assets at the plan level, except for those expenses for which the Company is required by law or chooses to pay. In 2024, the Company paid \$30 million and \$13 million of third-party plan administration and consulting expenses on behalf of Plan 635 and Plan 710, respectively.

Party-In-Interest Transactions — Certain investments of the Plans are managed by J.P. Morgan Asset Management, an affiliate of J.P. Morgan. J.P. Morgan is the trustee for the Plans, and therefore, these transactions with J.P. Morgan Asset Management qualify as exempt party-in-interest transactions. J.P. Morgan Asset Management's investment management fees are included as a reduction of the asset return earned at the Master Trust level or at the trust level.

Use of Estimates — The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results are expected to differ from those estimates.

Risks and Uncertainties — The Plans utilize various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate and credit risk, and overall market volatility. Market risks include global events, such as a pandemic or international conflict, which could impact the value of investment securities.

At December 31, 2023, Plan 710 had a significant concentration in the Vanguard Balanced Index Fund Open-End Fund, representing 91% of total investments. This fund was liquidated in August 2024 and the proceeds invested in the BlackRock Russell 3000 Index Fund and BlackRock US Debt Index Fund.

Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term, and such changes could materially affect the amounts reported in the financial statements.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, healthcare inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term could materially affect the financial statements.

The Inflation Reduction Act (IRA) was signed into law in August 2022, and details of implementation are still evolving. Based on the guidance currently available along with information regarding specific plan provisions, the Plan Sponsor's expected actions and expected participant behavior based on changes in the relative values of plan and individual market coverage, changes were made to assumptions as of December 31, 2024. A fully insured Medicare Advantage Prescription Drug (MAPD) plan trend was incorporated to reflect that the increase in Centers for Medicare and Medicaid Services subsidy benefit is likely to grow at a lower rate than claims cost. In addition, after reviewing the claims experience and prior subsidies for the MAPD plans, it was assumed that the fully insured MAPD plans will have a positive premium after the existing \$0 premium guarantee expires in 2028. No changes were made to the actuarial assumptions as of December 31, 2023. Additional changes may be reflected in future valuations as more regulatory guidance and actual plan experience become available.

Medicare Subsidy — The Plans' postretirement benefit obligation does not reflect an amount associated with the Medicare subsidy allowed under the Medicare Prescription Drug Improvement and Modernization Act of 2003 because the Plans are not directly entitled to the Medicare subsidy.

Subsequent Events — Subsequent events were evaluated through October 2, 2025, the date the financial statements were available to be issued. There are no subsequent events which need to be disclosed in or adjusted to these financial statements.

3. EMPLOYER GROUP WAIVER PLAN ("EGWP")

Plan 710 uses an EGWP structure. EGWP is a Center for Medicare Services ("CMS")-approved program offering savings opportunities for employers that provide prescription drug benefits to their Medicare-eligible retirees. Insurance companies contract with CMS to offer this benefit to the retirees' employers on CMS' behalf. The certified sponsoring insurance company receives the payments and passes the savings on to the employer's sponsored health and welfare plans.

There are several key elements of the program, including a low-income subsidy, a late enrollment penalty, a low-income cost-sharing subsidy, a direct subsidy, a reinsurance (catastrophic) subsidy, and a subsidy related to the Coverage Gap Discount Program.

Plan 710 received EGWP subsidies and recorded these amounts as contributions from other sources in the statements of changes in net assets available for benefits. In addition, EGWP subsidies receivables are recorded in the statements of net assets available for benefits.

4. POSTRETIREMENT BENEFITS

The amounts reported as postretirement benefit obligations in the accompanying financial statements represent the actuarial present value of those estimated future benefits that are attributed by the terms of Plan 710 to employees' service rendered to the date of the financial statements, reduced by the actuarial present value of the contributions expected to be received in the future from participants in the Plans. The amounts reported also include estimated liabilities for retired participants' health claims incurred but not reported as of year-end. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired or terminated employees and their beneficiaries and dependents and (2) active employees and their beneficiaries and dependents who are potentially eligible for benefits after retirement from service with the Company. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefits that is attributable to that employee's services rendered to the valuation date. The postretirement benefit obligation represents the amount that is to be funded by contributions from the Company and from the existing assets of Plan 710. As of January 1, 2022, Plan 635 no longer holds any postretirement benefit obligations.

The actuarial present value of the expected postretirement benefit obligations is determined by an independent actuary and is the amount that results from (1) applying actuarial assumptions to historical claims cost data for the purpose of estimating future annual incurred claims costs per eligible participant and (2) adjusting such estimates for the time value of money (through discounts for

interest) and the probability of payment (by means of decrements, such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

For the December 31, 2024 valuation, the annual rate of increase in health care costs was assumed to be 6.0% in 2025, then grading down by 0.25% in years 2026 through 2031 and remaining at 4.5% thereafter. For the December 31, 2023 valuation, the annual rate of increase in health care costs were assumed to be 5.5% in 2024 then grading down by 0.25% in the years 2025 through 2028 and remaining at 4.5% thereafter.

Other significant assumptions used in the valuations as of December 31, 2024 and 2023 were as follows:

- Assumed retirement rates vary from age 50 to 70.
- For the 2024 and 2023, the mortality assumptions were based on the RP-2006 projected forward to 2015 using MP-2017, adjusted for the Plan Sponsor's 2013-2017 retiree experience with a factor of 0.894 for males and 1.003 for females.
- The discount rates used to measure the Accumulated Postretirement Benefit Obligation ("APBO") increased an average of 45 basis points from prior year.
- Discount rates vary by employee group covered, as described below:

Significant changes in actuarial assumptions from December 31, 2023 to December 31, 2024 include the following:

- The per capita claims cost and administrative expense assumptions were updated for all plans.
- The EGWP subsidy assumptions were updated for the Helicopters and MDC plans.
- The annual non-ASO plan per participant administrative expenses were updated for all plans.

- The health care cost and medical plan trends were updated for all plans.
- The deferred loads for the Hourly and Salaried plans and the Medicare Part B only loads for the MDC and BNA plans were updated.
- The minimum retiree contributions percentages were updated for certain participants in the Salaried, Hourly, and MDC plans.
- The retirement rates were updated for the Salaried, Helicopters, BNA, and BSS plans.
- The plan participation election percentage was updated in the Hourly plan.
- The termination rates were updated for the Helicopters, MDC, BNA, and BSS plans.
- The claims enrollment percentages (fully insured versus self-insured) were updated in the MDC plan.
- The expected return on assets assumption in the BNA plan decreased from 6.4% to 6.0%.

The health care cost trend rate assumption has a significant effect on the amounts reported in the accompanying financial statements. If the assumed trend rate increased by one percentage point in each future year, it would increase the postretirement benefit obligations as of December 31, 2024 by \$151 million for Plan 710.

The foregoing assumptions are based on the presumption that Plan 710 will continue in operation. If Plan 710 were to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligations.

5. FAIR VALUE OF FINANCIAL ASSETS

Accounting standards establish a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy for financial assets are described below:

Level 1 — Values are based on unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets. An active market is a market in which transactions for the asset occurs with sufficient frequency and volume to provide pricing information on an ongoing basis.

Level 2 — Values are based on (a) quoted prices for similar assets in active markets; (b) quoted prices for identical or similar assets in nonactive markets; or (c) valuation models whose inputs are observable, directly, or indirectly, for substantially the full term of the asset.

Level 3 — Values are based on prices or valuation techniques that require inputs that are both unobservable and significant to the overall fair value measurement. The Plans do not have any Level 3 investments.

Commingled Funds — Investments in common/collective trust funds are valued based on the year-end unit net asset value (“NAV”). The NAV is used as a practical expedient to estimate fair value. Unit values are determined by the issuer or third-party administrator by dividing the fair values of the total net assets at year-end by the outstanding units. There were no unfunded commitments, no restrictions on redemption frequency, and no advance notice periods required for redemption for these investments.

Mutual Funds — are registered investment companies that invest primarily in short-term fixed-income securities and are valued using a market approach based on quoted market prices to represent the net asset value at year-end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although management of the Plans believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair values of financial instruments could result in different fair value measurements at the reporting date. Assets are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. For the year ended December 31, 2024, there were no transfers in or out of Level 3.

Assets Held in the Master Trust — As of December 31, 2024 and 2023, the Master Trust invested only in mutual funds, which are classified as Level 1 investments.

Assets Held Outside the Master Trust — The following table sets forth by level within the fair value hierarchy and by NAV which is outside the fair value hierarchy, Plan 710’s investments held outside the Master Trust. These investments are measured at fair value on a recurring basis as of December 31, 2024 and 2023:

The Plans also have other assets not measured at fair value on a recurring basis, including receivables. The fair value of these assets approximates the carrying amounts in the accompanying financial statements due to the short maturity of such Investments.

6. MASTER TRUST

Some of the Plans' investments are held in the Master Trust, which was established for the investment of assets of the Plans. Each plan has an undivided interest in the Master Trust. The assets of the Master Trust are held by J.P. Morgan.

On a daily basis, the Plans may have contributions, withdrawals, and/or expense charges. At month-end, the trustee calculates the participating interest factor for the month based on a daily dollar-weighted average and allocates to each plan its share of income and expenses from the Master Trust to arrive at each plan's ending beneficial interest.

Plan 635's interest in the Master Trust represented 0.04% and 0.03% of the Master Trust's net assets at December 31, 2024 and 2023, respectively. Plan 710's interest represented 99.96% and 99.97% of the Master Trust's net assets at December 31, 2024 and 2023, respectively.

The investment income of the Master Trust during 2024 is \$352,946, which consisted of interest income.

7. TAX STATUS

The VEBA Trusts established to hold the Plans' assets are intended to qualify pursuant to Section 501(c)(9) of the Internal Revenue Code ("IRC"), and accordingly, the VEBA Trusts' net investment income is generally exempt from income taxes. The Plan Sponsor obtained exemption letters from the Internal Revenue Service ("IRS") and believes the VEBA Trusts continue to qualify and operate in accordance with applicable provisions of the IRC. Therefore, no provision for income taxes has been included in the Plans' financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plans and recognize a tax liability (or asset) if the Plans have taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plans and VEBA Trusts are subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021 (including predecessor plans).
