This representation letter is provided in connection with your audit of the financial statements of Gurnick Academy Retirement Savings Plan (the “Plan”) an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, schedule H, line 4i – schedule of assets (held at end of year) as of December 31, 2024, and the related notes to the financial statements.

46. There have been no cybersecurity breaches or other cyber events whose effects should be considered for disclosure in the financial statements, as a basis for recording a loss contingency, or otherwise considered when preparing the financial statements.
47. We acknowledge our responsibility to maintain adequate fidelity bond coverage in accordance with ERISA requirements. As of December 31, 2024, the Plan's bond coverage was \$400,000, which did not meet the required coverage for 2024. We confirm our awareness that the required coverage should be the lesser of \$500,000 or 10% of beginning plan assets, and will evaluate and obtain sufficient coverage to comply with ERISA requirements going forward.
