Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Grain Millers Inc. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements

Note 1. Plan Description

The following description of Grain Millers, Inc. Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan that covers all United States employees of Grain Millers, Inc. (the Plan Sponsor) who have attained the age of 21 years. There is no minimum service requirement for eligibility; employees may enter the Plan immediately upon hire, provided they meet the age requirement. The Plan Sponsor has appointed Principal Trust Company to be the trustee, invest and manage the assets of the Plan, and provide administrative services. The Plan Sponsor is responsible for oversight of the Plan. The Plan's Investment Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Sponsors: In addition to the Plan Sponsor, the Plan has been adopted by the following related companies:

- New Century Holdings, Inc.
- GMI North America, Inc.
- Agricor, Inc.

Contributions: Participants may contribute a portion of their pretax and post-tax (Roth) annual compensation, subject to the limit specified in the Plan and subject to the maximum allowed by the Internal Revenue Code (the Code). In the absence of a deferral election, participants are automatically enrolled in the Plan at a deferral percentage of 8% of eligible compensation for their initial enrollment. The Plan also provides for employer matching contributions, which are made at the option of the Plan Sponsor's Board of Directors. The Plan Sponsor currently provides an employer matching contribution of 100% of the first 4% of eligible compensation and 50% of the following 4% of eligible compensation that a participant contributes to the Plan. Additional employer contributions may be made at the discretion of the Plan Sponsor's Board of Directors. There were no additional employer contributions made to the Plan during the year ended December 31, 2024.

Participant accounts: Each participant's account is credited with the participant's contributions, and allocations of the Plan Sponsor's contributions, if any, earnings or losses based on the performance of participant-selected investment options, and administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in all their contributions and earnings thereon. Participants vest in the Plan Sponsor's contributions and earnings thereon after completing two years of service.

Forfeitures: Forfeitures are used to fund employer matching contributions. During 2024, employer matching contributions were partially funded by approximately \$87,000 from forfeited nonvested accounts. The amount of forfeitures available to fund future employer matching contributions was insignificant at December 31, 2024 and 2023.

Investments: Plan participants are allowed to invest in a variety of investment choices, as more fully described in the Plan's literature.

Note 1. Plan Description (Continued)

Payment of benefits: Upon retirement, disability or termination, participants may elect to receive their vested balance in the form of a lump-sum payment or in monthly payments through an annuity. Distributions of benefits upon termination become automatic if the participant's account balance is less than \$5,000. Participants with an account balance less than \$5,000 but greater than \$1,000 receive a direct rollover into a qualified individual retirement account unless they elect to receive a lump-sum payment. Those with a balance less than \$1,000 receive a lump-sum payment. Participants may also elect to receive their vested balance in the event of a financial hardship, as defined, or upon attainment of age 59½, subject to the rules and regulations adopted by the Plan.

Although it has not expressed any intent to do so, the Plan Sponsor has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, all participants would become 100% vested in their accounts.

Subsequent Events: The Plan Administrator has evaluated subsequent events through October 3, 2025, the date the financial statements were available to be issued.

Note 2. Significant Accounting Policies

Basis of accounting: The financial statements are prepared using the accrual method of accounting.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policies utilizing information provided by the Plan's investment advisors and trustee. See Note 4 for a discussion of fair value measurements.

Interest income is recorded on the accrual basis, and dividends are recorded on the ex-dividend date. Realized gains and losses related to sales of investments are recorded on a trade-date basis, and unrealized gains and losses are recorded based on the fair value as of the end of the reporting period.

Contributions: Contributions from plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Benefits paid to participants: Benefits paid to participants are recorded when paid.

Administrative expenses: The Plan Sponsor may, at its discretion, absorb administrative expenses of the Plan, while the remaining expenses are paid by the Plan. In addition, certain investment-related expenses are included as an offset to net appreciation in fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

Risks and uncertainties: The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the 2024 statement of net assets available for benefits.

Note 3. Information Certified by the Plan Trustee

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedule, obtained by management and agreed to or derived from information certified by Principal Trust Company, the trustee of the Plan. The Plan Administrator has obtained certifications from the trustee that the information provided to the Plan Administrator by the trustee related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information that appears throughout the financial statements and ERISA-required supplemental schedule related to assets certified by the trustee.

Principal Trust Company also certified the completeness and accuracy of \$6,823,651 of net appreciation in fair value of investments and \$1,299,145 of interest and dividends related to the aforementioned investments for the year ended December 31, 2024.

Note 4. Fair Value Measurements

Accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under accounting standards are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Note 4. Fair Value Measurements (Continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies: Investments in registered investment companies are valued at the publicly quoted market prices of shares held by the Plan. The total value is calculated by multiplying the price per share by the number of shares held on the last business day of the plan year.

Collective trust fund: The collective trust fund is valued at the net asset value (NAV) as reported by the investment manager at year-end, adjusted to fair value based upon the fund's audited financial statements. The fund's underlying assets consist of investment contracts and security-backed contracts.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

This category includes a stable value collective fund whose objective is to provide preservation of capital, relatively stable returns consistent with its comparatively low risk profile, and liquidity for benefit responsive plan or participant payments. The fund invests in conventional, synthetic and separate account investment contracts issued by life insurance companies, banks and other financial institutions.

Note 5. Related-Party Transactions and Party-in-Interest Transactions

The Plan's investments are managed by Principal Trust Company. Principal Trust Company is the trustee, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included as part of net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment.

Note 6. Tax Status

The Plan has adopted a non-standardized pre-approved plan sponsored by Principal Life Insurance Company. Principal Life Insurance Company has received an opinion letter from the Internal Revenue Service (IRS) as to the pre-approved plan's qualified status. The pre-approved plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable provisions of the Code.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
