INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of the
Curia RLS Union 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Curia RLS Union 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section -

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Curia RLS Union 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Curia RLS Union 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

NOTE 1 — PLAN DESCRIPTION

The following description of the Curia RLS Union 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all union employees of Curia Global, Inc. (the “Company”) covered by a collective bargaining agreement with the Company, classified by the Company, in accordance with its personnel policy, as an hourly rate employee. There are no age or service requirements for covered employees to become eligible. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Each eligible employee can elect to make tax-deferred and after-tax contributions into the Plan from 1% to 75% of their eligible compensation, subject to certain limitations under the Internal Revenue Code (IRC). The Plan allows participants to make pre-tax deferrals and Roth deferrals, subject to IRC limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make additional catch-up contributions as determined by the IRC. Participants may also make rollover contributions of amounts representing distributions from other qualified retirement plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Participants are automatically enrolled at a pre-tax deferral rate of 3% of eligible compensation. Unless otherwise directed by the participant, contributions are automatically invested in the target date fund based on the participants’ expected retirement age. For auto-enrolled participants, the contribution will automatically increase by 1% each year up to a maximum of 10% of their eligible compensation, unless the participant elects not to participate in the auto-escalation feature.

The Company may make a matching contribution equal to 50% of the participant’s elective contributions. This matching contribution cannot exceed 5% of the participant’s total eligible compensation. The Company may designate any portion or all of its matching contribution as a qualified matching contribution (no matching contributions were designated as qualified matching contributions in 2024). The Company can also make a discretionary qualified non-elective contribution for the benefit of eligible employees. The Company may also make discretionary matching contributions. A participant becomes eligible for Company contributions after completing one year of service with the Company. A participant will generally share in the Company contribution for any pay period in which the participant also made an elective contribution and is eligible for the Company contribution.

Transfer of Plan Assets

During the year ended December 31, 2024, certain participant assets were transferred to another qualified retirement plan held by the Company due to a change in participant status.

NOTE 1 — PLAN DESCRIPTION (Continued)

Participant Accounts

Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's qualified non-elective contribution, if any, (b) the Company's matching contributions on their deferrals, if any, and (c) Plan net appreciation, and charged with an allocation of administrative expenses. Allocations are based on participant earnings on account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of (a) \$50,000 or (b) 50 percent of their vested account balance. Participants may not have more than one outstanding loan. Loan terms range up to five years or up to fifteen years when for the purchase of a primary residence. Loans are collateralized by the balance in a participant's account and bear interest at the prime interest plus 1 percent. Principal and interest is paid ratably through payroll deductions.

Vesting

Participants are immediately vested in their salary deferral and rollover contribution accounts, qualified non-elective contribution and qualified matching contribution, and net earnings thereon. Vesting in the Company's matching contributions and related Plan net earnings is based on years of continuous service. The vesting starts after two years of service at a rate of 20% per year, and becomes 100% vested after six years of credited service.

Forfeitures

Forfeitures of employer contributions and matching contributions are used to reduce the employer contribution or used to pay Plan expenses. At December 31, 2024 and 2023, forfeited accounts totaled \$66,387 and \$62,727, respectively. During the year ended December 31, 2024, approximately \$1,658 of the forfeited accounts were used to reduce employer contributions and \$2,952 were used to pay administrative expenses.

Payment of Benefits

Upon termination of service due to death, disability, retirement or other reasons, a participant's distribution will be in the form of a lump-sum distribution of the participant's vested interest in his or her account, or an alternate form of payment, if permitted by the Plan, at the time of the distribution. Termination distributions of account balances greater than \$5,000 may be deferred to a later date. Participants may also request an in-service withdrawal after age 59 ½ or hardship withdrawals upon meeting certain requirements as outlined by the Internal Revenue Service (IRS).

NOTE 2 — SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following are the significant accounting policies followed by the Plan:

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan determines valuation policies utilizing information provided by investment advisors and the insurance company.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts which are reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes realized gains or losses and unrealized appreciation on those investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when they are incurred.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Company pays for certain plan expenses except certain plan investment advisory fees, initiation charges on notes receivable from participants and participant activity charges which include benefit processing, installment payment charges, and annuity payment charges.

Subsequent Events

The Plan has evaluated subsequent events for potential recognition and/or disclosure through September 30, 2025, the date the financial statements were available to be issued.

NOTE 3 — PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are units of common/collective trust accounts with T. Rowe Price Trust Company, which is the Plan's trustee, as defined by the Plan. T. Rowe Price Retirement Plan Services, Inc. is the Plan's recordkeeper as defined by the Plan. As such, these transactions qualify as party-in-interest transactions.

Notes receivable from participant transactions also qualify as exempt party-in-interest transactions.

NOTE 4 — PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of a termination, participants will become 100% vested in their account balance.

NOTE 5 — INFORMATION CERTIFIED BY PLAN'S TRUSTEE

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, T. Rowe Price Trust Company, the trustee of the Plan has certified to the completeness and accuracy of all investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023 and the schedule of assets (held at end of year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

NOTE 6 — FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets. Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

NOTE 6 — FAIR VALUE MEASUREMENTS (Continued)

The assets or liabilities fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for the Plan's assets measurement at fair value:

Registered investment companies are valued at the closing price reported on the active market on which the individual securities are traded.

Common/collective trusts are valued at either the closing Net Asset Value (NAV) per unit on the day of valuation as an input to the Level 2 valuation or the trust's unpublished NAV, as provided by the trustee, which is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. There are no redemption restrictions or unfunded commitments in the common/collective trusts offered by the Plan.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 7 — FULLY BENEFIT - RESPONSIVE INVESTMENT CONTRACT

Separate Account Investment Contract

The Plan has entered into a benefit responsive separate account investment contract with MassMutual in order to provide a guaranteed interest investment option. MassMutual pays contract value for participant withdrawals, regardless of the value of the assets in the separate account. The credited interest rate is a function of the relationship between contract value and the value of the assets in the separate account. The rate is reset periodically, quarterly or semi-annually, by MassMutual and cannot be less than zero. The contract holder may terminate the contract at any time, and receive the value of the assets in the separate account. Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include premature termination of the contracts by the plan, layoffs, plan termination, bankruptcy and mergers. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

NOTE 8 — TAX STATUS

The IRS has determined and informed the Plan by a letter dated August 19, 2020, that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the determination letter. However, the plan administrator believes that the Plan through is designed and being operated in compliance with the applicable requirements of the IRC.

The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9 — RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
