



1. DESCRIPTION OF PLAN

The following description of the Houston Distributing Company, Inc. Tax Advantage Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

- A. General. The Plan is a defined contribution, contributory plan covering all full-time employees who have completed one month of service and are age 18 and older. Employer matching contributions begin when the employee has completed one year of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Board of Trustees.
- B. Employer Supplemental Contributions. Employer Supplemental Contributions may be made by Houston Distributing Company, Inc. (the Company) from its current or accumulated earnings and profits at the option of the Company's Board of Directors. The contributions are allocated to participants based on the percentage of their compensation to the total compensation paid to participants during the plan year. There were no Employer Supplemental Contributions during 2024 or 2023.
- C. Contributions. Each year, participants may contribute at a rate of not more than 100 percent of their compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. These contributions are made through payroll deductions and are deposited into the participant's account within the funds established by the Plan. The Company contributes 50% of the first 6% of base compensation that a participant contributes to the Plan. The matching Company contribution is invested directly in the investment options selected by the Participant. Contributions are subject to certain statutory limits. The Plan also allows Roth Elective Deferrals. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contributions plans. (rollover). Contributions are subject to certain IRS limitations.

- D. Participant Accounts. Each participant's account is credited with the participant's contributions and allocations of (a) the Company's matching contribution and (b) Plan earnings (losses) and charged with an allocation of any fee charged by the Plan. Allocations are based on participant earnings or account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested accounts.
- E. Vesting. Participants are vested immediately in their contributions plus actual earnings on the contributions. Vesting in the Company's contribution portion of their accounts is based on the participant's years of continuous service. A participant is one hundred (100) percent vested after five (5) years of credited service.
- F. Payment of Benefits. On termination of service due to death, disability or retirement, a participant may receive a lump-sum amount equal to the value of their account, or the value of their account may be distributed to them using another method as approved by the Plan's Administrative Committee. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.
- G. Notes Receivable from Participants. Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are secured by the balance in the participant's account and bear interest at a rate of one percent over the prime interest rate as of the date of the loan (4.25% to 9.50% for loans outstanding at December 31, 2024). Principal and interest is paid ratably through payroll deductions.
- H. Forfeited Accounts. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$5,185 and \$7,215, respectively. These accounts will be used to pay plan expenses or reduce employer contributions. Also, in 2024 and 2023, respectively, plan expenses were reduced by \$13,468 and \$7,341 from forfeited nonvested accounts.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

- A. Basis of Accounting. The financial statements of the Plan are prepared using the accrual method of accounting.
- B. Use of Estimates. The preparation of financial statements in accordance with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

- C. Investment Valuation and Income Recognition. Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 6 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

- D. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024, and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

- E. Benefit Payments. Benefits are recorded when paid.

- F. Plan Expenses. Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation/depreciation of fair value of investments.

- G. Subsequent Events. Subsequent events have been evaluated through August 15, 2025, which is the date the financial statements were available to be issued.

3. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become one hundred (100) percent vested in their accounts.

4. INCOME TAX STATUS

The Internal Revenue Service has determined and informed the Plan by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt. The Plan has been restated effective January 1, 2021, to provide for all IRS mandated amendments required since the Plan's last restatement, including amendments for the Bipartisan Budget Act of 2018, the SECURE Act, and the CARES Act.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

5. CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation/depreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Trust Bank, a qualified institution.

6. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
  - quoted prices for similar assets or liabilities in active markets;
  - quoted prices for identical or similar assets or liabilities in inactive markets;
  - inputs other than quoted prices that are observable for the asset or liability;
  - inputs that are derived principally from or corroborated by observable market data by correlation or other means.If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following methodologies were used to measure the fair value of the Plan's investments:

**Mutual Funds:** Valued at quoted market prices in an exchange and active market, which represents the net asset value (NAV) of shares held by the Plan. The money market fund seeks to maintain a \$1.00 NAV.

**Common Collective Trust funds:** The fair value of participation units held in the Morley Stable Value Fund are based on net asset value, which is obtained from audited information reported by the issuer of the common collective trust at year-end as a practical expedient.

Investment Disclosure/Fair Value

The Plan's valuation methods may result in a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Although Plan management believes the valuation methods are appropriate and consistent with those participating in the market, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The investment objective of the Morley Stable Value Fund is to provide preservation of capital, relatively stable returns consistent with its comparatively low risk profile, and liquidity for benefit-responsive payments. Withdrawals from the Morley Stable Value Fund for benefit payments and participant transfers to noncompeting options are made to plan participants promptly upon request but in all cases within 30 days after written notification has been received. All plan sponsor-directed full or partial withdrawals are subject to a twelve month advance written notice requirement, though the Morley Stable Value Fund may waive this requirement at its discretion. The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024, and 2023.

The Plan's policy is to recognize transfers between Levels 1 and 2 and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the years ended December 31, 2024, and 2023, there were no transfers between levels 1, 2 and 3.

**7. GUARANTEED INVESTMENT CONTRACTS WITH INSURANCE COMPANY**

Beginning in 2014, the Plan made available investment in the Standard Insurance Company (Standard) Stable Asset Fund III. During 2017, the Plan entered into Standard Insurance Company Stable Asset Funds I and V. The funds are fully benefit-responsive. Standard maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1%. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The contract meets the criteria to be considered fully benefit-responsive and therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by the participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported by Standard, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by the future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

The contract value of the investment contracts at December 31, 2024 and 2023 was \$2,986,583 and \$2,942,605, respectively.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

9. RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by USI Consulting Group. USI Consulting Group is the trustee and recordkeeper for the Plan, and, therefore, these transactions qualify as party-in-interest transactions.

USI Consulting Group provides recordkeeping and administrative services to the Plan pursuant to a Master Plan Services Agreement (MSA) between the Company and USI Consulting Group. USI Consulting Group may receive revenue from mutual fund service providers. This revenue is used to offset certain amounts owed to USI Consulting Group for its administrative services to the Plan. Consequently, these transactions qualify as party-in-interest transactions.

If the revenue received by USI Consulting Group from such mutual fund services providers exceeds the amount owed under the MSA, USI Consulting Group remits the excess to the Plan's trust on an annual basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During 2024 and 2023 there were no excess amounts. The Plan or Plan Sponsor may make a payment to USI Consulting Group for administrative expenses not covered by revenue sharing.
