### **Opinion**

**NOTE 1 - DESCRIPTION OF THE PLAN**

The Southern California Local 831 - Employer Health Fund (the "Plan") is a multiemployer welfare benefit plan providing medical - hospital, dental, prescription, vision, life and accidental death and dismemberment, and employee assistance benefits to participants. Certain benefits are funded by insurance contracts or are provided by contracts with a prepaid health plan. Other benefits are paid directly by the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Active employees of participating employers, on whose behalf employers are required to contribute to the Plan, are eligible for those benefits specified by the Plan based on the employer contribution rate designated in the collective bargaining agreement between their employer and the Tradeshow and Sign Crafts Local Union 831. Retired employees eligible for retirement benefits from the Southern California Local 831 - Employer Pension Fund and meeting Plan retiree eligibility requirements, who are at least 60 but less than 65 years of age, are eligible for those benefits specified by the Plan. Retiree coverage is based on the class of benefits under which they were covered immediately prior to their retirement. Dependents of certain active and retired employees are eligible for those benefits specified by the Plan.

The Plan documents include detailed rules for each situation. Participants should refer to the plan agreement and any amendments regarding specific provisions of the Plan.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**A. Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**B. Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results may differ from those estimates.

**C. Contributions**

Employer contributions as reported are contributions made by employers on behalf of employees for hours or months worked during the year. Employer contributions receivable is estimated based on contributions received subsequent to the end of the year. Participant contributions are contributions from participants for coverage during the year. Participant contributions receivable is estimated based on contributions for coverage during the year that are received subsequent to the end of the year.

**D. Employer Payroll Compliance Program**

Employer remittance reports were accepted as submitted, without examination or verification of employers' payroll records. The system of internal control provides for examination of employers' payroll records by independent auditors under an employer payroll compliance program.

**E. Investments**

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820 provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are generally unobservable and typically reflect management’s estimates of assumptions that market participants would use in pricing the asset or liability.

**E. Investments (Continued)**

The fair values of investments were provided by the Plan's corporate trustee. Investment income, realized gains and losses on sale of investments and investment expenses are reported on the accrual basis. Realized gains or losses from the sale of investments and unrealized appreciation or depreciation in the fair value of investments is reported as net appreciation of investments.

**F. Cash**

Cash consists of cash on deposit with a financial institution in checking accounts.

**G. Benefits**

Benefits reported on statements of changes in net assets available for benefits are segregated by premiums for eligible participants paid during the year, net of refunds (Premiums Paid - Net) and benefits claims for participants services paid during the year under the indemnity plan, net of refunds and stop-loss insurance reimbursements, if any (Indemnity Claims Paid - Net).

Benefit obligations are segregated on statements of benefit obligations based on estimates at the end of the year of premiums for coverage during the year unpaid (Premiums Payable); claims incurred during the year, reported but unpaid, net of refunds, if any (Claims Payable); claims incurred during the year but not reported nor paid (Claims Incurred But Not Reported); future benefits costs to be incurred based on participants' accumulated eligibility credits (Future Benefits Based on Participants' Accumulated Eligibility) and the actuarial present value of those estimated future benefits expected to be paid to or for (1) currently retired or terminated participants and their beneficiaries and dependents and (2) active participants and their beneficiaries and dependents after retirement from service with the participating employers (Postretirement Benefit Obligations). See Note 2-H. Statements of changes in benefit obligations reports the components of the changes in benefit obligations.

**H. Postretirement Benefits**

The postretirement benefit obligations represent the actuarial present value of those estimated future benefits that are attributed to participant service rendered to December 31, reduced by the actuarial present value of contributions expected to be received in the future from current plan participants.

Postretirement benefits include future benefits expected to be paid to or for (1) currently retired or terminated participants and their beneficiaries and dependents, and (2) active participants and their beneficiaries and dependents after retirement from service with participating employers. Prior to an active participant's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that participant's service in the industry rendered to the valuation date.

The postretirement benefit obligations were determined by actuaries from Segal Consulting and are the amounts that result from applying actuarial assumptions to historical benefits cost data to estimate future annual incurred benefits costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability or withdrawal), between the valuation date and the expected date of payment.

**H. Postretirement Benefits (Continued)**

The significant actuarial assumptions and methods used for the year ended December 31, 2024 were (if the actuarial assumptions for the year ended December 31, 2023 or 2022 were different, they are disclosed in [brackets]): (a) Actuarial Cost Method: Projected Unit Credit, (b) Discount Rate: 5.25% [December 31, 2023 – 4.75%], (c) Administrative Expense Increase Rate - 2.00%, and (d) other assumptions for health trend rates, retiree contribution increase rate, postretirement mortality rates, termination rates before retirement, retirement rates, per capita costs and other factors.

The change in the discount rate from 4.75% to 5.25%, updates on per capita health claims costs and retiree contributions, updates in future trend rates on health costs and retiree contributions and those who terminate due to disability are now assumed to be eligible for Medicare resulted in a decrease of \$3,994,047 in postretirement benefit obligations during the year ended December 31, 2024. Assumption changes for per capita health claims costs and retiree contributions resulted in a decrease of \$1,398,453 in postretirement benefit obligations during the year ended December 31, 2023.

The foregoing assumptions and methods are based on the presumption that the Plan will continue to provide retiree benefits. Were retiree benefits to be terminated or be amended, different actuarial assumptions, methods and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligations.

The costs of the postretirement benefit plan are shared by the Plan's participating employers and retirees. Retirees, on average, paid approximately 57% and 56% of the estimated cost of postretirement benefits in the years ended December 31, 2024 and 2023, respectively.

The medical trend rates have a significant effect on the postretirement benefit obligations. A 1% increase in the medical trend rates would increase the postretirement benefit obligations as of December 31, 2024 and 2023 by \$351,861 and \$730,390, respectively.

The calculation and reporting of the postretirement benefit obligations does not imply that there is any legal liability to provide the benefits valued, nor is there any implication that the Plan is required to implement a funding policy to satisfy the projected expense.

**I. Claims Examination Program**

A program of examining benefit payments, on a sample basis, is being conducted by the Plan's independent auditors under a separate, continuing claims examination engagement.

**J. Tax-Exempt Status**

The Plan is tax-exempt under Internal Revenue Code Section 501(c)(9) and from the state of California under Revenue and Taxation Code Section 23701; therefore, no provision is made for federal or state income taxes.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 5 - PLAN AMENDMENTS**

At their meeting on March 2, 2023, the Board of Trustees approved to continue with the zero co-pay for COVID related services and supplies after the end of the emergency period.

At their meeting on September 13, 2023, the Board of Trustees approved the option to waive the benefit of Amendment No. 4, effective October 1, 2023.

At their meeting on September 13, 2023, the Board of Trustees approved to discontinue the zero co-pay for COVID related services and supplies, effective November 1, 2023.

Amendment to the Southern California Local 831 Employer Health Fund, Health Plan Restated as of July 1, 2015.

The Board of Trustees approved Amendment No. 5 to the Southern California Local 831 Employer Health Fund, Health Plan at their meeting on December 7, 2023. The amendment supplements Amendment No. 4 and allows participants to file a written request to suspend the rules regarding the forfeiture of reserve benefit credits including allowing their reserve benefit credits to fall to zero, effective October 1, 2023.

**NOTE 6 - PLAN TERMINATION**

In the event of termination, the trustees shall pay any and all obligations of the Plan and distribute and apply any remaining surplus in such manner as will, in their opinion, best effectuate the purposes of the Plan and the requirements of law.

**NOTE 7 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market fluctuations, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

The actuarial present value of postretirement benefit obligations is reported based on certain assumptions pertaining to interest rates, inflation rates, employee demographics and other factors, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

**NOTE 8 - CONCENTRATION OF CREDIT RISK**

During the year ended December 31, 2024, the Plan maintained bank accounts with cash balances in excess of the federally insured limit of \$250,000. The amounts in excess of the limit were subject to risk if the financial institution did not perform. The Plan has not incurred any loss on the uninsured balances. The Plan's uninsured balance as of December 31, 2024 was \$4,284,976.

**NOTE 9 - STOP-LOSS INSURANCE REIMBURSEMENTS**

The Plan has purchased stop-loss insurance on behalf of the participants covered under the self-insured health plan in order to limit its exposure, which will reimburse the Plan for total individual claims and total aggregate claims exceeding certain limits. For the years ended December 31, 2024 and 2023, the Plan received \$449,578 and \$306,130 in stop-loss reimbursements, respectively.

**NOTE 10 - TRANSACTIONS WITH RELATED PARTIES**

The Southern California Local 831 - Employer Pension Fund, a related entity, collected employer contributions through a lockbox system on behalf of the Plan and other related entities and transmitted to the Plan and other related entities the employer contributions collected. Employer contributions collected through the lockbox system on behalf of the Plan that were not transferred to the Plan as of the end of the year were recognized as a receivable. All expenses for lockbox system and collection of contributions are allocated to all of the entities.

**NOTE 11 - SUBSEQUENT EVENTS**

Management has evaluated subsequent events through September 5, 2025, the date on which the financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosures in these financial statements.
