This is a summary of the annual report for LAW OFFICES OF S ROSS KOCHENDERFER JR A PROFESSIONAL CORPORATION 401K PROFIT SHARING PLAN, 68-0442820/002 for 01/01/2024 through 12/31/2024. The annual report has been filed with the Employee Benefits Security Administration, formerly known as the Pension and Welfare Benefits Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Plan expenses were \$0. These expenses included \$0 in administrative expenses, \$0 in benefits paid to participants and beneficiaries, and \$0 in other expenses. A total of 3 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan was \$1,587,332 as of 12/31/2024 compared to \$1,309,195 as of 01/01/2024. During the plan year the plan experienced an increase in its net assets of \$278,137. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$278,137, including employer contributions of \$78,155, employee contributions of \$0 and earnings from investments of \$199,982.

The U.S. Department of Labor's regulations require that an independent qualified public accountant audit the plan's financial statements unless certain conditions are met for the audit requirement to be waived. This plan met the audit waiver conditions for the period covered by this Summary Annual Report and therefore has not had an audit performed. Instead, the following information is provided to assist you in verifying that the assets reported in the Form 5500-SF were actually held by the plan.

As of the last day of the period covered by this Summary Annual Report, the plan had:

You also have the right to receive from the plan administrator, on request and at no charge, a statement of the assets and liabilities of the plan and accompanying notes, if any, or a statement of income and expenses of the plan and accompanying notes, if any, or both. If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes, if any, will be included as part of that report. The charge to cover copying costs given above does not include a charge for copying of these portions of the report because these portions are furnished without charge.

You also have the legally protected right to examine the annual report at the main office of the plan at 12210 HERDAL DRIVE SUITE 11, AUBURN CA 95603-0000 and at the US Department of Labor in Washington DC, or obtain a copy from the US Department of Labor upon payment of copying costs.
