Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Omega Construction, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements ("financial statements").

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Notes to Financial Statements

1. Description of Plan

The following description of the Omega Construction, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the summary plan description for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Omega Construction, Inc. (the “Company” or “Employer”) who have attained age 21. Eligible employees may begin participation immediately following their date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Contributions

Participants are automatically enrolled at a pre-tax deferral rate of 5% of compensation (increased to 6% effective January 1, 2025), unless they elect an alternative percentage or decline participation. Participants may otherwise elect to contribute a percentage of their before and/or after-tax (“Roth”) compensation, as defined by the Plan, not to exceed the limits set by the Internal Revenue Service (“IRS”). Participants who have attained age 50 are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (“rollovers”). The Company may make a discretionary matching contribution, which was 50% of the first 6% of compensation contributed by participants for 2024. The Company may also make a discretionary non-elective contribution at a rate to be determined annually to participants that were employed on the last day of the year. However, no discretionary non-elective contribution was made for 2024.

Upon enrollment in the Plan, a participant may direct contributions between the investment options offered by the Plan. Participants may change their investment options and deferral percentages at any time.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, the Company’s contributions, and an allocation of the Plan’s net earnings and administrative expenses. Allocations are based on participant contributions, earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their own contributions, plus actual earnings thereon. Vesting in the Company’s discretionary matching and non-elective contributions plus actual earnings thereon, is based on years of continuous service according to the following schedule:

Payment of Benefits

Upon termination of service due to death, disability, retirement, or separation, a participant or beneficiary may elect to receive an amount equal to the participant's interest in his or her account in a lump-sum payment. In-service distributions may be made to participants who have reached age 59½. Withdrawals from the Plan may also be made upon circumstances of financial hardship, in accordance with provisions specified by the Plan.

Notes Receivable from Participants

Participants may borrow from his or her account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the participant's vested balance, reduced by the participant's highest outstanding note balance during the preceding one-year period, if any. Participants may have up to 2 loans outstanding at any time. Notes are secured by the balance in the participant's account and bear interest at prime plus 1%. Principal and interest are paid ratably through payroll deductions.

Forfeitures

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$40,500 and \$30,100. These accounts will be used to reduce future Company contributions or administrative expenses. No forfeitures were used during 2024.

Administrative Expenses

The Company absorbs certain expenses incidental to the administration of the Plan, including internal administrative costs. Other fees, including recordkeeping fees, may be paid by the Plan. Note and distribution fees are paid from the affected participant's account.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared under the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Certain investments of the Plan are included in the financial statements at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan invests in an investment contract through the Empower Annuity Insurance Company of America ("Empower") (Note 8).

2. Summary of Significant Accounting Policies (Concluded)

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

Management has evaluated events occurring subsequent to the date of the financial statements through September 15, 2025, the date the financial statements were available to be issued, and has determined that no events have occurred that require adjustments to or additional disclosure in the financial statements.

3. Certified Investment Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower.

4. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

5. Income Tax Status

The Plan has adopted a prototype plan document sponsored by CCH Incorporated, DBA ftwilliam.com ("CCH"). The IRS has determined and informed CCH by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended since the date of the determination letter; however, the plan administrator believes that the Plan is currently designed and being operated in compliance with applicable provisions of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants' accounts will become fully vested and nonforfeitable.

7. Party-in-Interest Transactions

Certain plan investments are managed by Empower or its affiliates. Fees paid by the Plan to Empower or its affiliates were approximately \$27,800 in 2024, net of approximately \$3,200 in distribution fees included in benefit payments. Empower is the custodian and recordkeeper of the Plan and, therefore, these transactions qualify as party-in-interest.

Fees paid by the Plan to Aprio Wealth Management for investment advisory services were approximately \$24,000 in 2024.

8. Investment at Contract Value

The investment at contract value is the Empower Key Guaranteed Portfolio Fund (“EKGP”), which is a guaranteed insurance contract that is fully and unconditionally guaranteed and backed by Empower. The EKGP is not available for sale or transfer on any securities exchange and is stated at contract value, which equals the accumulated cash contributions, plus interest and less any withdrawals.

The EKGP provides a guarantee of principal plus a guaranteed minimum rate of interest (1.45% and 1.30% at December 31, 2024 and 2023). The interest rate is reset semiannually.

Benefit payments for participants will be made at contract value (no market value or surrender charge adjustments) for all plan benefits, including retirement, death or disability, termination of employment, or loans. In addition, no market value or surrender adjustments will be charged on transfers of assets into or out of the contract, with the exception of transfers to competing investment options as defined by the contract. The Company does not believe that the occurrence of any such event, which would limit the Plan’s ability to transact at contract value with the participants, is probable.

9. Fair Value Measurements

The Plan has adopted Accounting Standards Codification 820, “Fair Value Measurements and Disclosures” (“ASC 820”), which establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The three levels of the fair value hierarchy under ASC 820 are as follows:

Basis of Fair Value Measurement

- Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;
- Level 2: Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;
- Level 3: Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial instrument’s level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual funds: Valued at the net asset value (“NAV”) of shares held by the Plan at year-end. The NAV for these investments is a quoted price in an active market and is classified within Level 1 of the valuation hierarchy.

9. Fair Value Measurements (Concluded)

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
