Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Wynn Resorts, Limited 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes (collectively referred to as the “financial statements”).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor’s Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

Other Matter

Supplemental Schedules Required by ERISA

The supplemental schedules of assets (held at end of year) as of December 31, 2024, and delinquent participant contributions for the year then ended (referred to as the “supplemental schedules”), are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

Notes to Financial Statements

Note 1 - Description of Plan

The following description of the Wynn Resorts, Limited 401(k) Plan (the "Plan") provides only general information. The Plan document, as amended, provides a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by Wynn Resorts, Limited and subsidiaries (the "Company" and "Plan Administrator") for the benefit of its eligible employees who are at least 18 years of age. The Retirement Plan Committee of the Board of Directors of the Company controls and manages the operation and administration of the Plan. Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company serves as the custodian and trustee of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Contributions

Each year, participants may contribute up to the maximum allowed by the Internal Revenue Code (the "Code") on a pre-tax and after-tax basis. The Company matches these contributions at its discretion. In order to qualify for the match, employees must be enrolled in the Plan and actively employed by the Company on the last day of the Plan year, with at least one year of service. For the 2024 Plan year, the Company matched eligible participants as defined by the Plan, 50% of employee contributions, up to 6% of eligible compensation.

Participants may also contribute amounts representing eligible rollover distributions from other qualified retirement plans or individual retirement plans.

Participant Accounts

Individual accounts are maintained for each participant in the Plan. Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investments

Participants direct the investment of their Plan account, including salary deferrals, employer matching contributions, and other rollover contributions, among various investment options offered by the Plan. In the event that no investment election is received, or contributions are received prior to the employee's investment election, contributions will be directed to one of the target retirement date fund options. In such events, the specific target retirement date fund option is determined based upon the participant's normal retirement age under the Plan. The Company's contributions are invested in the same manner as that of the participant's elective contributions.

Vesting

Participants are immediately vested in their employee salary deferral and rollover contributions plus actual earnings thereon. Vesting in the Company's matching contributions is based on years of vested service. A participant is 100% vested upon the earlier of: 1) three years of credited service, 2) attainment of normal retirement age under the Plan, 3) termination of employment due to total and permanent disability under the Plan, or 4) termination of employment due to the death of the participant.

Payment of Benefits

Upon termination of service, a participant with an account balance greater than \$7,000 may elect to receive either a lump-sum amount equal to the vested value of his or her account, or elect to have all of the distribution paid in a direct rollover to another qualified employer plan, or a combination of the above. If the account balance is \$1,000 or less and the participant does not make an active election to take a lump-sum cash distribution or rollover the account balance to an Individual Retirement Account ("IRA") or another qualified plan, the account balance will be automatically distributed in cash (subject to applicable

taxes and penalties). If the account balance is greater than \$1,000 but less than \$7,000 and the participant does not make an active election to take a lump-sum cash distribution or rollover the account balance to an IRA or other qualified plan, the distribution will be automatically rolled over to a participant's IRA.

Forfeitures

A participant, whose employment terminates for any reason other than death or retirement, forfeits their non-vested balances. Unallocated forfeited balances as of December 31, 2024 and 2023, were \$75,940 and \$67,988, which were used to pay administrative expenses, with the remainder used to reduce Company contributions.

Participant Loans

Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, whichever is less, and may be granted up to five loans during any one-year period and limited to two outstanding loans. Loan transactions are treated as a transfer between the investment fund and the loan fund. The loans generally must be repaid within a five-year period. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates, as determined quarterly by the Plan Administrator. Principal and interest are paid ratably through payroll deductions. If a participant terminates employment with the Company, the balance of any outstanding loan is due in sixty days subject to the provisions of the Plan.

Administrative Expenses

The Plan's administrative expenses are paid either by the participants or the Company, as provided by the Plan's provisions. Administrative expenses paid by the participants include recordkeeping, custodian, and trustee fees. Investment management fees, used to cover the expenses related to running an investment fund, are paid by participants and are netted against investment returns. Loan administration, withdrawal processing, and distribution processing fees are also paid by participants. Administrative expenses are paid from unallocated forfeitures, to the extent there are any unallocated forfeitures. All other administrative expenses of the Plan are paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

Plan Termination

The Company reserves the right to amend or terminate the Plan at any time subject to the provisions of ERISA. In the event the Plan is terminated, participants will become 100% vested in their accounts.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes and supplemental schedules. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are recorded when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Investment Valuation

Investments in mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are classified within Level 1 of the valuation hierarchy.

Investments in pooled separate accounts and common collective trust accounts are measured using net asset values ("NAV") as a practical expedient, as reported by the trustee. Investments in pooled separate accounts consist of investments in mutual funds, domestic equities and international equities. Investments in common collective trust accounts include the Plan's target retirement date trust accounts and a stable value fund. NAV is derived from quoted prices for the underlying marketable securities owned by the fund, minus its liabilities and then divided by the number of shares outstanding. There are currently no redemption restrictions for these investment categories. Certain investment options provide for a written notice period of fifteen business days and place limitations on transfers between investment options within a thirty day period. See Note 3, "Fair Value Measurements" for further discussion and disclosures related to fair value measurements.

Income Recognition

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes realized gains and losses on investments bought, sold, and held during the year.

Payment of Benefits

Benefits are recorded when paid.

Note 3 - Fair Value Measurements

The Plan measures certain assets at fair value. A three-tier fair value hierarchy is established as a basis for considering fair value assumptions and for inputs used in the valuation methodologies in measuring fair value:

- **Level 1** - Observable inputs such as quoted prices in active markets.
- **Level 2** - Inputs other than quoted prices in active markets that are either directly or indirectly observable.
- **Level 3** - Unobservable inputs in which little or no market data exists, therefore requiring an entity to develop its own assumptions.

The valuation methods described in Note 2 may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, while management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4 - Information Certified by the Custodian and Trustee

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-5(c) of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. All investment information disclosed in the accompanying financial statements and supplemental schedules was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company, the custodian and trustee of the Plan's assets. Such information includes investments at fair value and notes receivable from participants at December 31, 2024 and 2023, and the net appreciation in the fair value of investments, interest income on notes receivable from participants, and dividend income for the year ended December 31, 2024.

Note 5 - Related Party and Party-in-Interest Transactions

Certain Plan investments totaling \$71.8 million and \$129.0 million at December 31, 2024 and 2023, respectively, were shares of pooled separate accounts and a common collective trust account managed by Principal Trust Company and its affiliates while serving as custodian and trustee of the Plan. Therefore, these transactions qualify as party in-interest transactions for which a statutory exemption exists.

Note 6 - Tax Status

The underlying prototype plan has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the written form of the underlying prototype document is qualified under Section 401 of the Code. Any employer adopting this form of the plan will be considered to have a plan qualified under Section 401 of the Code, and, therefore, the related trust is tax-exempt. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status.

The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7 - Delinquent Participant Contributions

As disclosed in the accompanying supplemental schedule, Form 5500, Schedule H, Line 4a - Schedule of Delinquent Participant Contributions, certain employee deferrals were not remitted to the plan within the timeframe required by the Department of Labor. The Company has since remitted any related lost earnings to the affected participants into the Plan.

Note 8 - Subsequent Events

Management evaluated subsequent events for the Plan through October 7, 2025, the date the financial statements were available to be issued.
