INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of
Advent International L.P. Employees' Profit-Sharing Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Advent International L.P. Employees' Profit-Sharing Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section.

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued. Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter — Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS AS OF DECEMBER 31, 2024 AND 2023 AND FOR THE YEAR ENDED DECEMBER 31, 2024

1. DESCRIPTION OF THE PLAN

The following description of the Advent International L.P. Employees' Profit-Sharing Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan Document for a complete description of the Plan's provisions.

General—The Plan is a defined contribution plan established by Advent International L.P. (the "Company" or the "Employer") under the provisions of Section 401(a) of the Internal Revenue Code (the IRC), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The 401k Fiduciary Committee, consisting of certain employees of the Company, administers the Plan. Fidelity Management Trust Company (Fidelity) serves as the trustee of the Plan.

Plan Amendments—Effective November 1, 2022, the Plan was amended to change entry date and allow for deferral contributions, employee contributions, and qualified nonelective employer contributions commencing from first day of every quarter to first day of every month.

Eligibility—The Plan covers all employees of the Company who have at least one month of service and are age 21 or older. Employees must complete one year of service to be eligible for employer non-discretionary or discretionary match.

Contributions—Each year, participants may contribute up to 60% of pretax annual compensation, as defined in the Plan Document. Participants may also contribute amounts representing distributions from other qualified defined benefit, or defined contribution plans. The Plan permits participants to make after-tax "Roth contributions". Participants who reach age 50 during the course of the plan year are also eligible for the IRC catch-up provision, whereby they are allowed to make an additional contribution to the Plan, limited to \$7,500 for 2024. Contributions are subject to certain IRC limitations.

The Company contributes a match each calendar year of 50% of the elective deferral contribution that a participant (with annual base compensation of \$65,000 or less) contributes to the Plan, with a maximum annual matching contribution of \$1,000 per participant. Additional discretionary amounts may be contributed at the option of the Company's board of directors. For 2024, the discretionary match was 100% of salary deferral, to a maximum match of \$12,000 per participant. During the year ended December 31, 2024, the Company recorded employer discretionary matching contributions of \$2,469,658.

The Company's employer non-discretionary matching contribution is made for eligible participants who are employed on the last day of each quarter. The Company's discretionary matching contribution requires a participant to be employed on the last day of the year.

Participant Accounts—Each participant’s account is credited with the participant’s contributions and allocations of (a) the Company’s contributions, if any, and (b) Plan earnings, and may be charged with withdrawals and allocation of Plan losses and administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested accounts. All amounts in participant accounts are participant-directed.

Vesting—Participants are fully vested in 100% of their account balance at all times.

Notes Receivable from Participants—Participants may borrow from their fund accounts up to a maximum amount equal to the lesser of \$50,000 or 50% of their account balance. The minimum loan amount is \$1,000. Loan terms range from one to five years, or up to 15 years for the purchase of a primary residence. Principal and interest are paid ratably through payroll deductions or as a lump sum for the outstanding loan balance. The loans are secured by the balance in the participant’s account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. As of December 31, 2024, participant loans have maturities through 2034 at interest rates ranging from 5.25% to 10.5%.

Payment of Benefits—On termination of service, death, disability, or retirement, a participant may receive a lump-sum amount equal to the vested value of his or her account. The Plan also permits in-service withdrawals, including, but not limited to, hardship withdrawals.

Terminated participants are allowed to request distribution of their account balance. If the account balance is \$1,000 or less, the distribution will be made automatically in the form of a lump sum payment. For balances over \$1,000 up to \$5,000, the terminated participant may direct the trustee for the preferred distribution method. If no direction is provided, the funds will be automatically paid to an Individual Retirement Account (IRA) provider chosen by the Plan administrator. The distribution is to be made as soon as administratively feasible, following the date of termination or death. Distributions made to individuals who have not attained the age of 59 ½ may be subject to an early withdrawal penalty.

Plan Termination—Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Investment Elections—Each participant may direct their account balance into one or more of the several investment options offered by the Plan including mutual funds, a stable value fund, and a self-directed investment option. The self-directed investment option allows the participant to direct contributions to be invested in any investment permitted under the Plan, including common stocks, mutual funds, and money market mutual fund. Allocations must be in increments of 1% of each contribution. A participant may change such allocation and may transfer all of the value of his or her account in increments of 1% among the investment options at any time.

2. SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting—The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

Valuation of Investments and Income Recognition—The Plan’s investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 4 for discussion of fair value measurements.

Net appreciation/depreciation on the fair value of investments is reflected in the statement of changes in net assets available for benefits and includes realized gains and losses on investments bought and sold and the change in appreciation from one period to the next. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Use of Estimates—The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Plan Expenses—Administrative expenses of the Plan are paid by the Plan or the Company, as provided in the Plan document. Expenses that are paid by the Company are excluded from these financial statements. All investment management and transaction fees directly related to the Plan investments are paid by the Plan. Participants also pay administrative costs for loans, distributions, and qualified domestic relation orders.

Notes Receivable from Participants—Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are recorded as distributions based on the terms of the Plan Document.

Payments of Benefits—Benefit payments to participants are recorded upon distribution. There were no participants, who elected to withdraw from the Plan, but had not yet been paid as of December 31, 2024 and 2023.

Excess Contributions Payable—The Plan is required to return contributions received during the Plan year in excess of the IRC limits.

3. CERTIFIED INVESTMENT INFORMATION

The following is a summary of the information regarding the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included in the Plan’s financial statements and supplemental schedule that were prepared by or derived from information prepared by Fidelity, the trustee of the Plan, and furnished to the Plan administrator. The Plan administrator has obtained certifications from the trustee that such information is complete and accurate.

4. FAIR VALUE MEASUREMENTS

Under GAAP, fair value is defined as the exchange price that would be received for an asset in the principal or most advantageous market for the asset in an orderly transaction between market participants and establishes a hierarchical disclosure framework that ranks valuation techniques based on the observability of inputs. Investments measured and reported at fair value under GAAP are classified based on the valuation techniques used and disclosed in one of the following categories:

Level 1—Investments with unadjusted quoted prices in active markets for identical securities as of the measurement date.

Level 2—Investments valued with inputs other than quoted prices in active markets, which are either directly or indirectly observable as of the measurement date, and fair value is determined through use of models or other valuation methodologies.

Level 3—Investments valued with inputs that are unobservable for the investment and includes situations where there is little, if any, market activity for the investment. The inputs into determination of fair value include significant estimates and assumptions.

If the inputs used to measure fair value fall across different levels of the hierarchy, then the categorization of the investment within the hierarchy is based on the lowest level input.

Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds—Mutual funds are valued at quoted prices on nationally recognized securities exchanges. The mutual funds held by the Plan are deemed to be actively traded.

Common Stocks—Valued at the last sales price or official closing price on the national securities exchange where the securities are principally traded. If there has been no sale, the securities are valued at the mean between bid and ask prices.

Stable Value Fund—A common collective trust fund that has been determined to have a readily determinable fair value based on the published price and transact at that price. The fund is valued at the daily closing price as reported or published by the fund, which represents the actual price at which the units held in the fund can be bought or sold. The fund is deemed to be actively traded.

Self-Directed Brokerage Account—Includes a variety of common stocks, mutual funds and money market mutual fund.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. RISKS AND UNCERTAINTIES

The Plan and its participants invest in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Recent market conditions have resulted in an unusually high degree of volatility and increased the risks and short-term liquidity associated with certain investments held by the Plan, which could impact the value of investments after the date of these financial statements.

6. INCOME TAX STATUS

The Plan is based on a prototype plan sponsored by Fidelity. The Internal Revenue Service (IRS) informed the prototype Plan sponsor, in an opinion letter dated June 30, 2020, that the form of the Plan is acceptable under the requirements of the IRC. An employer may rely on a favorable opinion letter issued to a prototype sponsor as evidence that the Plan is qualified under IRC Section 401(a) as provided in Revenue Procedure 2015-36. The Plan administrator believes that the Plan is designed and being operated in compliance with applicable requirements of the IRC so that the Plan is qualified, and the related trust is tax-exempt. Therefore, no provision for income tax has been included in the Plan’s financial statements.

7. RELATED PARTY TRANSACTIONS AND EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by an affiliate of Fidelity. Fidelity is the custodian and trustee of the Plan and therefore, these transactions qualify as party-in-interest transactions. Also, the Plan paid certain expenses related to Plan operations and investment activity to various service providers who are parties in interest under ERISA.

The Plan also issues loans to participants, which are secured by the vested balances in the participants’ accounts.

The Plan has a revenue-sharing agreement whereby certain investment managers return a portion of the investment fees to the recordkeeper who allocated them to the participants to offset administrative expenses.

8. SUBSEQUENT EVENTS

For the year ended December 31, 2024, subsequent events were evaluated through October 1, 2025, the date the financial statements were available to be issued.
