Notes to Financial Statements

NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The financial statements of the 403(b) Thrift Plan of Wesley Community Services Organization (the "Plan") have been prepared using the accrual basis of accounting using accounting principles generally accepted in the United States America ("GAAP").

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the statements of net assets available for benefits.

Related Party Transactions

Certain Plan investments are shares of mutual funds managed by Empower Trust Company, LLC (the "Custodian"). Empower Trust Company, LLC are the asset custodians of the Plan. Therefore, these transactions qualify as exempt party-in-interest transactions.

Several employees of Wesley Community Services Organization (the "Plan Sponsor") provide administrative services to the Plan. These services include Plan oversight and day-to-day Plan administration. The Plan is not charged by the Plan Sponsor for the services of the employees of the Plan.

Certain expenses and costs of administering the Plan were paid by the Plan Sponsor, and accordingly are not reflected in the Plan's financial statements. Certain investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

Estimates

The preparation of financial statements in conformity with United States generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from these estimates.

Payment of Benefits

Benefit payments to participants are recorded when paid.

NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Reclassifications

Certain reclassifications were made to the 2023 amounts in order to be consistent with the classifications adopted for reporting in 2024. These reclassifications had no effect on the net increase of assets available for benefits.

Subsequent Events

In preparing its financial statements, the Plan Sponsor has evaluated events subsequent to the balance sheet date through September 22, 2025, which is the date the financial statements were available to be issued.

NOTE 2 DESCRIPTION OF THE PLAN

The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of the Plan Sponsor. Another plan was merged with the Plan effective June 17, 2024. All employees of the merged plan were immediately eligible upon transfer to the Plan. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's original effective date is August 1, 2006 and was amended and restated effective October 1, 2023.

Eligibility

Employees are eligible to participate in the Plan immediately upon employment commencement and to receive the employer match upon commencement of 403(b) deferrals. Employees must be 18 years of age in order to receive the employer match. Effective January 1, 2022 the Plan has adopted an automatic enrollment feature that enrolls eligible participants at 2%, unless they elect to opt out.

Contributions

Participants may voluntarily make pre-tax or after-tax salary deferral contributions up to 100% of their eligible compensation. However, contributions may not exceed limitations established under Section 402(g) of the Internal Revenue Code of 1986 as amended (\$23,000 at December 31, 2024). For 2024, Section 414(v) of the Internal Revenue Code of 1986 as amended allowed a maximum catch-up contribution of \$7,500. Participants designate the percentage of their total contribution to be invested in any of the Plan's investment funds. Participants may change the percentage of contributions invested in each account and may make transfers between accounts anytime during the year.

The Plan Sponsor makes matching contributions to eligible participants in an amount equal to 150% of the participant's elective deferral to a maximum of 2% of the participant's compensation.

NOTE 2 DESCRIPTION OF THE PLAN (CONTINUED)

Rollover Contributions

Participants may rollover their taxable portion of funds previously held for their account in another qualified employee benefit plan to this Plan on a tax-free basis.

Participant Accounts

Each participant's account is credited with the participant's and Plan Sponsor's contributions and a pro-rata allocation of the Plan's earnings and expenses. The pro-rata allocation is based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested at the time of participation in the Plan in their voluntary contributions and rollover contributions. Vesting in the employer matching contributions is based on years of continuous service. Participants are 100% vested upon the completion of 3 years of continuous service. At December 31, 2024 and 2023, the balances in forfeited non-vested accounts were both \$-0-. During 2024, \$12,854 was used to reduce future employer contribution and plan expenses.

Payment of Benefits

Upon a participant's retirement, death, disability, or other reason, the participant may receive benefits in accordance with the Plan's provisions and existing laws and regulations. The Plan Sponsor may initiate a mandatory distribution as a lump-sum cash payment for those terminated participants whose vested account balance is \$1,000 or less.

In conditions of "financial hardship," a participant may request approval to withdraw that portion of his or her 403(b) retirement account balance necessary to meet the financial hardship, subject to the limitations of the Plan and the Internal Revenue Code.

Upon termination of the Plan, assets will be distributed to participants in accordance with the Plan's provisions and existing laws and regulations.

NOTE 4 FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs.

The hierarchy is broken down into three levels based on the ability to observe inputs as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the net asset value ("NAV") of shares held by the Plan at year end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflect future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different approaches or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan invests in a fully benefit-responsive investment contract with Empower Annuity Insurance Company of America in the form of a guaranteed investment contract. The guaranteed investment contract is carried at contract value. Empower Annuity Insurance Company of America maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Empower Annuity Insurance Company of America is contractually obligated to repay principal and specified interest rate that is guaranteed to the Plan. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events may limit the Plan's ability to transact at contract value with Empower Annuity Insurance Company of America including plan termination and other event as specified in the guaranteed investment contract.

NOTE 6 TAX STATUS

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (the "Code"). The terms of the Plan have been prepared to conform with the sample language provided by the IRS in Revenue Procedure 2007-71. The Plan Administrator intends to apply for a determination letter on the Plan once the Internal Revenue Service opens such a program. The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for plan participants under Section 403(b).

NOTE 7 PLAN TERMINATION
