### 1. Description of Plan

The following description of Pacira BioSciences, Inc. 401(k) Salary Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

#### *General*

The Plan is a defined-contribution plan available to substantially all employees of Pacira BioSciences, Inc. (the Company or Plan Sponsor), adopted September 1, 1993. The Plan was amended and restated, effective June 3, 2021, to incorporate certain legislative and regulatory requirements.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). Fidelity Management Trust Company (Fidelity) serves as Plan trustee and custodian.

#### *Eligibility*

An employee is eligible to participate in the Plan and have salary-reduction contributions on his or her behalf after attaining age 21. An eligible participant can enter the Plan immediately upon meeting the eligibility requirements.

#### *Contributions*

Participants may contribute up to 97% of pre-tax annual compensation, as defined in the Plan document. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined-benefit or defined-contribution plans (rollover). The Plan also allows for Roth contributions and in-Plan Roth rollover conversions.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions are invested in a designated-balance fund until changed by the participant.

The Plan may make a discretionary employer matching contribution as a percent of eligible compensation deferred by participants. During 2024, the Company matched 100% of the first 5% (maximum of 5%) of the employee's eligible compensation. On an annual basis, the Company makes additional matching contributions (true up) for employees who are employed as of the last day of the year, using the aforementioned formula applied to the employee's eligible compensation for the year, less the amount of matching contributions previously made on behalf of the participant for that year.

The Company may make discretionary nonelective employer contributions to the Plan for all eligible participants who continue to complete a minimum of 1,000 hours of service during the year and are still employed at the fiscal year-end on an annual basis. There were no discretionary nonelective contributions made to the Plan for the year ended December 31, 2024.

### *Participant Accounts*

Each participant's account is credited with the participant's contributions, employer contributions, and an allocation of net Plan earnings, and is charged with investment losses, an allocation of administrative expenses, and withdrawals. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### *Investment Options*

Participants may direct contributions in any investment options of the Plan, which are investments in mutual funds, self-directed brokerage account, money market fund, or common collective trust.

### *Vesting*

Participants are 100% vested in their elective deferral contributions, Roth contributions, rollover contributions, and any earnings thereon. Employer matching contributions and discretionary nonelective employer contributions are subject to the following vesting schedule below:

Participants become fully vested in the event of retirement, death, or disability, as defined by the Plan.

### *Notes Receivable from Participants*

Participants may borrow from their individual accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000, reduced by the highest outstanding loan balance in their accounts during the prior 12-month period. Participants may only have one loan outstanding at any time. All loans are required to be repaid in five years, unless the proceeds of the loan were used for the purchase of a principal residence, in which case the loan repayment period may not exceed ten years from the date of the loan. The loans bear interest at rates commensurate with local prevailing rates, as determined by the Plan administrator. Principal and interest are paid ratably through monthly payroll deductions or directly to the Plan.

### *Payment of Benefits*

A distribution can be made to a participant, if requested, due to disability; retirement, as defined by the Plan, or termination of employment. A participant may elect to receive a lump-sum amount equal to the vested portion of the participant's account, or annual installments. Participants may elect to rollover their vested balance to another qualified retirement plan or an individual retirement account (IRA).

### ***Forfeited Accounts***

If a participant's employment terminates for reasons other than retirement, disability, or death, the unvested portion of the account is forfeited, either when the vested portion of the account is distributed or in other limited circumstances. Forfeitures shall be used to reduce Plan expenses and employer contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$362 and \$333,007, respectively. During the year ended December 31, 2024, the forfeiture account was reduced by the amount applied against employer matching contributions of \$729,149.

## **2. Summary of Accounting Policies**

### ***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting.

### ***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires Plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the period.

### ***Contributions Receivable***

Participant contributions and any related employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation. Non-elective/true up contributions are recorded in the relevant period in accordance with the terms in the Plan document.

### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as distributions, based on the terms of the Plan document. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

### ***Payment of Benefits***

Benefits are recorded when paid.

### ***Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

### **3. Risks and Uncertainties**

The Plan holds various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements and participant account balances.

### **4. Certified Investment Information**

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of year), related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends and interest, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity, a qualified institution.

### **5. Fair Value Measurements**

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 or 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

*Mutual Funds* - Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Self-Directed Brokerage Account* - The self-directed brokerage account primarily consists of mutual funds that are valued at quoted-market prices, which represent the NAV of shares owned by the Plan at year-end.

*Money Market Fund* - The money market fund is valued at quoted market prices, which represents the NAV of shares owned by the Plan at year-end.

*Common Collective Trusts* - The common collective trusts are valued at the NAV of units held. The NAV, as provided by the trustee of the common collective trusts, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the common collective trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the Galliard Stable Return Fund M common collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner. The MFS Mid-Cap Growth Fund Class R6 common collective trust provides for daily redemption by the Plan at reported NAV with no advance notice. The Plan has no unfunded commitments with the common collective trusts as of December 31, 2024. The common collective trusts are a direct-filing entities.

## 6. Related Party and Party-in-Interest Transactions

Plan investments include shares of mutual funds, a money market fund, and a self-directed brokerage fund managed by Fidelity. Fidelity is the trustee, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Additionally, certain employees and officers of the Company, who are also participants of the Plan, perform administrative services for the Plan at no cost. Notes receivable from participants also qualify as party-in-interest transactions.

Such transactions are permitted under the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA.

## 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right to discontinue its operations at any time and to terminate the Plan, subject to the provisions set forth in ERISA. In

the event of Plan termination, each participant will become 100% vested and the net assets of the Plan will be distributed, as prescribed by ERISA.

### **8. Tax Status**

The Plan uses a pre-approved plan document sponsored by FMR LLC. FMR LLC received an opinion letter from the Internal Revenue Services (IRS), dated June 30, 2020, which states that the pre-approved plan document, as then-designed, satisfies the applicable provisions of the Internal Revenue Code (IRC). Although the Plan has been amended since the date of the opinion letter, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a taxing authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **9. Delinquent Participant Contributions**

During the Plan year ended December 31, 2023, participant contributions totaling \$59 were not remitted to the Plan within the period prescribed by Department of Labor (DOL) regulations. These transactions constitute non-exempt party-in-interest transactions or prohibited transactions as defined by ERISA. The Company has followed the correction plans within IRS guidance and the funding was made on August 27, 2025.

### **10. Subsequent Events**

Effective July 1, 2025, the Plan was amended to allow participants to make voluntary, non-deductible, after-tax contributions up to 97% of their eligible contributions.

There have been no other material subsequent events that occurred through September 29, 2025, the date on which the financial statements were available to be issued, that would require disclosure in these financial statements, as of or for the year ended December 31, 2024.
