1. Description of the Plan

The following description of the 88 International Inc. Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The sponsor of the Plan is 88 International Inc., ("The Company"). The Company is in the business of the wholesale of garment products.

General

Effective January 1, 2013, the Company established the Plan for eligible employees of the Company. Employees of the Company are eligible to participate in the Plan as soon as they attain the age of 21 and have completed twelve months of service. Entry dates are the first day of 1st, or 7th month of the plan year on or next following eligibility satisfaction.

The Plan's trustee is John Hancock Life Insurance (U.S.A.) which provides the following services:

- Traditional investments 401k
- Target date funds plus funds in different risk classes
- Loan provision
- No surrender period
- No minimum funding
- No optional guarantee income

The Plan is a defined contribution plan covering all full-time employees of the Company with the exception of any employee (1) who is covered by a collective bargaining agreement, or (2) who is a non-resident alien. The Plan is subject to the provisions of the Employee retirement Income security Act of 1974 ("ERISA"). The Board of Trustees oversees governance of the Plan. The Plan's Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Board of Trustees.

Contributions

Participants may make voluntary contributions in the form of salary deferrals at participant's discretion subject to the annual maximum amount imposed by the Internal Revenue Service. The Company provides a safe harbor contribution of 3% of each participant's annual compensation. It also has a profit-sharing scheme which is based on compensation by class:

A - Qualified employee who is not in Class B, C, or D	4.5%
B - Highly compensated employee who is not 5% owner	7.5%
C - Qualified employee who is child of the President	7.5%
D- Qualified employee who is 5% owner and his/her spouse	7.5%

1. Description of the Plan, continued

Investment Elections

The investments of the Plan are self-directed by the participants. Investment elections may be changed at any time.

Participant Accounts

Each Participant's account is credited with the participant's and Company contributions and related earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in safe harbor is 100% at all times while vesting on the Company's 4.5% profit sharing is based on years of continuous service. In the first year vesting is 0% and then it is 20% per year.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the balance in the participant's account and bear interest at Prime + 1%. Principal and interest is paid ratably through monthly payroll deductions.

Payment of Benefits

On termination of service, participants may receive lump-sum amounts equal to the value of their account.

Forfeited Accounts

In 2024, forfeited unvested amounts totaled \$5,906. The balances for the forfeiture accounts were \$2,035 and \$578 as of December 31, 2024 and 2023.

2. Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America. Benefits are recorded when paid.

2. Summary of Significant Accounting Policies, continued

Significant Risk and Uncertainty

The fair value of the Plan's assets is subject to change as a result of changes in market rates and prices. A significant change in market rates and prices can significantly reduce the net assets available for Plan benefits and concurrently participant balances. Plans that invest in foreign securities are subject to foreign exchange and political risks among other risks.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expense when incurred. As of December 31, 2024, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the term of the Plan document.

Valuation of Investments and Income Recognition

The Plan's investments in the registered investment company accounts are valued at fair value as reported to the Plan by John Hancock Life Insurance Company (U.S.A.). The Plan presents, in the statement of change in net assets available for benefits with fund information, the net appreciation (depreciation) in the fair value of its investments, which consist of the realized gains or losses and the unrealized appreciation (depreciation) of those investments. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Contributions

Participant contributions are recorded in the period during which the Company makes payroll deductions from the Plan participants' earnings. Company contributions are recorded based upon the required Company matching levels as defined in the Plan agreement.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the administrator and trustee to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at December 31, 2024 and the reported amounts of additions to and deductions from net assets for the year ended December 31, 2024. Actual results may differ from those estimates.

Date of Management's Review

Subsequent events were evaluated through October 7, 2025, which is the date the financial statements were available to be issued.

3. Investments

Investments are reported at fair value. Fair Value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis.

Investments are held in custodial capacity by John Hancock Life Insurance Company (U.S.A.), the trustee of the plan. Individual Plan participants direct the transactions that take place in their accounts.

During the year ended December 31, 2024, the Plan's investments (including gains and losses on investments bought and sold as well as held during the year) in pooled separate accounts appreciated in value by \$539,574 while participant loans appreciated in value by \$7,498.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB Accounting Standards Codification Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, or inputs that are derived principally from, or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

4. Fair Value Measurements, continued

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts: The fair value of the plan's investment in the pooled separate accounts is based on the underlying unit value reported by John Hancock Life Insurance (U.S.A.) valued at NAV. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The pooled separate account NAV is not a publicly quoted price in an active market but its calculation is in accordance with the AICPA Audit and Accounting Guide, Investment Companies. Based upon these facts, FASB ASC 820 allows the use of NAV as a practical expedient to estimate fair value.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Notes Receivable from Participants

Participants may borrow from their vested balances, subject to certain limitations as set forth in the Plan and the Internal Revenue Code. The amounts borrowed carry fixed interest rates which are based on interest rates charged by persons in the business of lending money for loans which would be made under similar circumstances. Loans are payable in full upon the participant's termination of employment from the Company. There were 6 loans being granted during the year ended December 31, 2024.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

8. Income Tax Status

The Company has received a favorable determination letter from the Internal Revenue Service dated June 30, 2020, that the Plan qualifies under Section 401(a) of the Internal Revenue Code ("IRC"). The Company is of the opinion that the Plan is currently being operated in compliance with the applicable requirements of the IRC and that the trust, which forms a part of the Plan, is tax exempt. Accordingly, no provision for state or federal income taxes has been provided.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2020.

9. Related Party and Party-in-interest Transactions

Certain Plan investments are in units of participation in a pooled separate account, registered investment company, etc., offered by the Plan trustee, and therefore, these transactions qualify as party-in-interest. Any purchases and sales of these funds are open market transactions at fair market value. Consequently, such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transaction under ERISA. Notes receivable and the related interest income are considered related party transactions.

Certain administrative functions are performed by officers and employees of the Company. No officer or employee received compensation from the Plan for these services.

10. Expense

The costs associated with the formation and administration of the Plan are borne by the Company. Administrative costs of \$6,399 were paid by the plan during the year ended December 31, 2024.

11. Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risk such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
