As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of the Hyundai Motor America Profit Sharing Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**A. General**

The Plan was adopted effective January 1, 1986 as a defined contribution plan and most recently restated effective January 1, 2015. It covers all eligible employees of Hyundai Motor America (HMA) (Sponsor), and Washington DC employees of its parent, Hyundai Motor Company (HMC) (collectively referred to as the Company) not covered by a collective bargaining agreement. An eligible employee is automatically enrolled, and 6% deferrals are automatic upon satisfying age and service requirements unless specifically waived by the employee. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**B. Contributions**

Participants may make contributions to the Plan of up to 75% of their eligible annual compensation, as defined in the Plan. Contributions are subject to a limitation under Section 402(g) of the Internal Revenue Code (IRC). Participants who have attained the age of 50 before the close of the Plan year may make catch-up contributions in accordance with, and subject to limitations of, Section 414(v) of the IRC. The Plan permits Roth contributions and in-Plan Roth rollovers.

At the end of each pay cycle, the Company makes a matching contribution to the account of each participant equal to 66 $\frac{2}{3}$ % of the employee's elective contributions, not to exceed 4% of the employee's compensation. In addition, following one year of service, certain HMA participants receive enhanced Company contributions equal to an additional percentage of eligible compensation per pay period, paid quarterly.

Contributions may be invested in any of the investment options available under the Plan, as directed by the participants. If no election is made by the participant, contributions are invested in the appropriate target-date mutual fund.

**C. Participant Accounts**

Each participant's account is credited with the participant's contribution, rollover contributions and allocations of (a) the Company's contribution and (b) earnings or losses. Earnings or losses are allocated to the participants' balances, based on the proportion each account bears to the total of all account balances within each investment fund. The benefit to which a participant is entitled is the benefit that can be provided from his or her vested account.

**D. Vesting**

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company contribution portion of their accounts plus earnings thereon is based on years of service at a rate of 25% per year. A participant is 100% vested after four years of service, as long as the participant has worked at least 1,000 hours per calendar year. A participant is also 100% vested upon death, disability, or retirement.

**E. Notes Receivable from Participants**

In order to be eligible for a loan, a participant must be an employee of the Company and must have a vested account balance of at least \$2,000. A participant may borrow a minimum of \$1,000 up to the lesser of \$50,000 reduced by the highest outstanding loan balance during the previous 12 months or one-half of his or her vested account balance. The interest rate on such loans is the prime rate plus 1%. Related administrative expenses are charged to each participant's account.

**F. Payment of Benefits**

Upon termination of service or retirement, vested benefits over \$5,000 due to participants or their beneficiaries can be held in the Plan or paid in a lump sum. The Plan requires distributions to be made to the participant or beneficiary no later than April 1 of the calendar year following the year in which the participant reaches 70½. Vested benefits of \$5,000 or less may be distributed to the participant or beneficiary without the participant's written consent. A participant may make a hardship withdrawal from his or her account subject to certain IRC provisions and the approval of the Employee Benefits Committee.

**G. Forfeited Accounts**

Forfeitures of nonvested accounts of terminating participants are used to offset future Company contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$10,674 and \$11,718, respectively. Forfeitures and dividends earned on forfeited accounts during 2024 totaled \$97,237. The Company reduced its 2024 contributions by \$98,281 through the use of forfeited accounts.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**A. Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

**B. Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**C. Risks and Uncertainties**

Plan investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in the various risk factors in the near term could materially affect participants' account balances and the amounts reported in the financial statements.

**D. Investment Valuation and Income Recognition**

GAAP establishes a hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Under the fair value hierarchy Level 1 inputs are quoted prices in an active market. Level 2 inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data. Level 3 inputs are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability.

Shares may be redeemed any time at net asset value. There are no restrictions on redemptions and no unfunded commitments to purchase additional shares of the common/collective trust.

**D. Investment Valuation and Income Recognition (Continued)**

Purchases and sales of investments are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Mutual fund capital gains distributions are included in dividend income. Net appreciation includes gains and losses on investments bought and sold as well as held during the year.

**E. Payment of Benefits**

Benefits are recorded when paid.

**NOTE 3 - INFORMATION CERTIFIED BY THE TRUSTEE**

The Plan Sponsor elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, the trustee, certified that the following information included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments reported in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income reported in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule of Assets (Held at End of Year) - December 31, 2024.

The plan administrator instructed the Plan's independent auditors not to perform any auditing procedures on certified information, except for comparing such information with related information included in the financial statements and supplemental schedule.

**NOTE 4 - RELATED PARTY TRANSACTIONS**

Certain investments of the Plan are shares of mutual funds and a common/collective trust managed by Fidelity Management Trust Company (Fidelity). Fidelity is the trustee as defined by the Plan, and therefore, these transactions qualify as party in interest transactions.

**NOTE 5 - ADMINISTRATIVE EXPENSES**

Most expenses are paid by the Company. Participant account balances of \$5,000 or more are charged with a recordkeeping fee of \$23.75 each quarter. Participants are also charged fees for certain types of transactions such as loans and some withdrawals. Net revenue credits totaled \$128,889 for 2024 and were allocated to participants' accounts.

**NOTE 6 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**NOTE 7 - INCOME TAX STATUS**

The Internal Revenue Service has determined and informed the Company by a letter dated March 2, 2017 that the Plan is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator believes the Plan is designed and being operated in compliance with the IRC.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 - SUBSEQUENT EVENTS**

Management has evaluated subsequent events through September 25, 2025, the date the financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosures in these financial statements.
