Notes to Financial Statements

December 31, 2024

1. Description of the Plan

The OrthoTennessee Group Medical and Dental Plan (the “Plan”) provides medical, prescription, dental, and vision benefits covering all employees of OrthoTennessee, P.C. (the “Plan Sponsor”) who work at least twenty-nine hours each week and have completed thirty-nine consecutive weeks or more each year, as well as their eligible dependents. For previously covered employees that are no longer eligible, benefits may continue as required under federal law. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan agreement provides that the Plan Sponsor make contributions to the Plan sufficient to provide benefits for participants. Receivables from the Plan Sponsor for these contributions are unsecured. The participants contribute specified amounts, determined periodically, based on whether coverage is extended to eligible dependents.

The Plan has a prescription drug rebate program with EpiphanyRx. Rebates earned totaled \$1,096,251 in 2024 and are netted with benefits paid to participants.

As of December 31, 2024, cash contributions receivable from the Plan Sponsor included \$585,891 that was funded during 2025 through the prescription drug rebate program with EpiphanyRx. As of December 31, 2023, cash contributions receivable from the Plan Sponsor included \$646,538 that was funded during 2024 through the prescription drug rebate program with EpiphanyRx.

Although it has not expressed any intention to do so, the Plan Sponsor has the right under the Plan to modify the benefits provided to active employees, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions set forth in ERISA.

The foregoing description of the Plan provides only general information. Participants should refer to the publication OrthoTennessee Health Benefit Plan Evidence of Coverage for a more complete description of the Plan’s provisions. Copies of this publication are available from the Plan Sponsor.

2. Significant Accounting Policies

Accrual Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

2. Significant Accounting Policies (continued)

Health Claims Payable

The Plan has established a liability for those claims reported but not paid and those claims incurred but not reported. Claims are administered by a third-party. Although the Plan is self-funded, the Plan has individual excess loss coverage (whereby if a participant's claims during the year exceed specified dollar amounts, the excess will be paid by the insurance company) with a third-party insurance company, as well as additional coverage with an insurance company related through common ownership with the Plan Sponsor. Insurance premiums paid to this related insurance company totaled \$230,052 in 2024 and \$283,190 in 2023. Excess loss coverage reimbursements received, which are netted with benefits paid to participants in the accompanying statements of changes in benefit obligations and net assets available for benefits, totaled \$29,885 during 2024.

Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein, claims incurred but not reported, eligibility credits, claims payable, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Plan obligations for health claims incurred by active participants but not reported are estimated by the Plan based on subsequent payments and past experience. It is reasonably possible these estimates could change in the near term as more information becomes available.

Subsequent Events

In preparation of the accompanying financial statements, management has evaluated events that have occurred subsequent to the balance sheet date through October 6, 2025, the date the financial statements were available for issuance.

3. Income Tax Status

The Plan Sponsor has determined the Plan is currently designed and being operated in compliance with applicable requirements of the Internal Revenue Code that qualify for exemption, and accordingly, no provision for income taxes has been made in the accompanying financial statements.

4. Administrative Expenses

Certain plan administrative expenses are paid by the Plan Sponsor and are excluded from these financial statements.

5. Postretirement Benefits

Participants who have completed 15 years or more of continuous service with the Plan Sponsor and have attained age 55 upon retirement, may elect to continue participation in the Plan for themselves and for their dependent(s) through age 65. The current cost of participation is the applicable COBRA rate. It is the Plan Sponsor's intention to charge rates that will approximate claims incurred by these participants and their dependent(s), in the aggregate. Accordingly, no benefit obligation for postretirement benefits has been recognized.
