1. Description of Plan

The following description of the Accelerate Diagnostics, Inc. 401(k) Plan (Plan), sponsored by Accelerate Diagnostics, Inc. (Company), provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a deferred arrangement that is part of an employee savings plan covering all employees of the Company who are age eighteen or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute pretax annual compensation as defined in the plan agreement. Participants may also make Roth contributions to the Plan. In addition, participants may contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company does not make matching contributions, and additional profit-sharing contributions may be contributed at the option of the Company's board of directors. During the years ended December 31, 2024 and 2023, the Company made employer contributions totaling \$-0- and \$4,326 respectively. Contributions are subject to certain limitations imposed by the Internal Revenue Service (IRS).

Participant Accounts

Each participant's account is credited with the participant's contribution, Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the remainder of their account is based on years of continuous service. A participant is 100% vested after three years of service.

Notes Receivable from Participants

Participants may borrow from their fund accounts, a minimum of \$500 up to a maximum of \$50,000 or one-half of their vested account balance, whichever is less. Loan maturities may not exceed 5 years unless the loan proceeds are applied toward the purchase of a primary residence. In that case, the term of the loan may be for the term of the mortgage. The notes receivable from participants are secured by the balance in the participant's account and bear a reasonable rate of interest, which is determined at the time the loan is made. Interest rates range from 4.25% to 9.50%.

Administrative Expenses

The Plan allows certain administrative expenses to be paid from Plan assets. Administrative expenses for the years ended December 31, 2024 and 2023 are comprised of investment management fees in the amount of \$34,369 and \$31,820, respectively, and recordkeeping fees in the amount of \$9,373 and \$9,632, respectively.

Payment of Benefits

On termination of service due to death, disability, retirement or other reasons, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a period of years not exceeding the participant's normal life expectancy or the normal joint life expectancy of the participant and designated beneficiary.

Forfeitures

Forfeitures occur when a participant receives a cash-out distribution of their account balance upon termination, and they are not fully vested. Forfeited amounts are reallocated to the remaining Plan participants and/or used to pay administrative expenses in accordance with provisions of the Plan document. There were no forfeitures utilized for the year ending December 31, 2024 and 2023. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$4.

SECURE 2.0

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023, which included SECURE Act 2.0. SECURE Act 2.0 contains over 90 new retirement provisions, with varying effective dates through 2027. Since SECURE Act 2.0 provisions include both required and optional elements, the plan administrator will determine the optional provision to elect and amend the Plan document accordingly. Most of the significant provisions will become effective in 2024 and thereafter. Management has determined that there is no material impact to the Plan's 2024 financial statements.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net change includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

Payment of Benefits

Benefits are recorded when paid.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

3. Plan Termination

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. As discussed in Note 10, the Company filed for protection under Chapter 11 of the Bankruptcy Code on May 8, 2025. See Note 10.

4. Income Tax Status

The IRS has determined and informed the Company, by a letter dated July 8, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been restated since receiving the determination letter. The IRS has issued a letter dated November 14, 2022 that the Plan, as amended, is designed in accordance with the applicable sections of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. As of December 31, 2024, management is not aware of any uncertain tax positions that are potentially material. The Plan is subject to routine audits by taxing jurisdictions. However, there are currently no audits in progress for any tax periods.

5. Fair Value Measurements

The Financial Accounting Standards Board has established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: valued at the net asset value of shares held by the Plan.

Guaranteed investment contracts (fully benefit-responsive): valued at contract value, which represents contributions made under contract, plus earnings, less participant withdrawals and administrative expenses.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

9. Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. Excess contributions payable as of December 31, 2024 and 2023 are \$48,451 and \$-0-, respectively. The Plan distributed the 2024 excess contributions prior to March 15, 2025.

10. Subsequent Events

The Company filed for protection under Chapter 11 of the Bankruptcy Code on May 8, 2025. On August 1, 2025, the current management made the decision to close the Company, and all employees were terminated. In connection with the closure, the trustees terminated the Plan with an effective date of October 10, 2025.

The Company was unaware of any additional subsequent events as of October 6, 2025, the date the financial statements were available to be issued.
