As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section –

- The amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedule Required by ERISA

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 - DESCRIPTION OF THE PLAN

The Writers Guild of America, West, Inc. 401(k) Plan (the "Plan") is a defined contribution plan that covers all employees of Writers Guild of America, West, Inc. (the "Guild"). The Plan was established on July 1, 1997 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Investment fund options are participant-directed.

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

A. Eligibility

All employees age 21 and above who have one month of service are eligible to participate in the Plan. Plan entry date is the first day of the month following the date on which a participant satisfies the eligibility requirements.

B. Contributions

The Plan permits each participant to contribute up to the Internal Revenue Code (the "IRC") annual maximum. The Guild has the option of making discretionary matching contributions based on the participant's elective deferrals. In 2024 and 2023, the Guild's matching contributions were equal to 50% of the first 5% of a participant's deferral, to a maximum of 2.5% of the participant's eligible compensation.

C. Vesting and Forfeitures

A participant is fully vested immediately as to voluntary salary deferrals, rollover contributions and related earnings. Participants in the Plan vest 20% per year as to the Guild's matching contributions. Forfeitures are used to reduce the Guild's contributions at the end of the next Plan year after the participant has received distribution of his or her vested balance. Forfeitures for the years ended December 31, 2024 and 2023 were \$17,146 and \$7,744, respectively. Forfeitures used in 2024 and 2023 totaled \$0 and \$8,104, respectively. Investments as of December 31, 2024 and 2023 include \$26,288 and \$8,039, respectively, of forfeited funds available for future use.

D. Notes Receivable from Participants

The Plan permits participants to borrow from their accounts. Loans are available to all participants and must be approved by the plan administrator. The minimum loan is \$1,000. A participant may borrow an amount not to exceed the lesser of 50% of his or her vested account balance or \$50,000. Loans bear interest at the prime rate plus 1%.

E. Payment of Benefits

Benefits are recorded when paid. Hardship distributions are permitted.

F. Retirement Age

Benefits under the Plan begin when a participant retires, dies, is disabled or ceases to be an employee, whichever applies. Normal retirement age is 65. Early retirement is not permitted.

G. Administrative Expenses

The Guild pays for most administrative expenses of the Plan.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

B. Investment Valuation and Income Recognition

GAAP establishes a fair value hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market.

Level 1 – Inputs are quoted prices in active markets.

Level 2 – Inputs are based on quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data.

Level 3 – Inputs are generally unobservable and typically reflect management’s estimates of assumptions that market participants would use in pricing the asset or liability.

The following tables summarize the Plan’s investments at December 31, 2024 and 2023 based on the inputs used to value them:

Level 1 investments consist of mutual funds valued at fair value based on market quoted prices.

C. Estimates

The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

D. Risks and Uncertainties

The Plan provides for various investment options in any combination of investment securities offered by the Plan. Investment securities are exposed to various risks, such as interest rate, market fluctuations and credit risks. Due to the risk associated with investment securities, it is at least reasonably possible that changes in market values, interest rates or other factors in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

NOTE 3 - PLAN TERMINATION

Although it has not expressed intent to do so, the Guild has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. The accounts of the participants affected by a partial or complete termination of the Plan are nonforfeitable and will be determined as of the termination date, which will be treated as the valuation date.

NOTE 4 - INCOME TAX STATUS

The Guild has adopted a Vanguard Fiduciary Trust Company Prototype plan, which received an opinion letter from the Internal Revenue Service stating that it is designed in accordance with applicable sections of the IRC. The plan administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 5 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Information regarding investments held at December 31, 2024 and 2023 and investment income for the years then ended that is disclosed in the accompanying financial statements and supplemental schedule was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Vanguard Fiduciary Trust Company, the trustee of the Plan.

NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS

The trustee is a party-in-interest as defined by ERISA. The trustee, from time to time, may invest the Plan's assets in its mutual funds and fixed annuities. The Guild is also deemed a party in interest under ERISA as it provides certain administrative services at no cost to the Plan. Such transactions are exempt under ERISA.

NOTE 7 - SUBSEQUENT EVENTS

In January 2025, the Plan was amended, effective 2026, to include the SECURE 2.0 Act's optional Qualified Disaster Recovery Distribution provision to allow participants to take a distribution of up to \$22,000 per disaster if they meet certain requirements.

Management has evaluated subsequent events through September 30, 2025, the date on which the financial statements were available to be issued. There were no other material subsequent events that required recognition or additional disclosures in these financial statements.
