**Note 1. Plan Description**

The following description of the Kent Outdoors 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement or Summary Plan Description for a more complete description of the Plan’s provisions.

***General***

The Plan is a defined contribution plan sponsored by Kent Outdoors, formerly known as Kent Water Sports Holdings, LLC, (the “Plan Sponsor”) for the benefit of its employees who have at least 60 days of service and are age 18 or older, if hired before January 1, 2024. If hired after this date, the age and date of service requirements are waived and employees are eligible to participate in the Plan upon their hire date (excluding union employees, nonresident aliens, leased employees and residents of Puerto Rico).

Related employers who also participate in the Plan include Absolute Outdoor of America, LLC, Motion Sports of America, LLC, HO Sports Company, LLC, Connelly Skis, LLC, Kent Water Sports, LLC (Kent Water Sports Holdings, LLC), Barefoot International LLC, BOTE, LLC, and Kona USA, Inc. (the “Companies”).

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan’s management determines the appropriateness of the Plan’s investment offerings, monitors investment performance, and reports to the Plan’s Trustee.

Effective January 1, 2024, the Plan’s custodian changed from Charles Schwab Trust Company to TransAmerica Retirement Solutions, LLC (“Custodian”). In 2023, the assets were held in a trust with Reliance Trust Company. In 2024, the assets were held in a trust with Reliance Trust Company, TransAmerica Trust Company, and TransAmerica Life Insurance Company as the “Trustees” (see Note 3).

***Contributions***

The Plan permits eligible employees through a salary deferral election to have the Plan Sponsor make annual contributions of up to 100% of their eligible compensation. Employee rollover contributions are also permitted. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan at a 2% deferral rate unless they affirmatively elect not to participate in the Plan.

The Plan Sponsor may, at its discretion, make matching contributions equal to 50% of participant elective deferrals up to 6% (i.e. participants can get a maximum of 3% of their gross wages during their elected participation in the plan). Contributions are subject to certain Internal Revenue Service (“IRS”) limitations.

***Participant-Directed Investment Options***

Upon enrollment in the Plan, participant contributions are automatically invested in a designated target date fund until changed by the participant. A participant may direct the investment of their contributions into any of several investment options with varying degrees of risk and volatility, allowing participants to allocate their investments in accordance with their own risk tolerances and time horizons. Participants may change their investment options at any time.

***Participant Accounts***

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions and (b) Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Upon the death or permanent disability of a participant while an employee, their entire account balance becomes fully vested. Vesting in employer discretionary contributions is based on years of continuous service according to the following schedule:

***Notes Receivable from Participants***

The Plan Document includes provisions authorizing loans from the Plan to active eligible participants (effective December 21, 2023). A participant can only have one outstanding loan at any time. The minimum amount of a loan shall be \$1,000. The maximum amount of a participant's loans is determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested account balance. All loans are covered by promissory notes and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll withholdings unless the participant is paying the loan in full. Interest on the loans is based on local prevailing rates as determined by the Plan Administrator. At December 31, 2024, outstanding loans bore interest rates of 9.00% - 9.50%. Principal and interest are paid ratably through payroll deductions.

***Payment of Benefits***

Upon termination of service due to death, disability, attainment of age 59 ½, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a future period. Upon termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Distributions of a participant's account balance may be authorized at any time by the plan administrator under certain hardship conditions. There were no unpaid amounts allocated to participants who elected to withdraw from the Plan at December 31, 2024 and 2023.

***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$1,550 and \$180, respectively. These accounts will be used to reduce future employer contributions or administrative expenses. Also, in 2024, administrative expenses were reduced by approximately \$20,000 from forfeited nonvested accounts. No forfeitures were used to reduce employer contributions in 2024.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

In 2024, the Plan changed its basis of accounting from the modified cash basis to the accrual basis of accounting to conform with generally accepted accounting principles in the United States (US GAAP), as required for employee benefit plans subject to ERISA reporting requirements. This change in accounting principle has been implemented retrospectively and management believes it did not have a significant impact on the 2023 financial statements and as such the 2023 financial statements were not revised.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Investments***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 4 for discussion of fair value measurements.

Fully benefit-responsive investment contracts are valued at contract value. Contract value represents contributions made under the contract, plus interest at the contract rate, less participant withdrawals and administration expenses.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Interest income is recorded when received. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

***Excess Contributions Payable***

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants before March 15, 2025.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Certain fees related to distributions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

***Subsequent Events***

Plan management has evaluated subsequent events through October 6, 2025, the date the financial statements were available to be issued.

### **Note 3. Certification of Plan Trustees and Custodians**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Plan Trustees, qualified institutions, have certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedules is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedules.

### **Note 4. Fair Value Measurement**

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") Topic 820 are described below:

**Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common stocks: Valued at the closing price reported on the active market on which the individual securities are traded.

Corporate and foreign bonds: Valued using pricing models maximizing the use of observable inputs for similar securities. This includes basing value on yields currently available on comparable securities of issuers with similar credit ratings.

Common/collective trust funds: Valued based on the NAV of units of the collective trust fund. The NAV as provided by the trustee, is used as a practical expedient to estimating fair value. The NAV is based on the fair value of the underlying investments held by the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the Plan will sell the investment for an amount different

**Investments Measured Using the NAV per Share Practical Expedient**

These funds are valued at the net asset value ("NAV") of units of the collective fund. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the funds will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily.

## **Note 5. Investment Contract with Insurance Company**

The Plan has entered into a fully benefit-responsive investment contract with Transamerica Life Insurance Company. Transamerica Life Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula established by the issuer, with no stated minimum or maximum interest rate. Such interest rates are reviewed on a semi-annual basis for resetting. During the years ended December 31, 2024 and 2023, the crediting interest rate averaged 2.25% and 1.63%. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The guaranteed investment contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under terms of the Plan. Contract value, as reported to the Plan by Transamerica Life Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The total contract value of the fully benefit-responsive investment contract at December 31, 2024 and 2023 was approximately \$341,000 and \$400, respectively.

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Examples of such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA or (5) premature termination of the contract.

Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (1) an uncured breach of the Plan's investment guidelines, (2) a material amendment to the contract without the issuer's consent, (3) a violation of a material obligation under the contract, or (4) a material misrepresentation. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

## **Note 6. Exempt Party-In-Interest Transactions**

Certain Plan investments are managed by the custodians of the Plan. The custodians in 2024 and 2023 were TransAmerica Retirement Solutions LLC (with Reliance Trust Company, TransAmerica Trust Company, and TransAmerica Life Insurance Company as Trustees) and Charles Schwab Trust Company (with Reliance Trust Company as Trustee), respectively. The recordkeepers as defined by the Plan in 2024 and 2023 were TransAmerica Retirement Solutions LLC (January 1, 2024 through December 31, 2024), Spectrum Pension Consultants, Inc. (January 1, 2023 through December 31, 2023), and One Digital Pension Services (September 21, 2023 through December 31, 2023).

As described in Note 2, the Plan paid certain expenses related to the Plan operations and investment activity to various service providers, including the custodians. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. Fees paid by the Plan for administrative services were approximately \$53,000 for the year ended December 31, 2024. These transactions qualify as exempt party-in-interest transactions under ERISA.

**Note 7. Transfer of Plan Assets from Other Plans**

Effective January 1, 2024, the Kona USA, Inc 401(k) Plan merged into the Kent Outdoors 401(k) Plan. All participants in the Kona USA, Inc 401(k) Plan were provided the option to have their account balance rolled into any qualified plan (including the Plan). An aggregate of approximately \$812,000 was rolled into the Plan during the year ended December 31, 2024, and is included as a transfer on the statement of changes in net assets available for benefits.

**Note 8. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**Note 9. Tax Status**

The Plan operates under a non-standardized pre-approved profit sharing/money purchase/cash or deferred arrangement ("CODA") adoption agreement in connection with a prototype 401(k) profit-sharing plan and trust sponsored by TransAmerica Retirement Solutions LLC. This prototype plan document has been filed with the appropriate agency and has obtained an opinion letter from the IRS stating that the prototype constitutes a qualified plan under Section 401 of the Internal Revenue Code and that the related trust was tax exempt as of the financial statement date.

**Note 10. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 11. Reconciliation of Financial Statements to Form 5500**
