We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Responsibilities Of Management For The Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about BCLP LLP US Retirement Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities For The Audit Of The Financial Statements

Except as described in the Scope And Nature Of The ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with auditing standards generally accepted in the United States of America will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with auditing standards generally accepted in the United States of America, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required By ERISA

The supplemental schedule of Schedule of Assets Held at End of Year as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with auditing standards generally accepted in the United States of America. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTES TO FINANCIAL STATEMENTS

December 31, 2024 And 2023

1. Description Of The Plan

The following brief description of the BCLP LLP US Retirement Plan (the Plan) is provided for financial statement purposes only. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees and partners of BCLP LLP (the Partnership or the Employer), a limited liability partnership organized under the laws of the State of Missouri, except for non-resident aliens and employees expected to work for a predetermined period of time to complete a specific task or project. The Plan provides for retirement, death, and disability benefits.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Participants in the Plan may elect for any calendar year to contribute on a pre-tax or Roth basis, up to the lesser of the maximum amount permitted under Section 402(g) of the Internal Revenue Code (the Code) (\$23,000 and \$22,500 for 2024 and 2023, respectively) or 50% of their annual compensation. In addition, participants over 50 years of age are allowed to contribute an additional \$7,500 to the Plan, as allowed by the catch-up rules, in both 2024 and 2023. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

Eligible employees are automatically enrolled in the Plan at 6% pre-tax contribution, unless they elect otherwise within 30 days of hire date or have made another election within any prior annual automatic enrollment period. Pre-tax contributions automatically escalate at 1% per year, unless the participant elects otherwise. Certain exclusions apply to the automatic enrollment and automatic escalation process.

For eligible staff participants classified as regular full or part time employees by the firm or individuals employed by the firm engaging in the practice of law in the position of Counsel, the Employer will contribute an amount equal to 5% of the compensation, as defined by the Plan. An additional 5% of compensation in excess of the Social Security Taxable Wage Base (\$168,600 for 2024 and \$160,200 for 2023), if any, will also be contributed.

BCLP LLP US RETIREMENT PLAN

Notes To Financial Statements (*Continued*)

For eligible partners, the Employer contributes an amount based on a schedule that takes into account each partner's age, classification, and target compensation.

The aggregate contributions made for any participant under the Plan may not exceed the lesser of \$69,000 for 2024 and \$66,000 for 2023 or 100% of compensation or 100% of the participant's remuneration per the Code.

Participant Accounts

Each participant's account is credited with the participant's contribution, Employer contributions, as well as earnings and losses on investments and expenses. Allocations are based on participant earnings and losses, account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Upon enrollment in the Plan, a participant may direct contributions in a number of investment options offered by the Plan. Under the terms of the Plan and the agreement with Vanguard Fiduciary Trust Company (the Trustee), participants may also elect to invest in a self-directed brokerage option.

Vesting

Participants are vested immediately in their employee contributions plus actual earnings thereon.

Participants are fully vested after completing three years of service in their Employer contributions. If a participant terminates employment before completing three years of service for reasons other than disability, death or reaching retirement age (attainment of their 65th birthday), the Employer contributions in their account is forfeited.

Forfeited Accounts

If a participant forfeits any unvested balances in their account, the forfeited amount can be used to reduce future Employer contributions or pay reasonable Plan administrative expenses. Forfeited amounts totaled \$223,921 and \$148,879 for the years ending December 31, 2024 and 2023, respectively. Forfeitures that reduced Employer contributions were \$215,497 and \$150,323 for the years ended December 31, 2024 and 2023, respectively. At December 31, 2024 and 2023, available forfeited nonvested accounts totaled \$11,608 and \$1,278, respectively.

Notes To Financial Statements (*Continued*)

Notes Receivable From Participants

Participants may borrow from their accounts a minimum of \$500, up to a maximum aggregate amount equal to the lesser of \$50,000 or 50% of the total value of the participant's vested account balance. Only two loans are allowed outstanding to a participant at any one time. Loans are for a period not to exceed five years, unless proceeds are used to acquire a principal residence. Interest rates on loans are set at 1% over the prime-lending rate. Loans are repaid through payroll withholdings, including principal and interest.

Payment Of Benefits

Upon termination of service for any reason, a participant may elect a lump sum payment, installment payments or take partial withdrawals, providing that the participant's account shall be completely distributed no later than the latest time permitted by the Code. A surviving spouse or beneficiary may elect a lump sum payment or installment payments. Participant balances less than \$5,000 are required to be distributed in a lump sum.

Participant Withdrawals

Upon attainment of age 59-1/2 (age 62 for certain Employer contributions), hardship, disability, or criteria meeting in service withdrawals, a participant may withdraw all or a portion of his or her account balance. Provision is also made for distribution upon termination of employment, disability or death. Participants may also withdraw from the Plan from the vested portion of their accounts in the event of undue financial hardship. Certain conditions and restrictions apply, as defined in the Plan Document.

Administrative Expenses

The Plan Document provides that any reasonable expenses for the Plan's administration are paid from the assets held by the Plan, unless paid by the Partnership, without reimbursement from the Plan.

2. Summary Of Significant Accounting Policies

Basis Of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Estimates And Assumptions

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Investment Valuation And Investment Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Interest income is recorded as earned on the accrual basis. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan Document. Notes receivable from participants are secured by participants' vested account balances.

Payment Of Benefits

Benefits are recorded when paid.

Subsequent Events

Management has evaluated subsequent events through the date of the Independent Auditors' Report, which is the date, which the financial statements were available for issue.

3. Certified Investment Information

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee has certified that the following investment information included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown on the statement of net assets available for benefits as of December 31, 2024 and 2023;
- Investment income and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023;
- Investment information included in the supplemental schedule of assets held at end of year as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

4. Risks And Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

5. Fair Value Measurements

The Plan utilizes an established framework for measuring fair value of investments. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical investments (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the standards are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical investments in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar investments in active markets;
- Quoted prices for identical or similar investments in inactive markets;
- Inputs other than quoted prices that are observable for the investment;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the investment has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the investment.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The investment's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Notes To Financial Statements (*Continued*)

Following is a description of the valuation methodologies used for investments measured at fair value:

Interest-Bearing Cash

Valued at fair value based on cash deposits plus interest, less withdrawals from the account.

Mutual Funds And Money Market Fund

Valued at the net asset value (NAV) of shares held by the Plan at year-end. Mutual funds and the money market fund held by the Plan are open-end investment companies that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds and money market fund held by the Plan are deemed to be actively traded.

U.S. Government Securities

Valued using pricing models maximizing the use of observable inputs for similar securities.

Common And Preferred Corporate Stock And Exchange Traded Funds

Valued at the closing price reported on the active market on which the individual securities are traded.

Collective Investment Trusts

Valued at the NAV of units of the collective investment trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

All of the collective investment trusts held by the Plan file an annual report on Form 5500 as a direct filing entity. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at fair value under all circumstances including the termination of the Plan.

Notes To Financial Statements (Continued)

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There have been no changes in the methodologies used at December 31, 2024 or 2023.

6. Income Tax Status

The Plan adopted a pre-approved plan document. The pre-approved plan document sponsor obtained an opinion letter dated June 30, 2020, which states that the pre-approved plan document satisfies the applicable provisions of the Code. The Plan itself has not received a determination letter from the Internal Revenue Service (IRS). However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income tax has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Party In Interest Transactions

During 2024 and 2023, the Plan held investments in shares of various mutual funds, money market fund, and collective investment trusts, managed by the Trustee. In addition, certain participants have outstanding loans with the Plan as of December 31, 2024 and 2023. These investment transactions qualify as exempt party in interest transactions under ERISA.

8. Plan Termination

Although it has not expressed any intent to do so, the Partnership has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participants will become fully vested in their account balances.
